Please check my interpretation, but I read the definition to refer to (i) any AGM executive officer (as defined in the Securities Act) or (ii) an investment professional that provides services, on a substantially full-time basis, to AGM or one of its Subsidiaries and whose "total income" is among the top 25 highest (excluding Leon, Josh and Marc) for the prior fiscal year.

Can you please also tell us who the independent directors of AGM are. They are defined as the "Independent Board" in Section 5.3 of the Agreement.
