Amex called Air France re changing your return flight on June 21st to the 2:10pm flight (380 plane) and discovered that because the outbound flight on June 6th at 7:10pm has no first class seats left, they would have to release your entire ticket and try to rebook the round trip. This would be a scary move, because the 2 first class seats you currently hold could be scooped up by someone on the waiting list by the time a new ticket is processed for you. The Amex agent also said Air France will only honor the price we were quoted (\$17,943.80) up to 4pm today. The agent suggests purchasing this ticket we have on hold by 4pm today and then after you are in Paris, try and change the return flight to the June 21st, 2:10pm flight. Please let me know if I should purchase these tickets for you.
