Dave or Darren ? not sure there is an easy answer to this,  
If we type Dave in the GIV (\$23k) and keep him on current pay scale, with a GIV type, I can see Dave doing more contract GIV flying with others which will sometimes conflict with your flying schedule at some point. Dave has average \$110k the past few years for salary.  
Darren is very excited to fly the GIV with us, I've been speaking to him daily, Darren would be a great contract use pilot in GIV and Bell 430, however he's not been to school on the GIV in the past 12months, so he requires re-current training at this time \$15k at simuflite. Darren is not full time position material, he's involved in so many other business's, Crop dusting, Farming and partners with Luis Beck in helicopter partnerships etc. and does quite well monetarily.

in summary, "Dave" with a mixture of Bill Murphy and Darren in the GIV to help.

I'm still in Islip at the GIV, I'll arrive in NYC by 4pm today,.
