I'm Thomas Buchsein, Medical Director of FAI rent-a-jet, an Air Ambulance company based in Nuremberg, Germany with a branch in the United Arab Emirates, run by Mrs. Barbara Baumgartner as Managing Director.
I have already established contact with Dr Matthew Bacchetta and Dr Daniel Brodie, very helpful and professional colleagues, who kindly provided me with essential information and will try to obtain a comprehensive medical report.

Once the flight is confirmed and we have a GOP, our Flightoperations Center in Nuremberg shall prepare a tentative flightplan for an ICU-equipped Challenger CL 604 with our standard flightnurse and emergency physician crew, who will be reinforced by your specialist team (docs + perfusionist) and ECMO equipment. The exact schedule will have to be coordinated according to the actual medical situation.
