A different kind of humaneness is invoked I suppose.

I may well be completely wrong with this, but in the spirit of abject honesty, to be quite frank, I don't think your antics serve you and I never wholeheartedly did. It is ironic that you eulogize those that support it and contribute to it, but on your most intimate level , a place that I'd venture to say, I may well have touched, I think it leaves you feeling depleted. Balance and equilibrium in life is essential for wholeness and the move in Paris, though I remain sorry for any behavior on my part that engendered negativity, aniliated that sense. To have it yes, no doubt, you need it but I think you also need a caring that is different from that which you perpetually seek, both pleasure and emotional security in the long run are better when they are not bought. i might well be wrong with all of this, in fact i'm happy to be wrong. that is ok. I think you are an extraordinary person, and i'll always hold you as nothing other than most special and ' truly wonderful! '
