I note in Herman's Bar file, 2010-7i,108(11B-MRE) STIPULATION FOR SUMMARY PROCEEDINGS, page 4, paragraph L, " Present and past employees of the firm were also interviewed, and all indicated that Petitioner has not practiced law..."

The Bar file should be public record and a look at it should reveal if Holmes was interviewed or give us names of other persons who were employed in the time period.

Remember that before she was admitted in Florida, 5/09, she could not sign pleadings and would be essentially a paralegal.
