Elliot, this came from an email from Lindsey Cei on another subject but it makes me think any responsibility for a tax return should now be with Tom Turrin who does taxes for Leon and Black Family Partners.

AIF IV Management, Inc. This entity was formerly part of the Apollo structure, but was not included in the Strong Roll-Up. It was formerly the general partner of Apollo Management IV, L.P., which is the management company of Fund IV. In connection with the management restructuring that occurred in January 2007, the general partners of the management companies for each fund were converted from corporations to limited liability companies and were subsequently consolidated in the Strong restructuring. AIF IV Management, Inc. could not be converted to an LLC because there was an insurance policy for Leon tied to the entity. Leon is currently the sole shareholder of AIF IV Management, Inc. and it is a limited partner of Black Family Partners, L.P. It does not seem like this is an Apollo entity since it is not related to the management company or the fund.
