> Basic Terms:
>
> Price: US\$1,845,400 delivered to Air Center Helicopters, Ft. Worth, TX.
>
>
> -Seller pays only airworthiness discrepancies identified during Pre-buy
> Inspection consisting of a 100 hour Airframe and 150 hour engine inspection.
>
>
> - Tailboom ASB and ECU Software Update shall be at Purchasers Expense.
>
> Said Pre-buy inspection shall occur immediately upon arrival of Aircraft
> at Air Center Helicopters.
>
>
> -Refundable deposit of US\$100,000 sent to the escrow agent to remove the
> helicopter from the market pending execution of a formal Purchase
> Agreement. Upon execution by both parties deposit shall become
> non-refundable and released to Seller and Aircraft shall depart for Air
> Center Helicopters, Ft. Worth, Texas.-

> -Rather than get into more specifics the above terms make it fairly
> straight forward transaction. At closing you would pay Heli-X a commission
> of US\$40,000 and recover your fuel expenses for the delivery. Chris will
