2. MAIL OR FAX THIS INFORMATION TO ALCC.

b) PAYMENT INSTRUCTIONS

Make your check out for \$ 4384 to ALCC.

Put student's name and the Reference Number on the check.  
Mail to ALCC.

PAYMENT MUST BE RECEIVED BY ALCC TO PROCESS YOUR REGISTRATION.

Once registration is completed, we will send you your I-20 and  acceptance letter. Take these documents and original financial information (Bank statement or letter, Affidavit of Support - if applicable) to your local US Consulate to apply for  F-1 Student Visa.
