For the month of September, I'll be joining my kids Holly and Sam as a member of the core team of the Virgin Strive Challenge in which a 25 of us will be travelling from the base of the Matterhorn to the summit of Mt Etna in Sicily, entirely under human power. The trip is broken into 5 legs and I would absolutely love it if you could join me for a leg or two.

Here's the agenda to whet your appetite:

- Hike (1-8 September): Stunning 5 day hike over mountain col's and alpine valleys. Staying in mountain refuges along the way.
- Cycle 1 (8-14 September): Cycling at its very best as we cruise through all of Tuscany and then hit the Liguria coastline.
- Cycle 2 (14-20 September): Cycle around Rome and then spend a night on the Amalfi coast at the end.

- Triathlon (26-30 September): 3.5km swim to Sicily, 110km mountain bike along a stunning ridge line and a half marathon to the summit of Etna. A fitting finale to an amazing month.
