Moffett Federal Airfield Airport (no website; Airfield M/S 158-01, Moffett Field; 650-604-5050) is the closest to Palo Alto, located five miles east in Mountain View. Other options include Las Trancas (no website; 3564 California 1, Davenport; 408-423-4156), Bonny Doon Village (no website; 8647 Empire Grade, Santa Cruz; 831-459-8577), Little Hands (no website; 18320 Bollinger Canyon Road, San Ramon; 415-837-8981) and Meadowlark Field (no website; 4300 Greenville Road, Livermore; 925-606-1536). Private use fields require approval before landing or takeoff.
