Couple of things to fix in the application:
#30 Itinerary: should say the airlines, flight number and the route: you can put Austrian 90, Austrian 687

Newark-Vienna-Minsk

for #19: we can put up to 90 days for a short-term visa. Let's put validity from Sept.11th till December 8th, 2015. We can apply for a long-term with this passport, since it expires in June 2016. For a term of stay put 15 days

We also need a letter from his insurance company

-Please make sure the passport # on this form matches with what you are taking. I am almost positive we swapped the 10 year passport back in to JE's black bag and put the 2 year one in Jeffrey's private box in his bedroom (?) But if not and we need to change the number on the application to match the 10 year one, let me know.
