In order to take advantage of the Air France 2 for 1 (now called the International Program) the flight must start in the US. ...if they flew **NY to Doha** on Nov. 23rd and return on Nov. 27th the total for the flights would be \$12,526.80. [REDACTED] must be the card holder. We would have to book this ticket in 72 hours. ([REDACTED] ticket: \$11,760.90. [REDACTED] would pay taxes only of \$765.90)

The only carrier to fly direct from Paris to Doha is Qatar. Air France stops in Frankfurt. BA stops in Heathrow. Luftansa stops in Frankfurt. Swiss Air makes 2 stops. Delta co-shares w/AF and KLM...
