Re: Handcarry of the Raffaello Sanzio, called Raphael (Urbino 1483-1520 Rome);  
Head of a muse bought by you on 8 December 2009 in Sale 7782 (the "Drawing")

You hereby confirm that you are responsible for arranging insurance cover against all risk of physical loss, damage or theft arising from any circumstance to the Drawing from the time that the Drawing leaves the premises of Christie's at 8 King Street, London, SW1Y 6QT (the "Premises").

You hereby release Christie's, its officers, directors, employees, agents and contractors from and against any and all liability for physical loss of, theft of damage to the Drawing howsoever arising. You agree to notify your insurance carrier/company of this agreement and arrange for them to waive any right of subrogation against Christie's, its officers, directors, employees, agents and contractors with respect to any physical loss, theft or damage to the Drawing howsoever arising while it remains in Christie's care, custody and control.

This agreement will remain in full force and effect whilst the Drawing remains in Christie's care, custody and control.
