[REDACTED] reported her grandfather, name not obtained, whose care [REDACTED] was
in since she was a baby, had a house a few doors down from the Cuomo's at
[REDACTED], and [REDACTED] was taken by boat to Epstein's Island.
[REDACTED] said it was complicated and involved Jeffery Epstein and Ghislaine
Maxwell.

[REDACTED] also reported a meeting that took place at [REDACTED] Middle
School two years ago. [REDACTED] said she is/was a [REDACTED]
and at the meeting the school principal, [REDACTED] who is now
deceased, said something about pictures of [REDACTED] with Epstein. [REDACTED]
commented she does not know how the school had the information they did,
but mentioned a [REDACTED] Police officer was present at the meeting.

[REDACTED] remarked it was a not a traditional meeting and the school was upset with her for not being a Trump person. [REDACTED] suggested the school wanted her to testify and say things against Andrew Cuomo. [REDACTED] added the FBI and President Trump were allegedly on the phone during the meeting. [REDACTED] said the meeting was traumatic and trauma does not operate on a timeline.

[REDACTED] said she has never been treated as a victim, but as someone made to do what others wanted. [REDACTED] believes there may be baby pictures of her with Epstein that the FBI may have. [REDACTED] said she wanted the evidence for her personal healing and vindication. [REDACTED] claims she has been the victim of extraordinary abuse since she was a child and feels she has been gaslighted. [REDACTED] mentioned she does not know if she needs a victim's advocate or a lawyer.
