NYOC receives a USPS letter from United States District Court Southern District of New York, United States District Judge RICHARD M. BERMAN dated 07/23/2020 addressed to the NYO FBI ADIC [REDACTED] and includes a letter he received from repeat complainant/Five Points Correctional Facility inmate FOREST FATE, DOB [REDACTED], SSN [REDACTED], DIN# [REDACTED].

Mr. FATE's letter which is dated 07/12/2020, provides details on an unnamed JEWISH GIRL who he reports was raped by her father (no name provided) since the age of 8 years old. Mr. FATE advises that she then became pregnant as a result. At the age of 14 years old, Mr. FATE claims the unnamed JEWISH GIRL visited JEFFREY EPSTEIN'S mansion and became highly favored in their website seeking arrangements.

Mr. Fate further alleges that this unnamed JEWISH GIRL is responsible for approximately 3 homicides including one where she injected Fentanyl into an individual named PHILL. Mr. FATE claims that due to her father being well respected and powerful, he was able to cover these crimes for the unnamed JEWISH GIRL. Mr. FATE advises that if the FBI is interested in more information regarding this matter and can secure his safety, then to reach out to him and he can prove these claims.
