FBI Probing Death of Jeffrey Epstein, Prisons Director Reveals

Bureau of Prisons Director Kathleen Sawyer tells lawmakers on the Senate Judiciary Committee that the FBI is investigating whether a "criminal enterprise" may have played a role in the death of convicted sex offender Jeffrey Epstein. The financier died in his cell in August while awaiting trial on sex trafficking charges. Director Sawyer says Epstein's death was ruled a "suicide" by the coroner and that she has no evidence to suggest it was otherwise
