I have called and emailed repeatedly to tell you that I am being stalked and intimidated
By thugs sent after me by SCPD.

When I attended the EDNY summation of the Spota/McPartland trial, the prosecutors
Explained that Spota put police and prosecutors in key positions in the James Burke beat down
Of Chris Loeb that took place on December 14, 2012 (or thereabouts) to cover up for
James Burke, and not to investigate the crime.

In reality, Chris McPartland, Emily Constant, James Hickey, Peter Crusco, Taryn Merkyl
And Ross McCormack and others were specifically in place to cover up the beat down
And the DVD's that Burke had in his party bag that Loeb found and watched, and not
To actually investigate.

The Feds explained in detail to the jurors that the police were coached by James Burke

And James Hickey to lie to the Feds who were investigating the matter, and henceforth
The first attempt by the Feds to sue were thwarted by Spota and McPartland and henceforth
They (Spota and McPartland) were sued for obstruction of justice.

While I was at the government's summation, I witnessed John Ray, the attorney for the
Estate of Shannan Gilbert make "goo goo eyes" at Tom Spota. I witness Tom Spota
Looking deeply, lovingly into the eyes of John Ray. This occurred at approximately 12:45pm
On December 11, 2019 in Judge Azrack's court room. She had just let everyone go for lunch
And John Ray stayed behind to look at McPartland (who acknowledged Ray and then looked away)
And Spota. NONE of the lawyers in the room were looking at Ray except Spota. The lawyers
In the room were the prosecutors and the defense counsel of Spota and McPartland.

When I saw "the intimate look" between the two men, I knew that Spota had placed John Ray
To represent the Gilbert family to cover up the case, and not to actually fulfill his duties
To zealously defend his client, Shannan Gilbert.

I had met John Ray on December 3, 2016, and I learned that he had absolutely no expertise
In sex trafficking and he was clueless as to the evidence in Shannan's case. I knew more
About her case than her own lawyer did, and I had a lot of confusion in my mind as to why
He was Shannan's lawyer.

I know that when John Ray entered Mari Gilbert's life, he told Mari that he would line her
Pockets with Hackett's money.

After Mari Gilbert died, I was invited to her funeral. John Ray did not attend, as press were not
allowed. I was told information about the Hackett to Mari Gilbert phone calls from Mari's boyfriend,
Elroy S.

John Ray had a meeting on December 3, 2016 to discuss the Shannan Gilbert case. He asked me
To be on his Shannan Gilbert team.

The private investigator, Tricia Burton, on his team called me on December 4, 2016 to talk to me
And she said that he lied about a dozen things yesterday in the meeting.

On December 5, 2016 I called a professional survivor of sex trafficking and she offered to help me and discuss
Escort agencies and what drivers are responsible for and the drop and how agencies work.

On December 6, 2016, I went to a meeting at the New York State Anti Trafficking Coalition and asked for
Names of experts for "The Erotic Review."

After December 6, 2016, I, along with Tricia Burton, and a sex trafficking survivor who is a woman who trains FBI
In sex trafficking, and a NYPD Det. Lt in the Intel division who worked on the Barthelemy end of the LISK case
Started talking to have a sting conducted on Michael Pak to learn who the agencies were that he worked for
And where the drop was made.

I was doing this to get intel on Pak to give to John Ray, the lawyer representing Shannan Gilbert.

In January 2017 I spoke to Pak and he spoke to me. A texting and talking relationship developed.

January 18, 2018, I met [REDACTED] and [REDACTED] at a New York State Anti Trafficking Coalition meeting. I expressed that I was deeply upset because I had gone to Federal Court and stood in front of Judge Edward Korman To have Akeem Cruz put away, and Judge Korman put Akeem in prison for an upward departure for the Mann Act. Judge Korma said to Akeem that he did not kill [REDACTED] but he put her in the path of danger and was putting Him BACK in prison for the Mann Act instead of letting him go home.

The 2 AUSA's discussed with me that since Pak lived in Queens, there was a nexus and they could go after Him to prosecute him and gave me their business cards and said send us your intel.

I did, I first sent my intel to you in January 2018, and then on or about June 22, 2018.

The only people who knew that I was working with the FBI were the Town of Mamaroneck Cops (because Pak had threatened to kill me on the phone and I was in Town of Mamaroneck), John Ray, Mr. and Mrs Scalise, and my attorney Andrew J. Maloney, III.

On May 18, 2018 I was in their home discussing the Hackett - Mari Gilbert phone calls Of 2010 and they witnessed Michael Pak on the phone with me, and I told them that I had spoken to the FBI SDNY to prosecute Pak and I noticed their body language freak out, and I knew that they were going To tell John Ray what they had just witnessed, and they did call John Ray.

On November 6, 2018, I learned from Joe Scalise that his parents had paid John Ray \$25,000 CASH In a secret payment in the Shannan Gilbert lawsuit against Hackett. Joe Scalise had told people starting' On June 11, 2011 that Shannan Gilbert's body was in the marsh behind Hackett's house. I asked Joe Scalise how he knew that and he told me that there are things he cannot tell me.

I gave these recordings to you in 2018 in one of the data dumps.

On January 8m 2019, EDNY FBI SA [REDACTED] called me to tell me that [REDACTED] was No longer on the case and he was so if I had any concerns to talk to him. He hoodwinked me into Believing I was to work with him, but in reality he was grilling me on how I got the FBI on Shannan's case, Because he did not know.

I believe John Ray, being put on the Gilbert case by Tom Spota to pretend to defend Shannan, but in reality, just to Cover up for Spota and Burke, and also Joe Scalise's involvement of the death and cover up of Shannan Gilbert informed Spota that I had the SDNY FBI on the case to prosecute Pak. I believe John Ray and Spota Discussed how to have my SDNY Feds shut down because the police are covering up a series of murders

Of young ladies that were purchased for the specific intent of killing them for their pleasure.

While I was at the Central Islip court house, I witnessed Chris Loeb tell John Ray the content of 7 of the 7 DVD's that he found in James Burke's duffle bag and that he watched at his home later on When he took out the DVD's from the duffle bag. Chris Loeb was telling John Ray that 5 of the DVD's Were snuff films and that he witnessed choking, torture, beating, raping and killing of the girls. There Were 5 DVD's and one of the girls was an Asian Girl. Michael Pak is an asian sex trafficker who specializes In selling Asian girls for sex. I witnessed Chris Loeb tell John Ray about the 2 child pornography DVD's.

I witnessed John Ray show no emotion and he was nonplussed. I believe John Ray already knew the content Of the 7 DVD's that Chris Loeb found in James Burke's duffle bag because John Ray is in the inner circle of Burke, Spota and McPartland. I witnessed a very intimate look from Spota's eyes to John Ray's eyes just Moment's earlier, and I learned in the trial that Spota placed very important key figures to pretend to prosecute And investigate the Burke beat down of Loeb, but in reality they were covering up the beat down and any Intel of the content of the DVD's from going public. Chris Loeb called Burke a pedophile in the room and Burke realized that Chris had watched the DVD's to know that, and Burke unbuttoned his shirt and beat The shit out of Chris.

The DVD's that Chris Loeb watched have traumatized him to this day and between the beat down and The content of what he witnessed when he watched the DVD's has given him severe PTSD and he Is in the hospital as I write this.

I have been stalked to be intimidated ever since SCPD found out about me. I have had my phone Hacked, my computer hacked, I have had the mafia thugs sent by SCPD in my home, as they took Off door handles for the doors in my home and placed meticulously on the floor, and I was confronted By a mafia thug on December 11, 2019 when I was leaving the Central Islip court house.

He was waiting for me and sitting on the petition. He had greasy hair and as I passed him I saw A 2x2 inch black cube which was a recorder pointed at me, and he said "Got an electric heater?" Just the day before on December 10, 2019 there was a snow storm and I took out two hot Water bottles and plugged them in to put on my person for warmth.

This mafia thug was letting me know that they have a video wire in my home.

I have sent overnight mail that has never been received. They (the mafia thugs) are following Me in a Range Rover - NY License plate HZM-9140. It is registered to a government agency. I have a government agency following me. I have someone extracting my USPS priority mail Out of the system and stealing my mail. I have mailed you to ask you for help, and I am ghosted.

NO POLICE will help me with the stalkers, Not the Westchester DA, Not the Chief of the Westchester Anti Trafficking Task Force, Not the Town of Mamaroneck police for the death threat to me from Pak, Not the Brooklyn DA's Chief of Human Trafficking, and not you, my own Feds.

Why are you ghosting me? I have called and emailed for help and I get silence

You can have an investigator call me to help me get these wires out of my home.

Loretta Lynch is the reason that Spota and McPartland were tried, and the EDNY prosecutors Tried the case. Spota, Constand and McPartland went running to Loretta to have their mess Of the Feds investigating them for the cover up of the Burke Beat down and the DVD's, And Loretta heard her own voice on the illegal wire taps and she had them prosecuted.

James Burke had a prostitution escort agency starting in 1995 and he had a beeper Registered to a [REDACTED] at his home address. He was prostituting boys and girls And one of them was [REDACTED] He became involved with [REDACTED] In 1999 and she left her husband and moved in with Burke and she became the madam Of his prostitution ring, and she used the same beeper as just mentioned that Burke Had since 1995. In the divorce of [REDACTED] the husband, [REDACTED] had His private investigators run intel on the beeper and Burke's prostitution ring, and It was part of the divorce trial. Spota had his own law firm then and he was representing Burke.

I am being followed and stalked by mafia thugs because Shannan Gilbert was killed And it is a huge cover-up. I gave you intel to have Michael Pak and Alex Diaz prosecuted Under the Mann Act, and you did nothing. You have probable cause and Shannan is dead.

These 3 pictures are of the mafia thug that intimidated me at the Central Islip court house On December 11, 2019. He followed me to my car and he was memorizing my license Plate, so I took pictures of him and he turned his back to me. I drove to the court house In a rental car and borrowed a friends EZ pass so that SCPD would not know I was Driving there.

The man below is hiding his right hand because he has a camera recorder in his hand To film me. I was afraid he would do something to me and film me. THAT is what they do.

Please help me. I am afraid every time I enter my home that they will be in my home To rape me, torture me, beat me and kill me and film it.

THAT is the content of the DVD's that Chris Loeb watched from Jimmy Burke's duffle bag.

My number is [REDACTED].

I need help.

I understand you are busy on the Jeffrey Epstein case.

Well John Ray is connected to the Jeffrey Epstein Case.

He did a talk on January 22, 2020 at the Sachem library and he
Said that his life partner, Madeleine Kristofferson was an opera singer
In Sweden, and she was connected to a woman named

Barbro Ehnrom.

Enclosed below is a 3 or 4 minute video in which John connects himself to
Jeffrey Epstein via Barbro Ehnrom and Madeleine Kristofferson.

Also, below is a picture of Ghislaine Maxwell's name in Epstein's black book,
And right next to her name is John Ray with a country code for America
And a [REDACTED] phone number that says (w). John Ray has a coop or condo in NYC
At [REDACTED] It is an apartment with a concierge
In the lobby.

John Ray states that he is actively trying to get the victims names to help the
Victims of Barbro Ehnrom and Jeffrey Epstein. YOU are the Feds on the case,
John Ray is connecting himself to Barbro Ehnrom.

John Ray is a bum and he is an intimate friend of Spota. After I met John Ray
I asked him how the Shannan Gilbert Foundation was doing, and he told me
It was never to be started. He is a liar. I mailed him \$400 in 2012 for the court fees
To start the Foundation. I helped Mari Gilbert make the flyers asking the public
For monies to be sent to Ray and once it totaled \$400, it would be the cost to
File the Foundation in the court

I mailed him the \$400 in November 2012. In December 2016, after I met him,
I asked about the Foundation and he lied to me and said it was never to be started.
I told him to refund me my \$400 and he lied and told me that it went to his case,
But I told him the money was earmarked for the SMG Not-For-Profit and that
He put the money in his pocket.

My lawyer, Andrew Maloney told me to write the Bar Association and have him disbarred.
I did. Ray was not disbarred. And I knew why the minute I saw the look between Spota
And Ray - because SPOTANEEDSRAY to be the sleazy unethical fraudulent lawyer
Representing Shannan Gilbert.

Enclosed is the letter from the Bar Association to tell me John is not disbarred.

Please find a refund check to me from Ray's law firm, but his
Partner signed the check in the amount of \$400 to refund me my monies that
I sent to him in 2012. I wrote on the bottom left hand corner of the check
"Sampierre paid \$400 in November 2012 court fee to John Ray for Shannan M. Gilbert
Foundation - 501 c 3. John Ray NEVER filed it - lied to me for years."

Last but not least, here is a recording from November 6, 2018 in which Joe Scalise tells me that his family gave John Ray \$25,000 secretly and that no one knew about the money to help with the Shannan Gilbert lawsuit. That makes Scalise a 3rd party in a 2 party lawsuit, and allows the Scalise family to lead Ray by the nose and dictate to him what to do. What is the motivation of the Scalise family? Many people, I included, believe Joe Scalise is a strong POI in the murder and coverup of the murder of Shannan Gilbert.
