Also, while searching on the internet to answer your questions, I came across a recent interview she gave with some random podcast/youtube channel. I wanted to bring it to your attention. It looks like a wacky conspiracy theorist type of thing. She made some *extremely* concerning comments about the FBI, you, "elites" and Jews. I took some very rough notes when I listened to it. A link and my notes are bottom of this email. Apparently there's a part 2 coming out sometime soon.

██████████ Allegations Against Maxwell

From complaint:

- In her position at the front door, she observed that Maxwell was regularly bringing school-aged girls to the mansion and that the girls were always escorted upstairs
- Maxwell described her role to ██████████ as recruiting models for Epstein, and told ██████████ that the girls were interviewing for modeling positions with Victoria's Secret, a lingerie retailer. ██████████ witnessed Maxwell approaching young females on the street and talking to them outside of the mansion. Maxwell would leave the mansion claiming she had "to go get girls for Jeffrey" and referred to the girls she was recruiting as "nubiles."
- After complying with his request for a massage, Epstein invited ██████████ to sit on the bed where he was watching television. Maxwell then joined them on the bed. Epstein and Maxwell proceeded to attack ██████████ physically against her will, including by violently sexually assaulting ██████████
- After ██████████ returned to New York from Ohio, Maxwell called on behalf of Epstein and threatened ██████████ in order to keep her quiet: "We're going to burn all your art. And I just want you to know that anything you ever make will be burned. Your career is burned."
- Maxwell again called ██████████ to threaten her, but this time threatened ██████████ life: "I know you go to the West Side Highway all the time. While you're out there, just be really careful because there are a lot of ways to die there."

From Interviews:

- [NYT] [after a foot massage for Epstein] Ms. Maxwell joined them on the bed, ██████████ said, and the night took a sudden turn: Both Mr. Epstein and Ms. Maxwell began groping ██████████ over her clothes, rubbing her body, commenting on her features, and twisting her nipples to the point of bruising.

She said they did so in unison, mirroring each other's movements. Fearing that she was about to be raped, [REDACTED] eventually fled the room and barricaded herself in another part of the house. She soon discovered that three nude photographs she had kept in a storage box were missing. The photos were of Annie and a third Farmer sister, who was 12, modeling for [REDACTED] figurative paintings.

- [ABC] "I sat down. And Ghislaine got on the other side of me, and they proceeded to -- touch me," [REDACTED] said. "I don't remember the assault. I remember being in a lot of pain. I remember having some bruises. I don't remember everything they touched. But they didn't get my clothes off. They tried." "I was in an absolute panic to the point where I was able to get myself up and get out of that room," [REDACTED] continued. "And Ghislaine came after me, but I literally took these big pieces of furniture, and I pushed them against the doors. And I stayed up all night."

Recent Podcast Interview

Said [REDACTED] wished people would make public statements about [REDACTED] so [REDACTED] could sue them. "I have all this medical stuff going on that I wish I could pay for"

Hates the FBI, they're in on it etc.

"I think the FBI was created to protect these people"

Wants to explain the level of abuse I've endured. Says the FBI told [REDACTED] to not tell anyone (back in 90s)

FL case – FBI agent was amazing, like a superhero. But now nobody can find [REDACTED] They took [REDACTED] off the case because they didn't want it solved.

Angry that no victims were offered witness protection (in FL case)

Our case:

Berman is the most "ominous character" "he is so awful" "knows that I know a lot of stuff"

NYPD is amazing, they're the real deal. The FBI sweeps in and takes the credit. NYPD did all the work.

He never in a trillion years would have taken his own life. He was an intelligence asset.

"[REDACTED] was ordered to kill me"

Says [REDACTED] started when [REDACTED] was on Wexner's estate

The FBI was the worst enemy of all

We go to New York – [REDACTED] has had very little contact with [Epstein and Maxwell]" "it was horrifying contact but it was just brief. [REDACTED] saw nothing and [REDACTED] was never around any other women"

[REDACTED] angry that we interviewed [REDACTED] and not [REDACTED]

"They are absolutely blatantly not wanting to know anything"

(in the 90s) [The FBI] "wanted to feed more children to him I guess"

"When you're around these people, there is something completely off and different. About this one group...and for a long time, had a problem with all Jewish people. I'm going to be honest with you. For a long time I was thinking it was all the Jews. My sister is like - [REDACTED] it's just the ones you met. It's unfortunate that all the Jewish people that I met also happened to be pedophiles that run the world economy. So it like gives you a bad taste in your mouth. But [REDACTED] [sp?] has kind of helped me with that. I kind of understand it better now. [...] they did a number of all of us."

A lot of rambling about elites. "This is how the elites speak to, I don't know, the people who aren't Jewish"

[talking about Epstein and Maxwell] "Anyone who was not Jewish, the way that they spoke about them, it was really horrifying. It showed me a great deal about how these people truly believe that they're chosen to do something here." "It was every one of them, the way they spoke"

"Ghislane made it very clear to me that [REDACTED] would have been so lucky to be able to carry a Jewish baby"

Complains about how mainstream media doesn't cover this angle.

"This is a big part of it." "This elitism is very deep and these are the people pushing racism, these are the people say that there's white supremacy, which maybe there is in some ignorant southern hillbilly groups, but I don't know any white supremacists, but I know a lot of Jewish supremacists, they're all elites. And they're all connected. They are the biggest supremacists I've ever met." "they made it very clear that I was a servant because I was white."
