██████████, date of birth ██████████, was interviewed at ██████████. Present for the interview was AUSA ██████████, AUSA ██████████, Detective ██████████, and Special ██████████. After being advised of the identities of the above listed individuals and the nature of the interview, ██████████ provided the following information:

██████████ is currently a stay at home mother with three children. Her husband is in the ██████████ and he deploys a lot so they have lived all around the country. ██████████ is currently in school for psychology. She has two younger siblings, a brother and a sister. ██████████ had just recently told her parents and grandmother about JEFFREY EPSTEIN. ██████████ grew up in ██████████. She moved to Palm Beach with her father around 9th grade when she was 14 years old. They lived in the ██████████ area and she attended ██████████ and ██████████ High School. ██████████ left the Palm Beach area when she was around 21 years old.

██████████ met EPSTEIN through friends. ██████████ was told that if you give a guy a massage in your bra and underwear, you get paid \$200 for it. Her friend, ██████████, had the contact number for ██████████. ██████████ didn't have her parents watching her often. ██████████ was also involved. This is around the spring time of her senior year and she remembered this because she stayed at ██████████ aunt's house. ██████████ did not turn 18 until after her high school graduation. This could have been during her junior year but ██████████ is not 100% sure. It was either 2004 or 2005. ██████████ recalled ██████████ driving her and ██████████ to EPSTEIN's home. This was the only time she visited EPSTEIN. ██████████ received a call from ██████████ afterwards asking for ██████████ to come back but she did not.

The day ██████████ went she is greeted at the door by EPSTEIN. ██████████ went with only ██████████. ██████████ stated that it was not normal for EPSTEIN to

answer the door. [REDACTED] had known of [REDACTED] name prior to going because [REDACTED] had her saved in her phone as "[REDACTED]" was at the house that day holding a book. EPSTEIN was wearing a grey sweat suit when he answered the door and had them come inside. [REDACTED] met [REDACTED]. [REDACTED] told her that was [REDACTED]. EPSTEIN disappeared for a bit. They were waiting in the living room area that had a desk in it. There was a chef there. [REDACTED] never got [REDACTED] number nor had any personal contact with her afterwards. [REDACTED] told them it would be just a few more minutes before EPSTEIN was ready. [REDACTED] walked in and out as the girls waited. There were lots of books in the waiting room.

[REDACTED] told them that EPSTEIN was ready so [REDACTED] and [REDACTED] walked upstairs. [REDACTED] may have walked with them but [REDACTED] was not sure. They then walk out the back sliding door near the pool, then back inside and up a staircase. They went into what she believed to be a pool house which has a massage room attached to his bedroom. There was lots of nude pictures and paintings on the walls. [REDACTED] instructed [REDACTED] to get in her bra and underwear so they both did. EPSTEIN talked to them normal and asked about their school and family life. EPSTEIN undressed and got on the table. After a while, EPSTEIN asked [REDACTED] to leave. EPSTEIN then grabbed [REDACTED] on her buttocks and pulled her closer. EPSTEIN [REDACTED]. He told her to relax and wanted [REDACTED] to touch his nipples. EPSTEIN told her, "Breathe in through your stomach; it will feel better". He then jumped up and said he couldn't finish and he had other clients. EPSTEIN was frustrated with [REDACTED] and jumped into the shower and had her go into another room.

EPSTEIN got money out of the bedroom. [REDACTED] was waiting downstairs and was paid \$300 in the kitchen area. [REDACTED] told [REDACTED] that you get paid more to bring other girls. Also downstairs was the chef, [REDACTED], and another unknown male. EPSTEIN sat at his desk in the living room area after the payment and he talked about his work before [REDACTED] and [REDACTED] left. EPSTEIN said he was a neuroscientist. [REDACTED] recalled his penis being really small and she did not want to look at it. [REDACTED] may have called [REDACTED] to come pick them up but was not sure. [REDACTED] recalled that she had a pink razor phone. [REDACTED] arrived with [REDACTED] (known to law enforcement as [REDACTED] [REDACTED]) in the car to pick them up. They then left to go to a Florida Marlins game.

[REDACTED] did not have a detailed discussion with [REDACTED] about what occurred inside the massage room. [REDACTED] was more wild than [REDACTED] and may have went more than once. [REDACTED] (known to law enforcement as [REDACTED]) may have went to see EPSTEIN. [REDACTED] went more than once or twice and she sued EPSTEIN. [REDACTED] received some money for speaking on behalf of [REDACTED] lawsuit. Her attorney was Bob Josefsberg. [REDACTED] spoke with them over the phone about the case. [REDACTED] recalled being in [REDACTED] room when [REDACTED] received a text from [REDACTED] stating that EPSTEIN wanted them to come back. [REDACTED] told her no.
