didn't understand why she needed att.

Jt made her feel like he was her
buddy/sidekick

1st met told him she was 16
friends said don't say how old you are

didn't say ' underage girls' to her
but would say "you know what
I like"

she knew that meant he
wanted young girls

trial & error - he would tell her who he
liked

girls bringing from trailer park environment

ones c brought were young
he didn't like black, mixed

when working at club brought adult
when woman took off clothes, he left
said had to go. Gave money & they left

of age girls she brought just didn't
care to go

told girls C brought to tell him little

he wanted to know what girls

 (last name) JE really liked
looked very young

wanted \$300 to give to both girls
VA shook up & never wanted to go
back

believe there were certain girls
took to diff. level

In beg.

told girls just giving massage

later (so girls didn't freak out)

told girls he's gonna jack off
& look at you

JE voiced to C "why didn't you
tell the girls"

{ wanted to touch & jack off }

that's what he wanted C to tell them

JE was open about which girls he
really liked

- normal convo C talk about life w)

C $\frac{1}{2}$ [REDACTED]

- Jt would ask about mom (knew she struggled w/ drugs)

- they'd talk about bdays

doesn't remember girls telling her if Jt asked their ages

[REDACTED] would relay messages about girls Jt liked what's up w/ so so

staircase, bedroom, bathroom
shower, sauna

dresser in corner

1st lotions
drawer

2 sex toys

if Jt wanted use sex toy he'd get up $\frac{1}{2}$ get it

- it was normal routine

go in together 30 min
each massage a side

JE ask her^(C) go downstairs

he would flip over & say ^{you can go} downstairs
chef make you whatever food want

█ went multiple times

living w/ █ & her dad

█ still going to school &

she told C that people were talking
bout JE in school

█ (underage) 16 or 17

- stormed out & told C lets go ^{she} upset

- JE later called C & said please
tell her I apologize

- went one time after that


- gave her lot of money to make
