[REDACTED] / [REDACTED], just wanted to triple-check, does FBI know that we're sending out this notification? **It is Post indictment under the AG Guidelines We are responsible for sending out ALL notification.**

And [REDACTED], did you have language tweaks you wanted to provide (particularly on the plea language)? **I don't think you can tweak anything on the standard letter. This letter is mandated by EOUSA. The language is what all victims are sent coming from the DOJ from every USAO. We would need special permission to change language.**

I think we *\*have\** to get this out today since it's about the hearing on Monday, and in the future will want to be well in advance (that's on us for this one, I should say, not [REDACTED] or [REDACTED]).
