1. The following is a preliminary report and does not contain all information relative to this criminal investigation.
2. After making an initial disclosure of a sexual relationship with an older man to a friend, a female juvenile known to the commonwealth went to the Norfolk Advocates for Children in Foxboro on Wednesday, March 30, 2011 and had a SAIN (Sexual Assault Intervention Network) interview. During the interview, this female juvenile provided a statement alleging that she had been having a sexual relationship with a 72 year old white male. During her interview, the juvenile stated that she was introduced to the man in the spring or summer of 2009 when she was 14 years old through a woman friend of hers by the name of Phyllis Capuano, [REDACTED] a.k.a. "Kookie". Prior to the juvenile's arrival at the man's Quincy, MA residence, it was explained to the juvenile by Capuano that the male would provide payment for sex. The juvenile described in detail how she and Capuano [REDACTED] in front of the man to include

You see, Bill O'Connell was arrested and convicted of cocaine trafficking, but this arrest came only because a fourteen year old girl accused him of raping her for one year. They *had* to arrest him and he had many grams of cocaine on him when arrested.

Can anyone tell me when one of these top wealthy dealers was arrested in MA ? They aren't and in some cases they are even protected ! It also appears to me that one cop tied to him hacked this document to delete information on it. I also found some of the below Ebay accounts appear to have been canceled and reissued by a random person. This hides who the original owner of that account was and hides the cops ties to O'Connell.

Ebay accounts are used to pass money via Paypal and these cops have transactions with O'Connell. Below is one woman who pimped the child out for money and gifts.

A grand jury returned a total of 17 indictments Monday against William S. O'Connell, 71, and Phyllis Capuano, 21, on charges that stem from several alleged statutory rapes of a now 15-year-old girl over a two-year period.

O'Connell faces four counts of statutory rape, each of which stem from separate incidents. Capuano's charges stem from one of those incidents, which are alleged to have taken place between June and September of 2009.

O'Connell was indicted on 12 charges; Capuano on five.

Both are charged with committing statutory rape in the 2009 incident, as well as conspiring with and aiding the other

Rebecca Resendez, the alleged victim in the statutory rape case against Quincy developer William O'Connell, was killed in a fiery car crash early Tuesday ...

His name is Wm O'Connell and he is a part of this donor 'Enterprise'. He's another who wants me silenced. Me and many others feel this influential pedophile needs to be investigated, including the child's sudden death.

Has O'Connell ever communicated with Jeff Epstein? I cannot confirm whether he did or not, but you will find some eerie similarities within these documents. I know he drove his yacht to the Carribean, but I don't know if that was to visit Epstein's island, and I know this group has ties to the wealthy in Manhattan who were arrested for paying bribes to NYPD. But today I found they have accounts using the name of Ghislaine and appear they may be tied to the Granite Reality-Realty Group who claim to own her home. Below you can see a few tied to Bill O'Connell, but there are many more than that, and the BNEG nightclub owners have over one hundred realty companies they silently control and own. (Many tied to Seaport where Granite is located)

In September, William was arraigned in Norfolk Superior Court on charges including four counts of statutory rape, one count of cocaine trafficking, and two counts of committing an unnatural and lascivious act with a child under 16. Statutory rape convictions carry a minimum sentence of 10 years per charge. (William pleaded not guilty to all charges.) He retains a prominent role in three other development corporations — O'Connell Denver Properties Inc., Seaport Aviation Inc., and Seaview Real Estate Inc. — and, pending trial, is allowed to travel to Florida, Colorado, and New York for business, though he must submit to regular drug screenings and cannot

As soon as I heard the name Granite Reality and McClellan & Fish, I began checking into them. I did this because for many years I've sent in their extensive billion dollar hidden real estate, the many real estate companies and investment companies owned by these police and nightclub owners, and their online mortgage and loan companies. (They have many straw buyers but they silently own and control them).

Aside from that, I've found almost one billion in nonprofits they own using fictitious names and tied to these law firms, so I may have found a connection. If they are connected to Epstein and Ghislaine, it would be this underground group who placed her in that home. (see below)

I found more information on the above than I thought I would, and my new document titled Epstein, Ghislaine, and O'Connell ties is below. Harboring a fugitive? This document was added on 7-5-2020.

If you send this document back to Massachusetts nothing will happen to him. I've tried and I received nothing but more abuse from the corrupt police who support him. They all protect one another and you will see why if you view my other documents.

This group chose to surveil and chase me around state to state and year after year all in a bid to silence this information, yet hidden under the guise of a legitimate investigation. Over ten years straight and still no charges. Why? Because they are really doing this to watch me with hopes of protecting the wealthy I've been reporting, and I've sent ample proof showing this over the last eight years.

A crime is investigated and not a person. You don't investigate a person to wait for them to commit a crime, so what crime did I commit twenty years ago when this began and just after I divorced a trooper who has always stalked me? There can't be a different interpretation of law for the wealthy and the common man. From day one, MA law enforcement has been trying to bail out the corrupted troopers and wealthy committing crimes, as well as the police's heinous and blatant corruption, but chasing me around with hopes of silencing me. Aside from that, how come they're not investigating the troopers stolen overtime ten years back? Why only one year ago when most people know all of them didn't begin this one year ago.

It's to let them off easy, because they're probably stealing \$15,000 yearly. For those of you who don't know, one hundred MA State Troopers have been arrested since 2010, forty six of them arrested or implicated for stealing overtime while forging tickets. The Feds also just arrested the head of the MSP union, Dana Pullman.

The MSP hired Leigha Genduso years ago, an admitted drug dealer, perjurer, and money launderer, with her past criminal actions and acceptance on the force tying into all I've reported since 2010! Below is a story on the MSP hiring Leigha Genduso who had a long term relationship with a LT Colonel! That's okay with them providing she doesn't report their corruption as I do.

So think about it, over 20 years chasing me around, but just as many years working for and with the below wealthy man (Wm. O'Connell) who was arrested for child rape and cocaine trafficking. This child was killed one week before her trial was to begin so he got off, but the MSP swamp isn't looking his way because I'm much more important to them.

O'Connell is tied to the BNEG Nightclub and restaurant group which Joe and Ed Kane own. He's also closely tied to the MA politicians who still do business with him. BNEG has a brother who is a SGT on the MA State Police named Charlie Kane who I personally know and socialised with.

This wealthy and influential group, including rapist and cocaine trafficker O'Connell, appear to have their own private police force protecting them and the same force after me. O'Connell is one of the Kanes top guys and below you'll see how they do business

together. He's bad news and so is this group of rogue troopers. The only folks who don't believe he was involved in the child's death are his friends and these troopers.

Below, you'll also read about the corrupt attorneys who work with the troopers.

This document is about the little girl and the wealthy man whose family seems to avoid jail time, avoids thorough investigations, and scrutiny of his crimes due to his political affiliations and wealth.

On April 15th, 2018 this document was sent to FBI offices outside Massachusetts, Washington DC, and several other people I felt would stand for this child and look into O'Connell and the child's death. I've sent it to Boston [REDACTED] [REDACTED] as well. (They have now retired)

This document is to show who the members of this 'enterprise' of police are, including those MSP are loyal to, a wealthy child rapist and cocaine trafficker, while they harass me year after year and make up excuses why they are doing so. They've done this since I divorced their co-worker.

O'Connell, is a man tied to a few 'untimely deaths', as well as rape and drug charges, including the death of his friend under his boat propellers, murders by others in his family, a woman killed and buried, his son shot a US Marine and only got seven months, and O'Connell is one who the MA authorities refuse to investigate or surveil.

O'Connell was raping a child and arrested for cocaine trafficking, yet he's Trooper Charlie Kanes buddy who apparently knew about O'Connell and his child victims. (this is explained below).

The question is why does L.E. refuse to do their jobs and investigate the many horrific crimes against women and children, MSP crimes against humanity, or the massive government fraud driven by greed taking place by MA police and attorneys? I've already done all the footwork, and have submitted their paper trail, so the rest should be simple.

I've quoted this good male police officer in the past and I will quote him again today, because he can say in a few words what takes me thirty pages to say. He is one who knows what they've done to me since I separated.

*“THERE have long been whispers of prevalent sexual harassment in the law enforcement industry, but none have dared come forward with public disclosures. Given the exhaustive debates since the #MeToo campaign began, one would expect considered responses. Instead, it is dispiriting to witness many within the industry peddle the same tired tropes of shaming and blaming victims, and assumptions that sexual predators can be easily discerned.*

*It is ignorant to pretend that conditioning and social pressures have no effect on victims' ability to speak out, that sexual harassment cannot intersect with other disputes, or that 'hard working family men' are precluded from scrutiny. Abuse of power in law enforcement is particularly insidious given that informal work conditions are taken by some as a licence to exploit. For better or worse, the public looks up to police who, as such, have a civic responsibility to send the right signals. Being called out is not enough.*

*Sorely needed is an elected body of representatives and outsider experts to draw up a code of conduct and audit productions. Amending harassment legislation to grant the federal ombudsperson suo motu powers to investigate and arbitrate such claims would also show that harassment in any quarter will not be tolerated and will be followed by serious sanctions. For too long, in the absence of accountability and*

*restorative justice, women's experiences of abusive men have either been hushed up or relegated to 'whisper networks'. The industry must make it clear that, when women do speak up, their voices will be heard."*

**BILL O'CONNELL Both Protecting and Protected by the CORRUPT**

*SOUTH SHORE SEX and DRUG KINGPIN*

My name is Lisa Kenney and for almost nine years I've been reporting abuses and corruption by several MA troopers who are seemingly involved with bank, grant, and healthcare fraud, connected to pharmaceutical companies, doing business with unethical attorneys, nightclub owners, and construction companies, and their obvious money laundering.

I had been married to a trooper who I lived with for twenty years, and I dated one of the most corrupt and vindictive troopers mentioned below. I ended that 'friendship' due to his odd, vindictive, and egotistical behavior. His name is Trooper [REDACTED]

It seems no one in Massachusetts wants to investigate this group and excuses are made up as to why they are not. "There isn't enough evidence" is said, although I've sent almost their entire paper trail on their laundering, federal grant fraud, real estate, and bank fraud which O'Connell is a part of.

In order to get more evidence someone has to investigate and it's been proven MSP never investigated their own! I'm asking that this young rape victims sudden death be investigated because her sudden death is highly suspect, and the only folks who don't believe O'Connell was behind her death are the LE and politicians connected to him, those who accept his donations, and who are friends with him.

O'Connell would pay multi millions of dollars for others to look the other way and he is one of the civilians funding the troopers on the side to try to silence me. I've received numerous death threats, rape threats, threat to be "shot in the face and head", and two separate men have tried to force me into a guard rail on the highway. I have submitted these plates in the past. (See my Denise Robert doc, a FBI unsolved murder)

L.E. frequently asks the public for tips or help when crimes are committed and I've supplied a lot more than tips. These are excuses for an unwillingness to do their jobs or

investigate their friends, either that or it's due to reelection issues. (As it turns out, it just may be and that document has recently been sent)

People are being abused and there's hard evidence children and women have been raped and exploited, along with government grant money stolen. Today, I am focusing on the top wealthy civilians who the corrupt police and attorneys are loyal to and all are protecting one another.

I've sent thirty or more letters on this to former Director James Comey of the FBI and the FBI in Massachusetts. No response from them, but I've received more abuses from the corrupt I've been reporting.

Over the years I had been searching for a specific civilian who is tied to and heading this group with the nightclub owners Kanes of Big Night Entertainment (BNEG), and I believe I've now found him.

Based on what I've found over the years, I allege this 'enterprise' is laundering millions of dollars offshore, including stolen federal grant money, and bringing it back in via real estate and mortgage/financial companies. The attorneys deal with the legal loopholes of this while the wealthy nightclub and business owners launder the money through their many companies. This information can be found on my BNEG and Donor Racket document.

Seven years ago, one of these police officers was online writing to the other police and he told them;

"The person you REALLY work for drives his yacht to the Caribbean during the Winter, has an indoor swimming pool," and he gave a couple more hints as to who he was without giving his name. I believe they said he also owns a bakery but I'm not positive.

Someone in their group deleted this statement just after I found it on a website where they frequently communicate with one another. This is the same site Trooper Charlie Kane was posting his own writings about me which I have sent in the past. Since they have been hacked into my pc for years (per Computer Forensics Associates of Boston),

they see all of the information I am obtaining to send to you and delete any evidence I find.

For those new to my documents, I've previously reported their use of online servers to conduct their business and Kane's distribute laptops to members of the enterprise. I've sent this information in the past and I've sent proof they're distributing laptops. In fact, during 2007, and once Trooper Manning was off probation from MSP, he kept sending me emails asking me to tell Trooper Kane he needs a laptop. Manning later hacked my emails and deleted that conversation so I couldn't submit it. The laptop info is shown on my lawyers and courts document.

Based on their comments and other information, I've tried figuring out who this single wealthy person was for years, the "person they really work for" and I believe it is Quincy Developer Wm. O'Connell, the man mentioned above who was arrested for child rape and cocaine trafficking.

O'Connell is good friends with Norfolk DA Mike Morrissey, Rep Bruce Ayers, the Kanes who own BNEG nightclubs, Senators Keenan, Keating, and Senator Brian Joyce, FX Messina, and several politicians including Delahunt.

He's also described as one of the most powerful Massachusetts developers with strong political influence. Most of these politicians' names have already been mentioned in my many letters to show their ties to the corrupt police and unscrupulous attorneys. One being Braintree Attorney Kathleen Morrissey who you will read about below.

Kathleen is tied to the Messina boys who violently drugged and raped my friend, they are more big donors to the DA's office who never charged them with the rape either. All of these wealthy 'donors' seem to get away with their many violent crimes. At the same time of her rape I found these troopers had pay transactions with the Messina boys who raped SK. (I was invited out with her and them that night but declined). The Messina's also want me silenced, and the last time I was in their section of MA, a couple of them followed me around. They're easy to spot because their license plates begin with FX.

Due to his friendship, DA Mike Morrissey had to hire a special prosecutor for Wm. O'Connell for the rape and drug charges. I'd be curious to know if the fire which was in his office destroyed any information on the Messina rape. There was some backdoor settlement with my friend who probably thought it was normal court procedure, and it

was probably Attorney Morrissey who scammed her to settle and protect the Messina boys. The Messina's are also connected to Wm. O'Connell.

The two of them are also found entangled in the same drug treatment centers which troopers, lawyers, and some judges are silently running, including Judge Bibaud of the latest MA State Police scandal shown in the link below.

MA keeps screaming for more "drug epidemic money", yet the major wealthy white drug dealers, one whom I believe to be Wm. O'Connell, his son, or his nephew, are NOT being watched or investigated!

A little background on O'Connell is below and includes his arrest for child rape of [REDACTED]. He had nineteen grams of cocaine on him at the time of arrest. This is who the rogue MSP and politicians are loyal to.

A couple of nights ago I found information tying him to these troopers and I found plenty of information which shows they were aware of his yearly rape relationship with this fourteen year old girl who he lavished with money and gifts for sex.

They have registered plenty of shell corps and accounts using the fourteen year old girl's name, as well as the adult female named Capuano who pimped her out to O'Connell, a man who is in his seventies. They also used to run online 'Sugar Daddy' websites which they were members of. It's possible he met Capuano through the troopers website?

He's probably on the list of names of those who visited Jeff Epstein when he "drove his yacht to the Caribbean". They do have Ghislaine Ebay accounts. Check them quickly, or they'll certainly contact their friends in the law enforcement section of Ebay to delete, alter, or have them reissued to a random person not tied to them!

This is also a way kickbacks and political donations are distributed between these cops and attorneys. I've collected twenty million of their transactions since 2010 so I can identify them easily.

As you can see below, the account using his boat name holds 226 transactions and these will be transactions connected to O'Connell and the police ties to him. The transactions could be tied to his construction co, his nightclubs, or the little girls he raped.

KEEP IN MIND, I sent this information in a few years ago, so they've had plenty of time to get their Ebay friends to alter or cancel and reissue the below account name. They do this ALL the time to protect the original owner of the accounts they don't want connected to them! I've seen it happen with all the important accounts which expose them.

To break it all down for you, I've provided the link to their fictitious names shown on Behavioral Healthcare .

SAMHSA and BHTCC have to do with federal grant awards as explained on their website.

I've also supplied the cops and lawyers Ebay accounts for both these grant names of Samhsa and Bhtcc, and I've supplied the cops Ebay accounts they've created using the same fake names found under the center's leadership.





Her alias of Wilson is displayed first.

Morrissey is also connected to Wm O'Connell and all of the above engage in these activities together and have for over twenty years. She is also tied to the Messina's who raped my friend. This is shown on the sexual assault document.

Back to O'Connell..

A special prosecutor or investigative agency from another state is needed to investigate MA, O'Connell and the rot of society posing as police officers. Law enforcement ignored all of the rape and death threats which were sent to me via email and also directed at my minor daughter.

Since they're hacked into my pc, they can see the information I've been compiling and typing on this document. Rest assured, they will run to O'Connell and tell him what I am reporting which they've already done in the past with others.

**QUINCY, Mass.** — Less than two years after William O'Connell was charged with having a sexual relationship with a 14-year-old girl, and three months after the girl was killed in a fiery car crash, the wealthy Quincy developer is likely to walk out of court Friday a free man, our news partners at the [Patriot Ledger](#) reported.

A prosecutor and lawyer for O'Connell will present a plea agreement to a Norfolk County Superior Court judge that drops all charges against O'Connell, including four statutory rape counts and a cocaine-trafficking charge.

Keep one thing in mind while reading all of this, they know I've been collecting this information for years so they've had plenty of time to discard their hard drives, get new cell phones, close places they've held illegal 'stings', and destroy evidence. This is one reason they are still hacked into me, it's to protect, destroy, and prepare to discredit my findings and reports. They also have many attorneys coaching them behind the scenes.

O'Connell, a man who was convicted of multiple felonies, but a man who has money and ties to politicians and law enforcement, coupled with LE's priorities tied to elections, their political party, and a group blinded by greed, makes for a failed government and sham democracy.

I'm going to be showing more of O'Connells ties to the rogue troopers, the Kanes, and their ties to the escort business. What better way to protect the wealthy men, the

wealthy married men, married police, politicians, and the paid escorts than to have police run the show?! They are able to protect both the 'john' and the escorts since they're usually the ones responsible to arrest them.

There's one trooper I consider to be a sexual predator who has boasted about women deserving to be raped, lives at strip clubs when he's off, supports rapist Messina who raped my friend 'S', and he films unsuspecting women undressing, in the bathroom, and having sex. He's also posted numerous photos of naked women in their bathrooms on Craigslist and titled the photos 'Peeping Tom'. His name is Trooper David M. Manning whom I dated a few times and ditched.

In fact, he tried forcing me to have sex with him by holding me down, until I got angry and threw him off me so nothing else happened. He is the one currently sending ex-cons and criminal informants to harass and commit crimes against me in NH.

Years ago, one of the troopers told the others online "If I go down I'm taking everyone with me" and I'm pretty sure it was Manning who wrote that. This is the reason I feel they haven't held him accountable or even responded to my hundreds of letters about his crimes against me and my child. Manning was a part of their group long before he got on the state police because he probably worked for one of their nightclubs. PI Bob Long is one who is a part of this 'enterprise' because Long works for these same wealthy folks.

### **Facts on the O'Connell Family**

William O'Connell was charged with raping a fourteen year old girl for years and was charged with cocaine trafficking. He gave her cash and allowed her to use his credit card to purchase thousands of dollars of goods in return for sex. Child was killed one week prior to the onset of his trial.

William O'Connell was given six months probation after being charged with negligent motorboat homicide in 2002. O'Connell's best friend, William Sanderson, 62, of Quincy, was killed when he was struck by the propellers of a boat with O'Connell at the helm off Chappaquiddick Island. A charge of drunken operation of a boat was dismissed."

O'Connell was charged with assault with intent to murder, assault and battery with a dangerous weapon and unlawful discharge of a firearm.

O'Connell listed his occupation as a real estate developer with Marina Bay Development in a report filed earlier this year with the state Office of Campaign and Political Finance. There may be ties between him, Epstein, and Granite Reality.

He and his extended family have given thousands of dollars to local Democrats, politicians, and candidates over the years, including to U.S. Rep. William Delahunt, who lives at Marina Bay, and Treasurer Tim Cahill, also of Quincy.

This is not the first time that the extended O'Connell clan has run into trouble with police. Robert O'Connell's cousin, Matthew "Ky" O'Connell, was convicted of second-degree murder in the 1987 stabbing death of Julie Hamilton, 22, who grew up in Randolph. Hamilton's body was found in a shallow grave in a wooded area about 100 feet from the house where Matthew O'Connell was living with his mother. Matthew O'Connell, William O'Connell's son, was sentenced to life in prison with the possibility of parole after 15 years.

O'Connell 74, crashed his helicopter while entertaining two women in their twenties. The troopers even created Ebay accounts under the womens names.

O'Connells son was arrested for shooting a US Marine and firefighter during a road rage incident. O'Connell got off as the firefighter 'decided' to not press charges.

BNEG and O'Connell own nightclubs and restaurants next door to each other and have worked together for years. There seems to be lots of deaths surrounding O'Connell and his family and they always seem to get no real punishment or prison time.

Due to the sudden death of his young victim, O'Connell got off.

When arrested O'Connell had nineteen grams of cocaine on him.

Where did he get the large amount of cocaine? His sons? Do police watch them ? No, they do not. All law enforcement should know major dealers have 'safe houses'. Did anyone do any checking on the abandoned Quincy apartment where they found millions of dollars worth of cocaine and cash?

Guess who's a part of that complex? Bill O'Connell is!

A man named David Max Aaronson grew up near him and was arrested in 2008 for cocaine trafficking. I later noticed he was online with the troopers when he posted a photo of his stomach tattoo while communicating with them. He could be one of O'Connells Quincy drug dealers as well.

Most of their business is done online to avoid a footprint of their communications and dealings. This is how I'm able to find them.

I'd like to add that I believe there is more to the sudden death of the child rape victim [REDACTED] which I'll explain below. There are many people who feel her death should be properly investigated, especially since we know O'Connell will continue preying on young girls due to his protection.

This group will lead you to one of the major drug dealers in MA which for some reason law enforcement doesn't seem to be in a rush to find them.

Perhaps the dealer IS O'Connell or his sons?

This group was well aware of O'Connell's relationships with these girls, minors, and escorts, and yet they still referred to him as their 'real boss'.

I can also provide many of their Ebay accounts and shell corporations which were created under the woman involved with the Resendez girl, including the Malden officer who investigated her death and the fiery crash.

There was an Ebay account they created under the investigating officers name at the same time Rebecca returned to MA to prepare for trial. According to online news networks, the officer who investigated her death is Captain Gatcomb of Malden PD who was a detective at the time. When I contacted the PD involved they wouldn't respond to me because the MA troopers told them to ignore me.

I've provided the Gatcomb Ebay below. Again, he is the one who investigated the girls 'accident'. Someone placed a 'B' in front of his last name and I don't know if that is for Bill (O'Connell) or the troopers who use 'B' a lot online as a reference to their group. (I have monitored their online dealings for twenty years)

If this is the investigating officers Ebay account below, then it should raise suspicion of both her death and the investigation of the accident. If it's a troopers account, it's also highly suspect due to their business and friendship ties with O'Connell. I'd be willing to bet O'Connell would pay millions to make his statutory rape case go away.

Why was the rape victim driving a car she wasn't supposed to be driving, and is the owner of this car affiliated with the Phyllis Capuano girl who pimped her out to O'Connell?

Were accelerants found in the vehicle? I'd be willing to bet no one searched for them, and I'd be willing to bet the car can no longer be found.

Did anyone find any connections between the vehicle owner and Capuano, O'Connell, or any of his many construction businesses tied to the area where she lived or crashed ?

I'm sure one of O'Connells employees had ties to either the rape victim, Capuano, the car owner, or some of their family/friends. O'Connells reach is far and wide but I'm sure the ties can be found. Did anyone look for them?

My auto smelt of gas for a few days during the time two separate men were sent to try and force me into a guardrail on 93. I've since sent in their license plates.

Was there really a passenger in the vehicle with her and how did she escape slightly injured if the car went airborne and burst into flames? O'Connell would also pay a lot to say someone was in the car with her as a 'witness'.

One of them threatened me during 2011, they said " we pay a lot to get what we want" and I still have this on email.

Did this passenger see anyone try to force [REDACTED] to crash, or when she lost control of her vehicle before the crash ? NO, because it happened at 330 AM when most are asleep.

I find it highly odd that during 2012 [REDACTED] arrived back in MA, finds a car she wasn't supposed to drive, is immediately killed, and at the same time, these troopers connected to O'Connell created an Ebay account using the investigating officers name!

All of the above happened one week before the trial, the child was suddenly killed, and O'Connell got off and avoided the rest of his short life in jail.

I've checked all Ebay accounts including bgatcomb, billoconnell, and thundernlighting, and all three of them appeared to have been altered. So, someone is covering something up.

An easy way to cover who owns the accounts is to have their friends at Ebay cancel the original account and have a random person recreate another using the same name.

This way the original owner is hidden and protected.




As I've done in the past, I can match all the above names on the shell with the MA cops Ebay accounts..

Bill O'Connell referred to the little girl who he raped for months as 'Kookie' which is also a name his friend Trooper Charlie Kane texted to me during 2008.

For Charlie, this was a reference to his friend 'Mathias' who accompanies the troopers on illegal stings where they have sex with women and secretly film them.

This is the reason Trooper Kane texted the name 'Kookie' to me, because he's friends with O'Connell who probably calls all of his paid child rape victims 'Kookie' so he doesn't have to remember their names.

After I fought with them is when Charlie sent me the text.

Trooper Kane and O'Connell are very close, and during 2008 (and years prior) Manning was spreading rumors about me that I was a prostitute. The Kookie text from Kane was a reference to that rumor. But, the fact of the matter is that Trooper Kane knew about O'Connells many child victims he called Kookie, and that's why Kane texted me the same name.

A person named Jane Debo also tried luring me to Wm O'Connell's golf club but I declined. Jane was recruited by these troopers who told her to do so, but I have no idea what their plan was at the time.

A man driving a BMW once approached me on a Quincy beach and made sexual comments to me. He also knew things about me he shouldn't have known unless the troopers sent him. Looking back today, after seeing his photo, I believe that man was Wm. O'Connell.

O'Connell and his sons used their various construction company license numbers for their Ebay accounts as well, with all transactions between cops and the Kane Enterprise. I haven't provided these today but have provided them in the past. Below may be one of them, and when there is only one transaction on an Ebay account, it means a large amount of money has been passed.

One O'Connell Ebay account is shown below and originated around the time of the girl's death.. Since this document was typed a few years ago, that means the below account is actually over ten years old.

Malden Police Detective Gatcomb investigated her accident and claimed “no foul play”, but if this is his account, he has transactions with the biased troopers who are friends with Bill O’Connell, thus another conflict of interest, or cover up.

I was also told MSP took over the investigation of her death, but they’d never tell me because they know I will find his Ebay accounts and ties to them. MSP usually uses their names and four digit MSP ID numbers, and many times place a MA, S, or SP before their ID numbers when creating their accounts.

Trooper Charlie Kane uses Maine on his accounts as he has close family living there, so this Gatcomb account could belong to him as he is a close associate of O’Connells.

The name Gatcomb is the name of the officer who investigated the little girl's death. I find it suspect this account was created at the same time she returned to MA and at the same time was killed.

If Trooper Kane owns it, he is close to O’Connell and texted me to call me Kookie, just as they called Capuano. He’s also at the top of the rogue donor group and one who moves the big money around.

As I stated above, to cover up their connections and crimes, they’ve been duplicating Ebay accounts to hide the original owner, and they have friends working at Ebay to assist with this.

So, I’m wondering why the account below no longer shows it’s location in ME? It’s usually because it was tampered with. So, let’s say Bill O’Connell didn’t want the child’s death appropriately investigated, and he wanted to pay Gatcomb off to cover it up. Since he trusts the head of this rogue group Trooper Charlie Kane, he would pay him the large sum of money and Kane would open an Ebay account under Gatcomb’s name. The payoff would then be passed.

They would go to great lengths to cover something this big (if they did). I’ve provided the screenshot to the account I just found. The original account shows Maine and is older than it appears below.

If the ME account was connected to the troopers and the cop who investigated the little girl's death, that would be why it was changed.. The account was created *once the child victim arrived back in MA.*

I'd be willing to bet O'Connells trooper friends were illegally listening in on the [REDACTED] girls conversations while she was in California, just as they did to me for years, and heard she was coming back to Malden.

They also do this to get first hand knowledge of private meetings between attorneys and their clients if they are involved.

Listening in on her private conversations would give hints as to how he may beat the case, the specific evidence they have, and sensitive case information about him the child shared with the attorney.

After going through many of O'Connells business names, locations, folks he's connected to, employees, and all of the false real estate listings created for him by police, I know he is the one they were referring to as the "person they really work for".

I could list all of this for you but you're looking at another fifty or more pages. I've done it plenty of times in the past so you know I can obtain it easily.

Two days ago I found one of the troopers bogus Facebook accounts. The name of it was Kane-O'Connell and all of his FB friends were these police officers using their known aliases. Overnight, someone remotely hacked my pc and deleted the screenshots I took of this account, so I'm sure they also deleted the Facebook account. This is what they do to hide the truth.

I'm going to show some of the erotic women information I've found over the years which is tied to them and which I've reported to all MA investigative offices and James Comey.

Think about it though, had you investigated all I've told you since 2010, their escort ties and the Mathias incident, my friends rape, this little girl may have never been victimized and may be alive today, but Mass. LE chose to ignore me.

### **Facts and ties to escort services and sex workers.**

O'Connell- paid a fourteen year old girl for sex over a period of years. He was also convicted for cocaine trafficking and there are several sudden deaths and attempted murders involving him and his family members. Trooper Kane, Coletti, and Manning work with him. He's friends with Norfolk DA Morrissey.

Messina's- Drugged and gang raped my friend 'S' anally during 2006. She told me who did it but they were never charged. They are also wealthy developers and do business with Trooper Kane, Coletti, and Manning. Messina's are friends and donate heavily to Norfolk DA Morrissey where Trooper Kane was working. Attorney Kathleen Morrissey is also close with them. I was invited out with them that night but declined. Messina was approaching me at the gym during the same time Trooper Charlie Kane was.

Mathias- A civilian who assists the troopers on police stings where they illegally detain women, film them, and have sex with them. Trooper Manning does the filming and then distributes it while protecting Mathias' identity. Mathias is friends with Manning and Kane and he's either a lawyer or the excavator in Kingston. He is also always on

Craigslist with them advertising for women. Mathias was seen at the Kane clubs with Trooper Charlie Kane.

Mathias posted a photo six years ago which was found on one of their many 'hooker' sites. This photo consisted of several women in black dresses. As soon as I found the photo and saved it, they deleted the site and the photo. It had his name on it and is shown below. I believe these illegal stings of the private investigators, their 'Sugar Daddy' websites, their many trips to strip clubs, silent owners of some, and their advertising on Craigslist for women to strip for them, are to screen women for their own escort business and the VIP tables at Kanes nightclubs.



This photo was taken from their 'Mathiasparis' club website, a site which offers a bottle of grey goose for \$300.00.

I have submitted at least fifty of their Mathias accounts recently. Most were out of 'Germany, but the troopers use Germany.

I've submitted their many ties to strip clubs in both MA and RI. I found Kane to have all the club ties but O'Connell owns some as well.

During 2008 and years after, the troopers used to post on Craigslist seeking attractive strippers to entertain them at private parties on the South Shore.

I've submitted the rape threats they sent to me as well as rape threats directed at my fifteen year old daughter. There was no response from MSP or any MA law enforcement, including Maura Healey's Office.

They're tied to Tom McCready, a Norwood bartender who drugged my drink years ago. I left the bar before it hit me so nothing happened to me. The bar where he worked could be owned by friends of theirs, or even Bob Long, but the connections are there. They are

silent owners of many businesses. I know I was drugged because I only had two beers over a five hour period and felt fine before I left. McCready was the only one who served me the two beers, and kept asking me "how I was feeling" before I left. (He asked me at least six times) See Predator Cops document.

During 2009, Jane Debo of Braintree, a woman who the troopers recruited to target me, tried luring me to O'Connells Granite Links Golf Course in Quincy for drinks.

The cops have registered shell corporations for the wealthy under the names of the young rape victim, the nickname O'Connell called her which you can read in the article (Kookie), and Capuano. (The woman who brought the child to him) One of their shell corporations is below but they have them in all states. I told you, they're assisting the wealthy with laundering and they need shells to do so. They have over 250,000 of them. KOOKIES INC. is below.

I hold photos of a cop's wife they placed online. She was stark naked and posed in many graphic photos. The cops swap photos of their wives with one another and post them online. Think about this, if they do this to someone they 'love', what do you think they'll do to women they don't know, or women they hate such as me? I know about this because I tried getting the photos removed from online.

They had no problem recruiting two registered NH sex offenders of young girls to harass me and assist with stealing evidence from my residences, two of them being Dan Gallant and Kenneth G. Reed.

They had many escort sites which catered to their group. All transactions related to these escort sites were among cops, lawyers, and those connected to the troopers. These were not sites where cops are trying to catch 'johns' or prostitutes and were immediately removed once I located them.

One of their Ebay accounts showed a man complaining about the woman he had an encounter with, and the owner of the account told him "I put them through a two - three week thorough testing before dispatching them".

(I will show you some of the 'sale' descriptions from their escort accounts below.)

Many of their websites referred to underground club services, VIP's, and offered a variety of women. Some are mentioned below.

One of Kane's nightclub patrons told me a known escort works at his club and the VIP tables are known 'underground' services w/escorts. I also hold VIP Kane and Pimp EBay accounts which I will include but I'm sure they've discontinued them by now.

One of their sites offered underage girls which I reported to the FBI and AG at the time. This would entice someone like O'Connell and I'm sure there are others.

I found a website which sought underage Thai girls which had the Mathias and another wealthy civilian name from NH on it.

They also run or ran a site called 'Sugar Daddy'. They kept sending me the link for over a year before I looked at it. I originally looked at it after reading the weird ads alluding to men requesting to be used by gold-diggers and I also suspected Frank Messina Sr. was a member. It turns out he was, along with his sons who raped my friend, and who do business with Kane and Manning. If no MSP arrests were ever made from this site, it means they ran it to find attractive women to recruit for themselves.

I did interact with someone from this site but not for any 'daddy' reasons, I made fun of him for wanting to be used by gold diggers. This could also be how O'Connell came across some of his women, including the woman who brought a fourteen year old to him. (Phyllis Capuano).

During 2007 Trooper Charlie Kane texted me and asked me to meet him at a condo in Weymouth where he was "house sitting" for a female friend but I declined. They have

many properties and nightclubs; including O'Connells extensive properties to accommodate their women, and as you will read below, the hidden audio and visual devices are included. Kane probably thought I'd meet him and have sex so he could video it, but I've always turned down his sexual advances. (He is married or was at the time)

I've been to their after hours bars in Quincy until 6AM where a trooper was bartending. Kanes night clubs stay open past 2 AM and who is going to do anything when they're that closely connected to the police, Quincy politicians, and O'Connell? I'd check the clubs underground or basement entertaining after hours, but I've been typing this for a week so I'm certain there are clean up efforts taking place.

They were on Craigslist daily and nightly requesting all varieties of women to entertain them. I believe they were searching for women to work for them, because their demand was for all types of women. Asian, young, large women known as BBW's, etc.

One of the troopers made a comment about their erotic women being too expensive so he was going elsewhere.

MSP Trooper LeMar was arrested for going to the prostitutes at Brocktons Aria Salon. The owner of the salon said there were 23 other troopers who bought their services. This could be the cheaper place he was referring to. They have a large amount of 'Aria' accounts.

I read a review of one of Kane's clubs which I believe ended up being shut down. The review stated the person was disgusted watching the nightclubs bouncers frequently taking unknown drunk women home. These were woman who stumbled out of the club and could hardly function.

I'm going to throw out some of their online and known escort names they've used and have created websites under. I'm also going to show you some of their 'customers' comments. All of this and more was sent during 2015 to MSP, DOJ, FBI, and AG, and all accounts were active at that time. Today, many accounts have been removed or canceled, but I sent them to all of you in MA who did nothing.

Their hooker and escort club sites had the names Crystal Club, Paris Club, Hub51, and were run by the **Melman Brothers**. Some of their Ebay account names are below and were active five years ago. The melman account was definitely canceled and reissued to hide the original owner! I've thoroughly checked this!

One of these cops sites also hinted about their facility being in the “**Red Light District**” and they claimed it's their private “underground” club, which is probably a Kane or O'Connell club. Basically, their websites are disguised as upscale clubs and restaurants which offer VIP packages costing thousands of dollars.

On these sites, take a closer look at the 'restaurants' thousand dollar packages, and you will see women's physical descriptions who are labeled by class, bra sizes, and the more expensive package claims they will equip you with " all of your audio and visual needs".

Some of the tables at the Kane Clubs exceed \$5,000.00. Most of their accounts have now been deleted after I sent it to the FBI ,DOJ, AG several years ago.

According to their website, the 'business package' offers "complimentary audio and visual with wireless microphones" and I've sent all of this to LE in the past right from these websites!

This sounds similar to the Kanes Grand Nightclub and their offerings, but their erotic offerings are online only and disguised under various fictitious club and restaurant names.

I'm certain the online phone numbers one would call from these sites to reserve a table would have been tied right to those at the Kane Clubs. (I have sent all of this information in depth years ago, and since then one of the corrupt has gone into my emails to delete all of it. )

All transactions on these accounts are between cops, lawyers, wealthy, corrupt, and all men. Again, because I typed this years ago, the below accounts are older than they appear, but I'm sure have been tampered with.

Today, I pulled the account again and *they've had someone recreate the Melman account* to hide the **original owner who created the account during 1998.**

The new one is below and this is one way they are hiding their misconduct.

You want to find the owner of the original account, the one I copied and pasted from Ebay over 17 years ago.

The original account is out of CA and the newer one is out of TX.. Melman was one who claimed to run the "underground club". You can see below one of the cops recreated it, it was to hide the original owner, and there is a good reason why.

Below is from the Melman Club Package found on their website which they deleted as I can no longer find it. I did copy and paste this from their website years ago. There were nothing but sexual innuendos on the site and included with the restaurant/clubs menu,

and the comments were a lot more graphic than what I'm submitting today. It discussed these private sexual offerings in the luxury basement of the club.

One important item I forgot to include. The clubs website had a "NO CHILDREN Allowed" policy on the front page of the site, but yet they offered a "Kids Menu" !

I definitely had this and am pretty sure someone deleted it from my docs. I probably have it printed, but my important documents are in my safety deposit boxes because the troopers kept having criminals break in my home to steal my evidence.

I took the "kids menu" on this website to mean young girls. Below is what their menu actually said;

### **"Catering Menu**

1. If you're into the group thing".

### **2. "Drink Menu**

If you want an umbrella in your drink, put it on the floor and stick yours in it."

### **3. "Dinner Menu**

Whether you're in the market for a nice piece of bass or a juicy burger, we've got your fix".

Below are a couple of reviews posted by cops on the 'Melman' brothers clubs and restaurants website. Does this or the below sound like a restaurant to you?

Their Ebay will follow if I have it but the cops deleted my information via hacking me.

“The Melman boyz are obviously doing something right because it's been over a year since Hub 51 opened their doors- and they are still absolutely packed!”

(Titanium has canceled his account and I'm sure all of them have. This is why they block my letters because it buys them time to hide and delete evidence).

The below buyer wrote this feedback after buying a 'book' from the Ebay account 'hub51'

**“Thanks, everything worked very well and quickly. Great German Model. Happy again.”**

On my original email, I provided one of their accounts so you could see their “3 weeks to test the product”, or women, comments and feedback- (this is to ensure their escorts are disease free)

One of their feedback comments from the accounts '88girls' and 808girls has “\*S\*P\*A\*S\*S\* !!!!!” as a description of his purchase . This stands for SP- ASS.

The 88 girls accounts have been changed, altered, or deleted, as has the Mathiaspass account, but as you can see below it did exist because I also copied and pasted this from

Ebay a few years ago. I'm not sure what the reason is, but when they write 88 it's a reference to prostitution. I placed one Ghislaine account above, but they also have one with an 88 next to it. Ghislaine was Jeff Epstein's accomplice.

A separate erotic business found on the Melman Brothers site was a place named Mon Ami and the account is below. These are the accounts to check their bank statements and transactions. Monami had really graphic and obvious sex for money services. Like I said, they shut down these sites, comments, and photos right after I find them, but they can be found by their Ebay accounts. The accounts have emails and bank accounts tied to them and this is why I submit them.

If it were legitimate police work there would be no rush to shut them down.

They're online with the rapist Messina boys, O'Connells, Mathias', and predators such as Manning, and many other predators who need to be taken off the street. MA troopers always use Germany.

As you read Leonards words below, notice in the beginning he wrote "The" . This is not a typo and its written that way because it has meaning to the others.

I've showed you their coded way of writing when I submitted Manning laughing about vandalising my vehicle again. A comma placed in such a way usually means comm-a, for Commonwealth of MA , or State. The people taking the "cut" he writes about is most likely the nightclub or STATE running it. In their case, the Kanes.

The FBI gets the coded way of writing, ask Peter Strzok!

Their enterprise is online based and many things are written in a coded way by those who do business with them understand, or someone like me who has monitored them online for over fifteen years. They do this to try and hide what they are doing within the enterprise.

It's no different than the terrorists while conspiring online using coded writing such as "Providence" in place of writing Pakistan. (FBI Segmented on news)

You'll also notice he intentionally misspelled trafficking. He left out the FK for a reason, because it means something or they are his initials. It could also represent Kane.

(Below he writes about legalizing prostitution and how he would make it safer. Note his testing the girls for diseases. I read one of his replies to a bad Ebay feedback he received on their 'girls dispatched' and he wrote "It takes 3 weeks to take care of the testing before dispatching them". I feel he's both trying to promote and justify what they are running, and explaining why and how as LE they're running an escort business.)

**"1) escalate the clientel. Current clients are lawbreakers and sex addicts and morally challenged...only. legalizing brings in more mainstream clients that may still be "morally questionable"...but not as dangerous. Like strip clubs...you still get the creeps....but you also get the college kids and bachelor parties and old lonely guys.**

2) Allow women the ability to easily report problems. Now a woman has to admit being a prostitute to report a crime. Legalizing it means she's just a woman with a job and can report problems.

(providing you don't report their group!)

3) protects men...making sure the women are disease free...allowing men to come forward when they are robbed or assaulted.

4) it allows law enforcement to focus on areas of real crime...kidnappings, sex slavery, violence, rapes, child exploitation.

legalizing doesn't kills the roaches, but it turns the lights on and makes them scatter."

They'll lie and tell you they are running illegal stings with the private investigators to stop prostitution, yet judging by their above comments and websites, they clearly pay for them, support them, and I believe run them. But, they have the high up law enforcement who will tip them off if anyone is about to raid them because I'm sure they're getting a little on the side as well.

I can go on and on with this as I have many of their erotic women sites, but I've already sent it in to their friends at MSP, DOJ, and the AG who chose to ignore it. Now a little girl is dead and I'm sure plenty more women are being victimized by this group because no one cared enough to look into it.

Perhaps one day MA will care, when they assault and degrade a female in their family, be it a daughter, sister, mother, or young grandchild. This is a group of misogynistic men and police who prey on women and their track record proves it.

It's funny, a law abiding and honest trooper wrote the truth about arresting a judges daughter who propositioned him with sex for leniency, and the Massachusetts State Police were up in arms over that truth!
