As a follow up to our call this morning -- the attached pictures were produced as part of [REDACTED] civil case.

As to [REDACTED] photos –BSF only has electronic copies. The originals are with [REDACTED] in Texas.

As to the one photo of [REDACTED] [REDACTED] – BSF only has electronic copies – the original would be with [REDACTED] in Arkansas.

You will see that the [REDACTED] pictures have both the [REDACTED] bates number and the [REDACTED] [REDACTED] bates number. As reference in the redacted 302 (clipped below) the originals of these photos were taken into custody by the FBI so [REDACTED] does not have the originals of the photos but does have the CD that the FBI gave her.
