██████████, date of birth ██████████, was interviewed at One Saint Andrews Plaza, New York, New York. Present for the interview was ██████████ legal team, including attorneys ██████████ and ██████████. Also present for the interview was AUSA ██████████, Special Agent ██████████ and Detective ██████████. After being advised of the identity of the interviewing Agents and the nature of the interview, ██████████ provided the following information:

██████████ grew up in ██████████. ██████████ ██████████ ██████████ signed with a modelling agency. She moved to New York City to live in a models apartment. ██████████ ██████████

In June of 2004, ██████████ recalled a trip she took to New York City with her boyfriend. It was for an open call at the ██████████ agency. This is when she signed with the agency and was put into the models apartment. The apartment was on the east side of Manhattan in the 40's next to "Elite Food Bar". She recalled she and the girls would go to night clubs. It is there where ██████████ met ██████████ who is a party promoter. ██████████ talked about her friend "Jeffrey". ██████████ said that he loved to help people and he was good friends with the owner of ██████████. ██████████ was excited to meet him and told ██████████ yes. It seemed as though he had connections.

██████████ met ██████████ at the subway station and she brought ██████████ to JEFFREY EPSTEIN's upper east side home. ██████████ was brought into a massage room and was told to change into lingerie. At this point EPSTEIN was not in the room yet. He then came in wearing a bath robe. He laid down on the massage table. There was a phone next to the table which he talked on for about 15 minutes. EPSTEIN then hung up and made small talk with ██████████. It got quiet after ██████████ told him that her father was a ██████████.

EPSTEIN then flipped over and tried to touch [REDACTED]. He then tried to have intercourse with her and she said no. EPSTEIN then [REDACTED]. He asked [REDACTED] to [REDACTED]. He then [REDACTED] got up. EPSTEIN put \$300 on the massage table.

After changing, [REDACTED] left and met [REDACTED] who was waiting for her. They passed by the kitchen and [REDACTED] pointed out a tall slim girl in the kitchen who was about 19 years old and had short dark hair. [REDACTED] stated that she was EPSTEIN's main girlfriend. [REDACTED] later found a photo in an album from that time period with [REDACTED] and [REDACTED] in it.

After this incident [REDACTED] went home and did not tell anyone as she was ashamed. It turned her off to modelling and she stopped doing it. She left New York City in October and she never spoke with EPSTEIN again. She knows she left in October because her resume said [REDACTED].

[REDACTED] recalled meeting [REDACTED], the owner of [REDACTED] at a club. [REDACTED] recalled him being funny and she went back to his home with other models. At his home there was alcohol and cocaine. [REDACTED] was not sure what, if anything, happened to the other girls but [REDACTED] did nothing to [REDACTED]. She does recall him being "handsy" with the others but was not sure if he was that way with her.

[REDACTED] never talked to [REDACTED] about the sexual things that EPSTEIN would do. After leaving EPSTEIN's house, [REDACTED] had seen [REDACTED] out a few times. [REDACTED] invited [REDACTED] roommate [REDACTED] to EPSTEIN's. [REDACTED] went once, but at the time [REDACTED] wasn't sure if she got paid. No one ever called [REDACTED] back following this incident.
