[REDACTED] is ready to take direction from you [REDACTED] on next steps. He also has the memo reporting the oral admissions by the COs this morning when the paramedics arrived about not doing their rounds. As I mentioned to [REDACTED] we have lots of experience with these types of cases, and have a deep understanding of BOP processes and both criminal and administrative issues (BOP cases are 50% of our criminal docket).
