Hi [REDACTED],

Thanks for the call earlier today. I checked in with [REDACTED], and we think the best course here, instead of formally seeking an extension on Wednesday, is to submit a schedule to the Court on Friday (per the Court's current order) that says we'll submit everything for *in camera* review by May 14 (which we said we would do anyway if the DP doesn't happen), but explain where things stand more specifically in an *ex parte* submission to the Court on the same day, flagging that we may seek a new schedule soon if *Noel* resolves. I'll check in with the Times on Wednesday to get their sign off without telling them anything substantive (if they have a very adverse reaction we can go back to seeking a formal extension on Wednesday, but we think they'll stay calm), and then we can let PAE know where things stand on the DP on Friday instead of Wednesday.

Let me know if you have any concerns or would like to discuss. Otherwise, I'll check in on Wednesday to see where things stand.
