Hope you are well. Wondering if you have a few minutes this week to discuss Epstein in light of our expedited timetable of charging in the next few weeks. In particular, I was hoping to discuss (i) making sure we all review the remainder of the case file that is now up from Florida in advance of charging – my understanding is we are still waiting for approval to have it scanned; (ii) making sure to get all the physical evidence from Florida and review it; and (iii) what plans are being made for surveillance and what will ultimately be an extensive operation around arrest time of multiple approaches, etc. Given that this all may go down pretty soon, I just wanted to be on the same page from a supervisory level in terms of getting everything done. I am out of the country the first three days of next week but if you have a brief time period to chat or meet in the next two days, that would be great.
