In light of all these circumstances, I am going to be filing a motion to have [REDACTED] sentence reduced. I have discussed this with EDNY AUSA [REDACTED] and provided her with a draft of the motion. It is my great hope that she will join in it.

I am attaching here the portion of the motion that discusses her assistance to your investigation for two reasons. First, I don't want to misrepresent/misstate any aspect of her assistance or characterize your position on it in any way that you disagree with. Second, while I understand you might not feel a Rule 35 motion is merited, I am hoping you will agree to advise the Court (or allow me to) that she did try to assist you.
