██████████, date of birth (DOB) ██████████ was interviewed over video conference. After being advised of the identity of the interviewing Agent and Analyst and the nature of the interview, ██████████ provided the following information:

██████████ was the lead designer for ██████████ ██████████ started in California before it branched out to Europe, Brazil, India, Germany, and Switzerland. ██████████ is from New York and grew up in New York.

██████████' friend asked her if she had seen the news about a billionaire. ██████████ did not really watch the news. When ██████████ saw JEFFREY EPSTEIN's face she was "rocked". ██████████ could not originally place EPSTEIN but every time she saw his face something spoke to her. There was a story that came out about a school and EPSTEIN was from her neighborhood.

██████████ went to GEORGE WASHINGTON HIGH SCHOOL from around ██████████ She had a substitute teacher who was young and playful. ██████████ was 17 years old when there was a lot of flirting from the substitute. ██████████ was engaged to be married at the time. The substitute knew she was a dancer and wanted to go to parties.

██████████' friend had a pornographic magazine that was sold for around 10 cents in the streets back then. ██████████' friend opened the magazine and she saw her substitute teacher in it; he was getting blowjobs. The substitute walked in and saw them with the magazine and his face changed. The substitute pulled her aside and asked her not to say anything. He explained he was in the magazine to help him get through school. ██████████ believed the substitute was EPSTEIN; she was pretty sure it was him but could not say for sure.

██████████' friend asked if she had seen TIGER KING on NETFLIX. When ██████████ turned it on, she recognized the tiger king. ██████████' friend

remembered that [REDACTED] had pictures with him. When [REDACTED] went through her pictures that is when she came across other pictures with EPSTEIN.

[REDACTED] left New York to go to California where she married and had children. When [REDACTED] got divorced, she went to school to be a designer. [REDACTED] worked for [REDACTED]. In or around 1988/1989 [REDACTED] started the "billion dollar business" of [REDACTED]. [REDACTED] attended trade shows and met people. [REDACTED] attended a trade show in New Orleans that was full of adults and men in attendance including JIMMY SAVILE. [REDACTED] described SAVILE as a sexual deviant.

[REDACTED] went to a lot of trade shows and did a lot of international travel. [REDACTED] heard a conversation in Switzerland that children flew to the United States. The people she heard this conversation from were the same people that were having parties with SAVILE. [REDACTED] could not remember their names. [REDACTED] never saw "anything gross".

SAVILE had a partnership with [REDACTED] [REDACTED] [REDACTED] was owned by DR. ERNST GUBLER. [REDACTED] described GUBLER as a sexual deviant. [REDACTED] recalled GUBLER showing up with his wife, HELGA, who was an ex-hooker. HELGA told [REDACTED] that she was so beautiful she needed to have [REDACTED]. [REDACTED] told her boss GUBLER and HELGA made her uncomfortable.

[REDACTED]' boss' wife had cancer and GLEN DUBIN's wife EVA DUBIN was her doctor. GUBLER was involved with GLEN and EVA. GUBLER pulled out a chain that had a "gold dick" on it. GUBLER told [REDACTED] he drank the blood of children and it invigorated his sexual life.

[REDACTED] recalled hearing about a child being put on GUBLER's doorstep and he raised the child. The child became a "lunatic" and GUBLER sent her away.

[REDACTED] met the DUBIN's [REDACTED] who said she was a sex slave. In or around 1999, [REDACTED] was working at [REDACTED] in the California office when she went outside to smoke. Outside was a man whose name she did not recall with the DUBIN's [REDACTED]. [REDACTED] thought the [REDACTED] was around 16/17 years old. The [REDACTED] said she did not want to be there. [REDACTED] asked her why she did not get out then. The [REDACTED] said that they took her passport. The man laughed it off, saying that was what they do to hold onto it for her.

GLEN and BLACK knew each other. [REDACTED] was taking photographs around the office and recalled asking the receptionist, CINDY COOPER, who the asshole in the office was and she replied it was LEON BLACK. They wanted her to put her camera away.

Another person in her photos was L. DELGADO, who worked at [REDACTED].

[REDACTED] had looked at flight logs. The trade shows and flight logs matched up. [REDACTED] thought LEON BLACK was involved. [REDACTED] described this was just her putting all the stuff together.

People brought "sex slaves" to the trade shows and parties. They called themselves that. Everybody talked about sex slaves and laughed.

Due to technical difficulties, not all material was covered during this interview.
