Mark

You build a Gmail so I can gain your trust.

I sent you an email from the police. Check your two emails. Also check the spam box. See the sender's address.

Please please Create a Gmail to send to you via police email. These emails are not secure and may be monitored.

Many of these emails are not able to receive emails from the police due to low security.

I never threatened your family.

Many celebrities have either participated in your brother's business or received sexual services from him.

You were his only brother, no one will believe that you are unaware of this information and your brother's secret property, and the police report confirms your connection with JE. You are a sinner.

You only have 36 hours to buy information from us,

They will first try to imprison you. This information will help you prevent prosecutors and judges from doing so.

They may want to hurt you and your family. Give this information to a few trusted people and tell the person who ordered your brother's murder that if something bad happens to me, this information will be revealed by people I trust.

All the information about your brother's murder is on the internet. However, with the coordination of the director of prison regulations, the cameras were tampered with and some of the videos of the prison cameras were cut. At that time, prison guards ([REDACTED]) were paid \$ 6,500 so that they would not visit prisoners at this time. Within 15 minutes, a man named [REDACTED] entered your brother's prison cell and strangled him.

I have answered all your questions. You know very well that you are in great danger.

We are police and do not intend to interact with the killers. I desperately need money. Maaaaaark, if I sell this information to your brother's killers, they will definitely kill you.

Don't force me to interact with your brother's killers.
