The following text was also sent to your two emails via police email.
You want to use us as witnesses. I don't want my identity to be identified. The crime of disclosing confidential police information is even greater than murder. We tried to prove to you that we are members of the US police force. This could reassure you that you are dealing with trustworthy people. Whatever information we give you, you will say that this information is not enough. What matters to you is the confidential police documents and the confessions of the people with the police stamp.
