at the Palm Beach County Resident Agency (PBCRA). After being  
advised of the identity of the interviewing agents and the purpose  
of the interview, [REDACTED] provided the following information;  
[REDACTED] attended [REDACTED] High School during her  
freshman and sophomore years of high school and was home schooled  
during her junior and senior years. During her high school years,  
[REDACTED] resided with her family in her parents' home, located at  
[REDACTED]. [REDACTED] home  
phone number during that time period was [REDACTED]. The phone  
number, [REDACTED], belonged to her friend, [REDACTED] [REDACTED].  
[REDACTED] was a friend of [REDACTED] who was approximately one year

older than her. [REDACTED] friend [REDACTED] Last Name Unknown (LNU) introduced [REDACTED] and [REDACTED] to [REDACTED] LNU. [REDACTED] LNU was described as approximately 18-19 years old at the time [REDACTED] met him, approximately 5'11"-6' tall, tan with black hair which was longer on top and no tattoos or piercings. [REDACTED] LNU lived in Royal Palm Beach near a farm store, and [REDACTED] and [REDACTED] met [REDACTED] LNU at [REDACTED] LNU's home.

[REDACTED] LNU approached [REDACTED] and advised he knew a way she could make money by giving a massage to an older man. [REDACTED] LNU gave [REDACTED] a phone number to call to set up the massage. At some later time, [REDACTED] called the number and set up the massage appointment. [REDACTED] drove [REDACTED] to a residence located on Palm Beach. The first floor of the home was a living area and kitchen. [REDACTED] remained downstairs while [REDACTED] went to the upstairs of the residence. Approximately 3-4 girls were also present at the home when [REDACTED] and [REDACTED] were there. [REDACTED] could not provide a physical description of the girls. The upstairs was brown or black in color and furnishings, and the area was a bedroom and bathroom. A massage table was set up in the room, and towels were laid out. An unidentified older man appeared in the room, wearing a

towel. [REDACTED] could not recall the name of the man. [REDACTED] was shown a photograph of JEFFREY EPSTEIN. [REDACTED] identified EPSTEIN as the man who appeared in the room wearing a towel. EPSTEIN laid on the massage table on his stomach, and [REDACTED] began the massage. [REDACTED] and EPSTEIN engaged in conversation, and when the discussion turned to [REDACTED] age, [REDACTED] did not correct EPSTEIN when it was mentioned that she was 18 years old. After approximately twenty minutes, EPSTEIN rolled onto his back for a chest massage. [REDACTED] stated, "it got weird," when EPSTEIN began [REDACTED]. [REDACTED] backed away when EPSTEIN attempted to touch her, and she replied she had a boyfriend. At that point, the massage ended, and EPSTEIN paid [REDACTED] \$200.00, two one hundred dollar bills that he retrieved from his wallet. [REDACTED] believed EPSTEIN was mad or angry at how the massage ended. [REDACTED] reported that she did not have contact with EPSTEIN after that occasion.
