On July 12, 2021, Senior Special Agent [REDACTED] [REDACTED] and Special Agent [REDACTED] [REDACTED], U.S. Department of Justice Office of the Inspector General (OIG), conducted a voluntary interview of Lieutenant [REDACTED] [REDACTED], Federal Bureau of Prisons (BOP), Federal Correctional Institution (FCI) Danbury, Connecticut, within the FCI Danbury Training Center. The interview was conducted in reference to an official OIG investigation surrounding the death of BOP inmate Jeffrey Epstein, Register Number 76318-054, who was previously housed at the Metropolitan Correctional Center (MCC) located in New York, New York. [REDACTED] was an Activities Lieutenant at the MCC New York on August 9, 2019, the day before Epstein was found unresponsive within his cell at the MCC New York. The interview was recorded, and the recording has been transcribed. The interview transcript and documents discussed with [REDACTED] during the interview are attached to this report. The audio recorded interview has been saved separately to the case file due to its large file size.
