Interview of [REDACTED], Communications Technician, Federal Bureau of Prisons

On April 7, 2022, Assistant Special Agent in Charge (ASAC) [REDACTED], ASAC [REDACTED] and Special Agent [REDACTED], U.S. Department of Justice Office of the Inspector General (OIG), conducted a voluntary interview of [REDACTED], Communications Technician, Federal Bureau of Prisons (BOP), Metropolitan Correctional Center (MCC) New York, New York at the OIG's New York Field Office. The interview was conducted in reference to an official OIG investigation surrounding the death of BOP inmate Jeffrey Epstein, Register Number 76318-054, who was previously housed at the MCC New York.
