SUBJECT: Evidence Retrieved from FBI Regarding OIG Case 2019-010614

On November 17, 2021, SA [REDACTED] retrieved the evidence listed below from FBI SA [REDACTED] and turned it over to NYFO Evidence Custodian SA [REDACTED] to be retained in the NYFO evidence room. The evidence was transferred from the NYFO to SA [REDACTED] as part of related OIG case 2019-011073.
