- in SHU since 7/25 - cellphone found in room - was bunkie's but used it - in 7N, bunkie Dionisio De la Cruz
- LLB star cellphone - small phone
- on 7N since 4/3/19
- Dionisio bought cellphone from another inmate, when OD arrived in 7N, D. Misio already had it
- CO found cellphone - someone told CO that OD had cellphone. when they came into room + found OD w/ cellphone on him. Gave phone to CO. then took to SHU.
- in K-tier, last cell on the night, bunkie was "Easy" 2wks
- then in L-tier third cell on the night, bunkie was Pedro Garcia Peña still in that cell.
- moved before Epstein ~~was~~ died - there a couple days before hand
- knew Reyes from 7S
- after got to the SHU, heard people talking abt Epstein, could see out the window from cell door, saw cameras outside at court - didn't hear anything abt trying to kill self before he died
- usually fall asleep when 12-3, 4, 5<sup>VE</sup>, sometimes listen to radio, read books, wakeup when guards come in unit at night
- before JE died, officers would come 10, 12, 2, 4, 6 breakfast. after he died, every 15-30 min, even at night.
- sometimes before weekend counts overnight sometimes doesn't happen <sup>needed,</sup>
- don't know Reyes hat left MCC, think week before or same Friday saw Reyes at visits and Reyes said they should bunk up together b/c know each other from other unit. When Reyes told OD that he was alone, Reyes said he was in 2/2. Call Reyes "stony"?
- Night Epstein died, only saw lady CO once (chubby, black woman) around 9:30-10 pm. Didn't see her overnight.
- from OD's cell can see 3 cells across + half of security door + can see guards' desk, can watch them, at night, guards put music, smoke pipe, on computer. can hear music.
- Didn't look at guard's night Epstein died
- heard commotion overnight, before breakfast, heard inmates banging on door, didn't hear guards yell anything

- inmate noise woke OD up, saying he hurt
- CO's kept coming + going
- saw different CO's coming
- other inmates were saying "I'm going to be commuted"
- I didn't see anyone carrying body - can only see grill
- other inmates were saying they took out body
- after he died, guards treated people better, food is better, guards listened to inmates now
- come by every 15 min - 1/2 hour
- lady CO works in box, works nights + afternoon - try to not talk to lady CO's
- Silva works nights a lot, sometimes [REDACTED] works at night
- never saw/met w/ Epstein
