In attendance for the Proffer interview were AUSA [REDACTED], Special Agent [REDACTED] (FBI), Special Agent [REDACTED], Office of the Inspector General for the Department of Justice.

8/19/19

- got to SHU ~ 7/22 - went to L-tier first few days, then G tier, then H-tier
- was in first cell on the night in L-tier - alone in cell there ~ 4-5 days
- during 7/23 attempt - heard from other inmates on gate that Epstein told his bunkie to strangle him and he was going to pay him
- then went to G tier - cell first one to the right next to shower there 9-10 days
- then to H-tier, cell 107, second on night - LN = ~~Saver~~ Mojica - latin kings
- moved from L-tier b/c Lt. Perez said they need that cell b/c box is so full so moved to G-tier which is observant unit. ~~the~~ G-tier is single cells. Then they said they could give us a bunkie + moved downstairs. Lt. (black, old, bald, short, fat) and one CO moved in.
- counts - happen ~ 9:15 - 9:30, they supposed to do 30-min checks overnight and they never do it. stay up until 30/2 generally and they don't do any checks. Don't see anyone walking after 9:30 check - next time they come around is 6:30 breakfast. Have clock on radio.
- Have to ask them to turn off lights at 9:30 count. If they don't turn it off out of luck until am.
- can see guards perfectly from L-tier cell on the night
- heard from other inmates at SHU - guards don't do anything, guards don't count, leave the unit for hours at a time, don't do anything to stop K2

- coop, first cell on night

- neighbor - Jones heard female officer who got fired - heard officer say to male officer "were not doing the rounds tonight" - after 9:20 count - they didn't walk Jones repeated it to unit - echoes in there

Jones said y'all heard that - he's on the gate at all times
↳ re what officer said

! she said to male officer but d/n think meant to be overheard

- think there's afternoon count - not aware of any other counts during night - d/n seen anyone doing count between 9:30 breakfast - before JE death

- would hear key if they come in overnight - d/n remember ever hearing overnight - before JE death

- after his death - they're doing all the counts; they're actually doing their jobs.

counts - 1 officer stands at gate, the other walks unit and bangs to make sure they move. then they switch. Always two officers.

Female who got fired was lazy. when you ask for paper/envelope/one - she just ignores you. she won't do it. he doesn't even like to come to the gate to do count - her attitude - she seems annoyed.

d/n recall seeing male officer b/c d/n do rounds - he d/n to double, she did. Believe male officer did rounds w/ her. usually all males on mtg. never 2 females.

↳ try to catch people smoking/fishing - d/n do 30-min rounds during day.

██████████ usually work at night.

- [redacted] hadn't seen until Epstein died
- morning he was found - sounded like female voice yelled "oh shit / oh fuck" then heard running w/ keys, called for backup - people start yelling "he's dead. they fucked up" saying its all female officer's fault. inmates were all blaming female officer.
- kept calling out when agents were there that ♀ guard fault
- MCC compared to other jails -
 - Blades told CL that he was beat up + cut in Ben pop and guards weren't on unit - people smoking out in open
 - officers here seem to be too comfortable w/ inmates
 - seems like officers don't care + don't do jobs
- [redacted] is known for beating people up - call him dirty Lt. - bunkie has a case on them b/c [redacted] broke his foot
- few counselors + female officers - having sex w/ inmates heard from Rayshawn
- ~~the~~ "Miss Black" has sex w/ inmate in her house
- Arabic counselor - heard she was having sex w/ inmate
- after JE died they started doing everything right w/ long 30 min rounds, courts
- seen on H + L tier - when people said I'm having suicidal thoughts - guards do nothing but that changed after JE died
- everyone knew JE wanted to kill himself on SHU - people gossiping about it

- heard that VE wanted to die and offered his bunkie \$ to kill him. when he had marks on neck, bunkie denied that he did it. → heard from guys on H tier
- H/n heard that "killer cop" on SMU
- does not happen that get legal calls in SMU. Don't get stamps. threats at mee -

- on H-tier - other Bloods said (moved to V-tier but on third on left in H-tier)

- you not rat ass n * we catch you we gotta kill you, you told on a hat now in V tier

- 2 bloods guys were trying to convince bunkie to do something to CL but didn't
- people in V tier can yell to H tier
- happened a week ago

- [redacted] said its crazy smekbody has to pass away to make someone do their job

- guards have come + done cell cleanup - food is better, enough
