1 MR. [REDACTED]: The recorder is on. My  
2 name is [REDACTED], and I am a senior  
3 special agent with the U.S. Department of  
4 Justice, Office of the Inspector General. New  
5 York Field Office. And these are my  
6 credentials.

8 MR. [REDACTED]: This interview with  
9 Federal Bureau of Prisons employee, [REDACTED]?

13 MR. [REDACTED]: Is being conducted as

23 Could everyone please identify themselves for  
24 the record, and spell your last name? To start,  
25 again, I am DOJ/OIG Senior Special Agent,

1 [REDACTED]. [REDACTED].

2 MR. [REDACTED]: This is DOJ/OIG Special Agent  
3 [REDACTED]. [REDACTED]. And these are my  
4 credentials.

5 MS. [REDACTED]: Okay.

6 MR. [REDACTED]: And can you identify  
7 yourself?

8 MR. [REDACTED]: Could you -?

9 MS. [REDACTED]: My name is [REDACTED]. [REDACTED]  
10 [REDACTED].

11 MR. [REDACTED]: And what is your  
12 position?

13 MS. [REDACTED]: I am a general maintenance.

14 MR. [REDACTED]: Here at the MCC.

15 Correct?

16 MS. [REDACTED]: Yeah. MCC.

17 MR. [REDACTED]: Perfect. Thank you. And  
18 this is an official DOJ/OIG investigation into  
19 the death of inmate Jeffrey Epstein, and the  
20 surrounding circumstances, and you are being  
21 asked to voluntarily provide answers to our  
22 questions. Will you agree to a voluntary  
23 interview with the DOJ/OIG?

24 MS. [REDACTED]: Yes.

25 MR. [REDACTED]: Awesome. So, we're just

1 going to read this form. It's just in regards  
2 to voluntary interviews. Everybody that, you  
3 know, gets these. United States Department of  
4 Justice, Office of the Inspector General,  
5 Warnings and Assurances to Employee Requested  
6 to Provide Information on a Voluntary Basis.  
7 "You are being asked to provide information as  
8 part of an investigation being conducted by the  
9 Office of the Inspector General. This  
10 investigation is being conducted pursuant to  
11 the Inspector General Act of 1978, as amended.  
12 This investigation pertains to job performance  
13 failure and security failure. This is a  
14 voluntary interview. Accordingly, you do not  
15 have to answer questions. No disciplinary  
16 action will be taken against you if you choose  
17 not to answer questions. Any statements you  
18 furnish may be used as evidence in any future  
19 criminal proceedings, or agency disciplinary  
20 proceedings, or both." And the waiver section  
21 says, "I understand the Warnings and Assurances  
22 stated above and I am willing to make a  
23 statement and answer questions.

24 MS. [REDACTED]: Okay.

25 MR. [REDACTED]: No promises or threats

1 have been made to me, and no pressure or  
2 coercion of any kind has been used against me."  
3 So, you can take a second, if you want, to  
4 review it. I did just read it verbatim, but --

5 MS. [REDACTED]: That's okay.

6 MR. [REDACTED]: -- it says employee  
7 signature there, if you agree, and then,  
8 employee's name, and just print right down  
9 there.

10 MS. [REDACTED]: Okay.

11 MR. [REDACTED]: And then, we can fill out  
12 the rest of the form.

13 MS. [REDACTED]: Do you have a pen?  
14 (Indiscernible \*00:02:51) opposite.

15 MR. [REDACTED]: Thank you very much for  
16 signing. This is, again, [REDACTED] and  
17 I am signing as the signature of the Office of  
18 the Inspector General, Special Agent. Now I'm  
19 printing my name. I'm writing in the time as  
20 1:00 p.m. And it is again --

21 MR. [REDACTED]: August 5th.

22 MR. [REDACTED]: -- 8/5/2021. At MCC, New  
23 York. Special Agent [REDACTED], could you  
24 please sign as the --

25 MR. [REDACTED]: Yes.

1 MR. [REDACTED]: -- as the witness, and  
2 print your name, please.

3 MR. [REDACTED]: This is [REDACTED]. I'm  
4 signing as simply witness.

5 MR. [REDACTED]: Did you understand that  
6 form?

7 MS. [REDACTED]: Yeah.

8 MR. [REDACTED]: Do you understand  
9 everything is voluntary?

10 MS. [REDACTED]: Yeah, yeah, yeah.

11 MR. [REDACTED]: You could stop at any  
12 time?

13 MS. [REDACTED]: Yeah.

14 MR. [REDACTED]: You don't have to answer  
15 our questions. Before starting, I'd like to  
16 place you under oath. Ms. [REDACTED], can you  
17 please raise your right hand? Do you swear to  
18 tell the truth and nothing but the truth during  
19 this interview?

20 MS. [REDACTED]: Yes.

21 MR. [REDACTED]: Thank you. Please let me  
22 know if you don't understand any of my  
23 questions, and I'll rephrase or ask in a  
24 different way.

25 MS. [REDACTED]: Okay.

1 MR. [REDACTED]: What is your current home  
2 address?  
3 MS. [REDACTED]: [REDACTED].  
4 MR. [REDACTED]: And where is that?  
5 MS. [REDACTED]: In [REDACTED].  
6 MR. [REDACTED]: [REDACTED]. [REDACTED]. And  
7 what is your date of birth?  
8 MS. [REDACTED]: [REDACTED].  
9 MR. [REDACTED]: And your social security  
10 number.

13 cell phone number?

24 MS. [REDACTED]: Yeah.  
25 MR. [REDACTED]: And criminal law? And

1 where is Monroe College located?

2 MS. [REDACTED]: It's in the Bronx.

3 MR. [REDACTED]: In the Bronx?

4 MS. [REDACTED]: Mm-hmm. At Fordham.

5 MR. [REDACTED]: At Fordham?

6 MS. [REDACTED]: By Jerome, yeah.

7 MR. [REDACTED]: Okay. Cool. When did  
8 you receive that bachelor's degree?

9 MS. [REDACTED]: I started here 2008. So, '08.  
10 2008, '07, '08. '06, '07, '08.

11 MR. [REDACTED]: 2006?

12 MS. [REDACTED]: So, '07 --

13 MR. [REDACTED]: 2007, 2008?

14 MS. [REDACTED]: -- '07, '08. Yeah.

15 MR. [REDACTED]: So, you think you finished in  
16 2008?

17 MS. [REDACTED]: Matter of fact, '07 or '08.

18 Yeah. One of those two.

19 MR. [REDACTED]: Sorry. I'm going to turn  
20 that down because I don't think that's going to  
21 pick - hear what you're saying - up.

22 MS. [REDACTED]: Okay.

23 MR. [REDACTED]: Great. And --

24 MS. [REDACTED]: '07, '08. Yeah.

25 MR. [REDACTED]: -- what did you -. So,

1 2008 is when you think you finished?

2 MS. [REDACTED]: Yes.

3 MR. [REDACTED]: What did you do prior to  
4 working for the BOP?

5 MS. [REDACTED]: What do you mean? Like -?

6 MR. [REDACTED]: Did you have an  
7 employment prior to working for the BOP?

8 MS. [REDACTED]: Oh, no.

9 MR. [REDACTED]: Okay. So, this was,  
10 like, your first job?

11 MS. [REDACTED]: Oh. Well, I was working at  
12 Macy's, cosmetics and stuff, like, with makeup  
13 artists and stuff --

14 MR. [REDACTED]: Okay.

15 MS. [REDACTED]: -- and then, after that, this  
16 is my first, real job. Yeah.

17 MR. [REDACTED]: Okay. Do you have any  
18 military service?

19 MS. [REDACTED]: No.

20 MR. [REDACTED]: How long have you served  
21 with the Federal Bureau of Prisons?

22 MS. [REDACTED]: 13 years.

23 MR. [REDACTED]: How many?

24 MS. [REDACTED]: But, like, how long I've been  
25 working here? 13 years.

1 MR. [REDACTED]: 13.

2 MS. [REDACTED]: Mm-hmm.

3 MR. [REDACTED]: And do you remember your  
4 enter on duty date?

5 MS. [REDACTED]: Yes. December 7, 2008.

6 MR. [REDACTED]: Okay. And do you  
7 remember when you graduated from BOP training?  
8 Like, the year?

9 MS. [REDACTED]: I know it was in March because  
10 it was Irish, and I went to a bar. And that's  
11 all I can remember.

12 MR. [REDACTED]: Would it have been 2009?

13 MS. [REDACTED]: And that's '09, yeah, '09.

14 MR. [REDACTED]: Okay. So, about March  
15 2009.

16 MS. [REDACTED]: Yeah.

17 MR. [REDACTED]: And what is your - again  
18 - your current position with the BOP?

19 MS. [REDACTED]: I'm a general maintenance.

20 MR. [REDACTED]: And what does that  
21 entail?

22 MS. [REDACTED]: General maintenance, we work,  
23 some of us, we do floors, walls, doors,  
24 maintenance plumbing, painting, you name it.  
25 Even electrical.

1 MR. [REDACTED]: So, basically --

2 MS. [REDACTED]: A little bit of everything.

3 MR. [REDACTED]: -- almost as the  
4 description.

5 MS. [REDACTED]: Yeah. My boss is calling me.

6 MR. [REDACTED]: You know, by the title,  
7 general maintenance, any general maintenance of  
8 the MCC?

9 MS. [REDACTED]: Oh, I'm sorry. Say the  
10 question again.

11 MR. [REDACTED]: So, the maintenance of  
12 the MCC?

13 MS. [REDACTED]: Yes.

14 MR. [REDACTED]: Okay. Great. And are  
15 you familiar with Jeffrey Epstein?

16 MS. [REDACTED]: I don't recall.

17 MR. [REDACTED]: Yes. Do you know if he  
18 was housed at the MCC in July and August of  
19 2019?

20 MS. [REDACTED]: If he was here?

21 MR. [REDACTED]: Yes.

22 MS. [REDACTED]: Yes. July and August. Yes.

23 MR. [REDACTED]: Okay. And what was your  
24 position at the MCC in July and August of 2019?

25 MS. [REDACTED]: The same position.

1 (Indiscernible \*00:06:37 --

2 MR. [REDACTED]: The same position.

3 MS. [REDACTED]: -- yes.

4 MR. [REDACTED]: Okay. So, how long have  
5 you been in that position?

6 MS. [REDACTED]: I've been in this position -  
7 this is 2021 - I got promoted to that in  
8 February. I don't remember the date. It's  
9 February 12th to the 19th.

10 MR. [REDACTED]: Okay. So --

11 MS. [REDACTED]: Yes.

12 MR. [REDACTED]: -- right before then?

13 MS. [REDACTED]: Yes.

14 MR. [REDACTED]: What was your position  
15 before that?

16 MS. [REDACTED]: I was a facility assistant.

17 MR. [REDACTED]: Okay.

18 MS. [REDACTED]: Working for the facility  
19 department.

20 MR. [REDACTED]: Okay. So, this was a  
21 promotion. What is your grade level?

22 MS. [REDACTED]: Now?

23 MR. [REDACTED]: Mm-hmm.

24 MS. [REDACTED]: WS-8/5.

25 MR. [REDACTED]: Okay. So, eight, step

1 five?

2 MS. [REDACTED]: Yes. Eight. Step five.

3 MR. [REDACTED]: Okay. Did you have any  
4 interactions or involvement with Epstein during  
5 his stay at the MCC?

6 MS. [REDACTED]: No, sir.

7 MR. [REDACTED]: No. Did you even see  
8 him?

9 MS. [REDACTED]: I did see him. But, you know,  
10 not see him close by, but probably if I did a  
11 job in Nine South, but other than that, no.

12 MR. [REDACTED]: Okay. So, you didn't,  
13 like, speak with him --

14 MS. [REDACTED]: No.

15 MR. [REDACTED]: -- or say hello or  
16 anything? So, when you say you saw him, where  
17 would you have seen him at? Sorry.

18 MS. [REDACTED]: On Nine South. That's the only  
19 place --

20 MR. [REDACTED]: Oh, Nine South.

21 MS. [REDACTED]: -- yeah.

22 MR. [REDACTED]: I'm sorry. I wasn't sure  
23 what you said.

24 MS. [REDACTED]: Oh.

25 MR. [REDACTED]: So, in the SHU?

1 MS. [REDACTED]: Yes.

2 MR. [REDACTED]: Okay. Do you know if you  
3 worked at the MCC on August 9th and 10th of  
4 2019?

5 MS. [REDACTED]: If he worked?

6 MR. [REDACTED]: If you worked at the MCC.

7 MS. [REDACTED]: August 10th?

8 MR. [REDACTED]: August 9th.

9 MS. [REDACTED]: No, I did not.

10 MR. [REDACTED]: So, the Friday before he  
11 was found in a cell.

12 MS. [REDACTED]: I don't recall if I worked that  
13 Friday, but I know for sure, August 10th, that  
14 Saturday, I did not work.

15 MR. [REDACTED]: Okay.

16 MS. [REDACTED]: Those are my off days.

17 MR. [REDACTED]: But would you have  
18 typically worked on the Fridays? Monday through  
19 Friday?

20 MS. [REDACTED]: Yes, I do. My schedule is  
21 Monday through Friday.

22 MR. [REDACTED]: Okay. So, do you believe  
23 you probably worked on that Friday?

24 MS. [REDACTED]: Yeah, I probably worked.

25 MR. [REDACTED]: Okay. August 9th. Okay.

1 And during that time, do you remember what your  
2 duties and responsibilities would have been, if  
3 you were -? Were you acting for anyone, or were  
4 you doing -?

5 MS. [REDACTED]: I don't recall if I was acting  
6 for anyone that day, for Mr. [REDACTED], my boss.  
7 I don't remember if I did. If he was here  
8 then. No.

9 MR. [REDACTED]: So, I have this out of  
10 office assistance from a [REDACTED] [REDACTED].  
11 Was he your supervisor?

12 MS. [REDACTED]: Yes. He is.

13 MR. [REDACTED]: And what was your  
14 position? What was his position? I'm sorry.

15 MS. [REDACTED]: He's the facility manager.

16 MR. [REDACTED]: Facilities manager.

17 Okay. And it was from him to a [REDACTED] [REDACTED].

18 MS. [REDACTED]: Mm-hmm.

19 MR. [REDACTED]: Is he someone who also  
20 works under him?

21 MS. [REDACTED]: Yes.

22 MR. [REDACTED]: And the only reason I'm  
23 sending you this because it was an out of  
24 office automatic out of office assistant from  
25 [REDACTED] [REDACTED] to [REDACTED] [REDACTED], saying,

1 "I will be out of the office on Monday, August  
2 5th through Friday, August 9th. I will have  
3 limited phone and email access. Acting for me  
4 is Ms. [REDACTED] --

5 MS. [REDACTED]: Mm-hmm.

6 MR. [REDACTED]: -- on Monday, 8/5, and  
7 Tuesday, 8/6, and she can be reached at --".  
8 And then, it says a phone number. "And/or via  
9 radio track four. Wednesday through Friday,  
10 Mr. [REDACTED] [REDACTED] (Phonetic Sp. \*00:09:10) will  
11 be acting, and he can be reached at --". It  
12 says a phone number. "And/or track four, via  
13 radio." So, it doesn't say that you were  
14 acting for him, but do you remember, at all,  
15 acting for him on that Monday and Tuesday of  
16 8/5 and 8/6, by chance?

17 MS. [REDACTED]: No.

18 MR. [REDACTED]: No?

19 MS. [REDACTED]: I don't remember anything like  
20 that.

21 MR. [REDACTED]: And would you act  
22 regularly for Mr. [REDACTED], back then?

23 MS. [REDACTED]: Yes.

24 MR. [REDACTED]: Yes. Okay. And do you  
25 have any reason to believe you were not acting

1 for him?

2 MS. [REDACTED]: That was two years ago. I  
3 don't really --

4 MR. [REDACTED]: Oh, absolutely.

5 MS. [REDACTED]: -- remember that. I mean, you  
6 know, if I did, I would be, like, yes, I did,  
7 but I don't remember.

8 MR. [REDACTED]: Sure.

9 MS. [REDACTED]: Almost receiving the emails, or  
10 -.

11 MR. [REDACTED]: And I don't expect you  
12 to. Here, just so you know that --

13 MS. [REDACTED]: Thank you.

14 MR. [REDACTED]: -- you could look at it  
15 just to make sure. Maybe that will help jog  
16 your memory. When you're acting for Mr.  
17 [REDACTED], specifically back in August, what would  
18 that mean? What was your duties and  
19 responsibilities be for when you're acting for  
20 him?

21 MS. [REDACTED]: So, it will be, like, any case  
22 of an emergency. Especially plumbing, that we  
23 have, a lot of plumbing situation, the whole  
24 entire building. Everybody calls for [REDACTED].  
25 [REDACTED] is not here. I'm the one that responds,

1 and I have my other foremans. I will do the  
2 work. They do the work. So, we'll work  
3 together.

4 MR. [REDACTED]: Okay.

5 MS. [REDACTED]: Anything that happens. Like,  
6 an emergency.

7 MR. [REDACTED]: So, emergencies --

8 MS. [REDACTED]: You know?

9 MR. [REDACTED]: -- with regards to  
10 facilities?

11 MS. [REDACTED]: Yes.

12 MR. [REDACTED]: Okay.

13 MS. [REDACTED]: It's a facility only.

14 MR. [REDACTED]: Okay.

15 MS. [REDACTED]: Yes.

16 MR. [REDACTED]: Right. Okay. So, would  
17 the cameras - if there were problems with the  
18 cameras - would that fall under your purview,  
19 when you were acting as the facilities manager?

20 MS. [REDACTED]: Well, if I was acting, there  
21 was a problem, situation with cameras, yes.

22 MR. [REDACTED]: Okay.

23 MS. [REDACTED]: But, of course, I would  
24 definitely call my executive, then. You know,  
25 and ask them to, whatever situation, but at

1 that being, I never had a situation with  
2 cameras.

3 MR. [REDACTED]: Okay.

4 MS. [REDACTED]: Since I've been, like, if I  
5 act. I don't know. I do recall that I never  
6 had a situation --

7 MR. [REDACTED]: Okay.

8 MS. [REDACTED]: -- with cameras.

9 MR. [REDACTED]: Sounds good. And when  
10 you were acting for Mr. [REDACTED], would this  
11 [REDACTED] [REDACTED] report to you?

12 MS. [REDACTED]: Yes. He would --

13 MR. [REDACTED]: Okay.

14 MS. [REDACTED]: -- report to me.

15 MR. [REDACTED]: And what was his  
16 position?

17 MS. [REDACTED]: His position is a Comtech.  
18 It's a communication tech.

19 MR. [REDACTED]: Okay.

20 MS. [REDACTED]: So, he's - if there is any  
21 problem with the phones, radios, or cameras -  
22 he will report it.

23 MR. [REDACTED]: Okay.

24 MS. [REDACTED]: If there is anything problems.

25 MR. [REDACTED]: So, he was responsible

1 for the cameras at MCC?

2 MS. [REDACTED]: Well, he works with the  
3 cameras. And yes.

4 MR. [REDACTED]: Okay. Are you aware that  
5 the cameras were not working properly within  
6 MCC on August 9th and 10th of 2019?

7 MS. [REDACTED]: No.

8 MR. [REDACTED]: So, even at this point,  
9 you weren't aware of that?

10 MS. [REDACTED]: No. No. I don't -.

11 MR. [REDACTED]: Have you heard in the  
12 news anything about --

13 MS. [REDACTED]: No.

14 MR. [REDACTED]: -- cameras being down?

15 MS. [REDACTED]: No.

16 MR. [REDACTED]: Oh, you don't even know -  
17 -

18 MS. [REDACTED]: No.

19 MR. [REDACTED]: -- that now?

20 MS. [REDACTED]: Not in the news. No.

21 MR. [REDACTED]: Okay.

22 MS. [REDACTED]: Telemundo? No.

23 MR. [REDACTED]: Okay. But you said that  
24 [REDACTED] would have been responsible for fixing  
25 the cameras if they did go down?

1 MS. [REDACTED]: Well, he does fix the -. You  
2 know, he works with the cameras. So, I believe  
3 he will be, you know, responsible for - not  
4 responsible - he works with the cameras, so -.

5 MR. [REDACTED]: Yeah. Well, if he wasn't  
6 responsible, who would be responsible?

7 MS. [REDACTED]: That would be -.

8 MR. [REDACTED]: If they went down, who  
9 would fix them?

10 MS. [REDACTED]: It would be [REDACTED].

11 MR. [REDACTED]: Okay.

12 MS. [REDACTED]: But if there's something more  
13 than that, then our manager will make an  
14 executive decision where, if we need  
15 contracting or anything, I'm not too sure.

16 MR. [REDACTED]: And who would be the  
17 manager?

18 MS. [REDACTED]: Mr. [REDACTED].

19 MR. [REDACTED]: Okay. So, if you're  
20 acting for him, and you said that if something  
21 happened, you would report it up, who would be  
22 that manager?

23 MS. [REDACTED]: Oh, who will be my AW, at that  
24 point.

25 MR. [REDACTED]: Okay. Would that be an

1 AW that you would --

2 MS. [REDACTED]: Yes.

3 MR. [REDACTED]: -- report to?

4 MS. [REDACTED]: I would definitely. I will not  
5 make any decisions like that, big decisions, if  
6 I would have a situation like that, I'm going  
7 to contact somebody.

8 MR. [REDACTED]: Okay. So, the facilities  
9 manager reports directly to the AW?

10 MS. [REDACTED]: Mm-hmm.

11 MR. [REDACTED]: And who would that be, at  
12 that time? In August of 2019. Would it have  
13 been [REDACTED] [REDACTED]?

14 MS. [REDACTED]: It was between Scott or --

15 MR. [REDACTED]: Is it --

16 MS. [REDACTED]: -- what's the other one?

17 MR. [REDACTED]: -- it begins with a B.

18 MS. [REDACTED]: A B?

19 MR. [REDACTED]: Is it [REDACTED] [REDACTED]?

20 MR. [REDACTED]: Oh, [REDACTED]. Sorry. [REDACTED].

21 MS. [REDACTED]: No. [REDACTED] was with -. I don't  
22 think [REDACTED] was with -. [REDACTED] was with her.  
23 With us a couple of weeks ago. But before, I  
24 don't think [REDACTED] -. I think it's between  
25 Scott, and there was two. There was another

1 one.

2 MR. [REDACTED]: I think [REDACTED] [REDACTED]  
3 just started, like, that week. Maybe.

4 MS. [REDACTED]: She just started. Yeah. So,  
5 she wasn't our AW.

6 MR. [REDACTED]: So, she wouldn't have  
7 been there.

8 MS. [REDACTED]: So, the only person I got in  
9 mind is Scott.

10 MR. [REDACTED]: Okay.

11 MS. [REDACTED]: And that's it.

12 MR. [REDACTED]: Okay. Fair enough. So,  
13 if a problem was to have occurred with the  
14 camera system, you would have reported that to  
15 Ms. [REDACTED]?

16 MS. [REDACTED]: Yeah.

17 MR. [REDACTED]: Okay. But you're unaware  
18 that there were any problems with the cameras  
19 when you were, at all, in August of 2019?

20 MS. [REDACTED]: Absolutely.

21 MR. [REDACTED]: So, did electrician  
22 technician, or a coms tech, [REDACTED] [REDACTED],  
23 ever inform you that the cameras were not  
24 working properly, during that week of August  
25 9th, 2019?

1 MS. [REDACTED]: No. I did not have any  
2 conversation with anyone about no cameras. No.

3 MR. [REDACTED]: So, and you're position  
4 he never brought --

5 MS. [REDACTED]: I'm positive.

6 MR. [REDACTED]: -- that to your -.  
7 You're positive. Okay.

8 MS. [REDACTED]: And if he did, you know, not to  
9 me.

10 MR. [REDACTED]: And so, if there were a  
11 problem, who would have he informed, if Mr.  
12 [REDACTED] was out, and he didn't report it to him?

13 MS. [REDACTED]: The higher ups. The AWs.  
14 That's the next rank --

15 MR. [REDACTED]: All right.

16 MS. [REDACTED]: -- that we would go to.

17 MR. [REDACTED]: And do you think that he  
18 wouldn't have reported it to you? Would have he  
19 gone directly to something like Ms. [REDACTED]  
20 [REDACTED]?

21 MS. [REDACTED]: If he what?

22 MR. [REDACTED]: So, if there were a  
23 problem with the cameras --

24 MS. [REDACTED]: Mm-hmm.

25 MR. [REDACTED]: -- and he reported it up

1 -.

2 MS. [REDACTED]: He would report it to us.

3 MR. [REDACTED]: Would he report it to  
4 you, or he would go directly to the AW?

5 MS. [REDACTED]: He would probably - yeah - he  
6 will go to me and the AW. Like, he's a  
7 communicator. He's like that.

8 MR. [REDACTED]: So, if he's saying that  
9 there were problems with the cameras, and he  
10 did report it up, but he didn't report it to  
11 you?

12 MS. [REDACTED]: No. That day, I don't - no - I  
13 don't remember anything having -.

14 MR. [REDACTED]: Or the - yeah. I know  
15 you were the 5th and 6th, and what I'm talking  
16 about was more, like, the 8th and 9th.

17 MS. [REDACTED]: Oh, well, so, no.

18 MR. [REDACTED]: But during, earlier that  
19 week, when you were acting, I'm just wondering,  
20 that maybe he report it to you? And you're  
21 certain of that?

22 MS. [REDACTED]: I'm positive.

23 MR. [REDACTED]: Okay.

24 MS. [REDACTED]: I've never dealt with any type  
25 of problems.

1 MR. [REDACTED]: Do you know anything  
2 about Mr. [REDACTED] being sent home on August 9th,  
3 2019 --

4 MS. [REDACTED]: No.

5 MR. [REDACTED]: -- knowing that the  
6 cameras were not working properly?

7 MS. [REDACTED]: No. I don't.

8 MR. [REDACTED]: No. Do you know anything  
9 about if [REDACTED] was instructed on August 9th,  
10 2019 to --

11 MS. [REDACTED]: No.

12 MR. [REDACTED]: -- fix the cameras the  
13 following day, on August 10, 2019, when he  
14 reported to work?

15 MS. [REDACTED]: No.

16 MR. [REDACTED]: So, you don't know  
17 anything about that?

18 MS. [REDACTED]: Hmm-mm.

19 MR. [REDACTED]: What is your thoughts, if  
20 that was what was to have happened, if Mr.  
21 [REDACTED] knew - and if you were acting, at the  
22 point, and this is now theoretical - if you  
23 were the acting supervisor, and Mr. [REDACTED] knew  
24 that the cameras went down August 9th, half the  
25 cameras in the MCC, including all of the

1 cameras in the SHU, or just about all the  
2 cameras in the SHU, were not recording, what  
3 should have he done?

4 MS. [REDACTED]: Well, I know for a fact, if  
5 there was any type of deficiency or anything  
6 with the cameras, he would definitely report  
7 that. I don't know. He would speak to the  
8 manager in regards to that.

9 MR. [REDACTED]: Okay. But again, you  
10 were never aware that any cameras weren't  
11 working?

12 MS. [REDACTED]: No. No.

13 MR. [REDACTED]: I mean, should have he  
14 fixed it on the spot?

15 MS. [REDACTED]: I mean, I don't know if it was  
16 broken or not. So --

17 MR. [REDACTED]: What --

18 MS. [REDACTED]: -- if I wasn't aware of that.

19 MR. [REDACTED]: No, no, no. I'm saying,  
20 if - no, they were - so, the cameras --

21 MS. [REDACTED]: Okay.

22 MR. [REDACTED]: -- were broken. They  
23 were not recording.

24 MS. [REDACTED]: Okay.

25 MR. [REDACTED]: And [REDACTED] was

1 responsible for them.

2 MS. [REDACTED]: Right.

3 MR. [REDACTED]: So, we're trying to  
4 figure out what course of action should have he  
5 taken? He should have reported it up. Should  
6 have he fixed -? Should have he left the  
7 institution without fixing them?

8 MS. [REDACTED]: No. Of course not.

9 MR. [REDACTED]: Okay.

10 MS. [REDACTED]: But my thing is, I didn't know  
11 that there was a camera situation.

12 MR. [REDACTED]: Absolutely.

13 MS. [REDACTED]: So --

14 MR. [REDACTED]: So, that's why we're  
15 saying --

16 MS. [REDACTED]: -- if he had an issue, he  
17 knows, you know, what to do. So, I can't  
18 answer for him.

19 MR. [REDACTED]: But you can answer as an  
20 acting --

21 MS. [REDACTED]: Absolutely.

22 MR. [REDACTED]: -- manager. That's what  
23 I mean --

24 MS. [REDACTED]: Yeah.

25 MR. [REDACTED]: -- what I'm asking you --

1 MS. [REDACTED]: Absolutely.

2 MR. [REDACTED]: -- is, again, you weren't  
3 acting those days. What I'm asking you --

4 MS. [REDACTED]: No.

5 MR. [REDACTED]: -- is, as someone who has  
6 acted in that position, what should have he  
7 done? So, he's already said he knew it. He  
8 went home.

9 MS. [REDACTED]: I don't know if he said that.

10 MR. [REDACTED]: No, no, no. I'm telling  
11 you.

12 MS. [REDACTED]: Oh, okay, okay. I'm, like, I  
13 don't know.

14 MR. [REDACTED]: But he's saying that he  
15 did report it to a manager, and they said that  
16 to leave and fix it the following day.  
17 However, we haven't talked to any managers that  
18 he's told. So, that's where I'm trying to  
19 figure out --

20 MS. [REDACTED]: Oh, okay.

21 MR. [REDACTED]: -- who would have he  
22 reported that information to. Because he can't  
23 remember what manager it was.

24 MS. [REDACTED]: Like, we only got two managers.  
25 One manager and one supervisor. And that would

1 be Mr. [REDACTED] (Phonetic Sp. \*00:17:09) and Mr.  
2 [REDACTED].  
3 MR. [REDACTED]: [REDACTED]?  
4 MS. [REDACTED]: [REDACTED] wasn't here. No, no,  
5 no. I think - I don't think he was hired at  
6 that time.  
7 MR. [REDACTED]: So, and that's it, and --  
8 MS. [REDACTED]: [REDACTED] was --  
9 MR. [REDACTED]: -- and that --  
10 MS. [REDACTED]: -- (Indiscernible \*00:17:15).  
11 MR. [REDACTED]: -- to put a wrench in the  
12 works, [REDACTED] was gone. And both yourself, and  
13 at the time, [REDACTED] was acting for him that  
14 week.  
15 MS. [REDACTED]: Mm-hmm.  
16 MR. [REDACTED]: So, but he didn't speak  
17 to you?  
18 MS. [REDACTED]: No.  
19 MR. [REDACTED]: And you definitely --  
20 MS. [REDACTED]: I don't remember that.  
21 MR. [REDACTED]: -- didn't tell him --  
22 MS. [REDACTED]: No.  
23 MR. [REDACTED]: -- come back the next  
24 day.  
25 MS. [REDACTED]: No.

1 MR. [REDACTED]: Okay. And who had access  
2 to the camera system? In August of 2019,  
3 specifically August of that week.

4 MS. [REDACTED]: I don't know.

5 MR. [REDACTED]: Leading up to it.

6 MS. [REDACTED]: Not myself.

7 MR. [REDACTED]: You didn't even have -.

8 MS. [REDACTED]: I do not have no access for no  
9 camera.

10 MR. [REDACTED]: Do you know how someone  
11 would be able to take them offline?

12 MS. [REDACTED]: I have no idea.

13 MR. [REDACTED]: No? So, you're not even  
14 familiar --

15 MS. [REDACTED]: No.

16 MR. [REDACTED]: -- even if there were an  
17 issue?

18 MS. [REDACTED]: At all.

19 MR. [REDACTED]: Okay. Do you know if  
20 anyone could have intentionally taken the  
21 cameras offline?

22 MS. [REDACTED]: No.

23 MR. [REDACTED]: No. Do you know if  
24 [REDACTED] could have intentionally taken the  
25 cameras offline?

1 MS. [REDACTED]: No.

2 MR. [REDACTED]: So, you don't even know,  
3 is what you're saying?

4 MS. [REDACTED]: No.

5 MR. [REDACTED]: Do you have any reason to  
6 believe that anyone intentionally took the  
7 cameras offline, or stopped them from recording  
8 on or around August 9th, 2019?

9 MS. [REDACTED]: No.

10 MR. [REDACTED]: Do you know anything  
11 about cameras going down prior to August 10th,  
12 2019?

13 MS. [REDACTED]: No.

14 MR. [REDACTED]: Do you know if any steps  
15 were taken to correct the problem of the  
16 cameras going down?

17 MS. [REDACTED]: No.

18 MR. [REDACTED]: Do you know that we have  
19 - there's a new camera system in the MCC?

20 MS. [REDACTED]: If I do know that there's a new  
21 camera system?

22 MR. [REDACTED]: Do you know if there is a  
23 new camera system at MCC?

24 MS. [REDACTED]: I know there's new cameras at  
25 MCC, as of now, yes.

1 MR. [REDACTED]: And do you know when that  
2 occurred? And the new camera system was put in?

3 MS. [REDACTED]: Months ago.

4 MR. [REDACTED]: So, this year, though?

5 MS. [REDACTED]: I'm not too sure.

6 MR. [REDACTED]: Okay.

7 MS. [REDACTED]: If they started last year or  
8 this year.

9 MR. [REDACTED]: Sure. And are you  
10 involved at all with the documentation for when  
11 cameras --

12 MS. [REDACTED]: No.

13 MR. [REDACTED]: -- go down, or  
14 maintenance? No?

15 MS. [REDACTED]: No.

16 MR. [REDACTED]: Who would be in charge of  
17 documentation?

18 MS. [REDACTED]: It will be my manager.

19 MR. [REDACTED]: Mr. [REDACTED]?

20 MS. [REDACTED]: Yes.

21 MR. [REDACTED]: Okay. If the camera  
22 system was outdated and needed replacing, who  
23 would be the people that would be in the know?

24 MS. [REDACTED]: The comtechs.

25 MR. [REDACTED]: The comtechs. And then,

1 who?

2 MS. [REDACTED]: And then, Mr. [REDACTED].

3 MR. [REDACTED]: And then, who?

4 MS. [REDACTED]: And then, the AWs, and it goes  
5 up and up and up --

6 MR. [REDACTED]: The warden.

7 MS. [REDACTED]: -- and up and up.

8 MR. [REDACTED]: Oh, okay. And what about  
9 the captain? Is he involved with that at all?

10 MS. [REDACTED]: He should be.

11 MR. [REDACTED]: Okay. Do you know if Mr.  
12 [REDACTED] was ever asking for a new camera system,  
13 leading up to --

14 MS. [REDACTED]: No.

15 MR. [REDACTED]: -- August 10th?

16 MS. [REDACTED]: I don't know.

17 MR. [REDACTED]: You're not aware. What  
18 are Mr. [REDACTED] responsibilities as the  
19 Comtech?

20 MS. [REDACTED]: Phones. Radios. And cameras.

21 MR. [REDACTED]: Okay.

22 MS. [REDACTED]: Other than that, I'm not sure  
23 what else.

24 MR. [REDACTED]: Okay. Do you believe  
25 appropriate action was taken if [REDACTED] knew

1 that the cameras were offline, and then he went  
2 home, and the plan was to fix it the next day?

3 MS. [REDACTED]: I don't know. I don't know.

4 MR. [REDACTED]: You don't know. Okay.

5 What is your understanding of what happened to  
6 Epstein on August 9th and 10th of 2019?

7 MS. [REDACTED]: Well, I don't know, he hanged  
8 himself.

9 MR. [REDACTED]: He hung himself?

10 MS. [REDACTED]: Yeah.

11 MR. [REDACTED]: Is it your understanding  
12 that he died from hanging within the MCC?

13 MS. [REDACTED]: Because of MCC.

14 MR. [REDACTED]: Is it your understanding  
15 that Mr. Epstein died from hanging within the  
16 MCC?

17 MS. [REDACTED]: I don't know.

18 MR. [REDACTED]: You don't even know?

19 MS. [REDACTED]: I don't even know.

20 MR. [REDACTED]: So, you said that you  
21 thought he hung himself.

22 MS. [REDACTED]: That's what --

23 MR. [REDACTED]: So, can you expand on  
24 that, then? Where --

25 MS. [REDACTED]: -- that's what the media said.

1 MR. [REDACTED]: -- where did he hang  
2 himself?  
3 MS. [REDACTED]: In Nine South.  
4 MR. [REDACTED]: Okay. So, is that within  
5 the MCC?  
6 MS. [REDACTED]: Yeah.  
7 MR. [REDACTED]: Do you believe he died  
8 when he was here in the MCC?  
9 MS. [REDACTED]: Well, I wasn't here. I know  
10 the media said he died here. I mean --  
11 MR. [REDACTED]: Okay.  
12 MS. [REDACTED]: -- I don't know.  
13 MR. [REDACTED]: But you didn't hear  
14 anything about --  
15 MS. [REDACTED]: No, no, no --  
16 MR. [REDACTED]: -- being here?  
17 MS. [REDACTED]: -- no, no.  
18 MR. [REDACTED]: In the MCC? No one ever  
19 spoke about it?  
20 MS. [REDACTED]: No. Huh-uh.  
21 MR. [REDACTED]: Really? I'm just -.  
22 MS. [REDACTED]: You know, everybody, but no,  
23 I'm not -.  
24 MR. [REDACTED]: No one ever talked about,  
25 hey --

1 MS. [REDACTED]: I don't --

2 MR. [REDACTED]: -- the biggest, highest

3 profile guy --

4 MS. [REDACTED]: He is the highest profile --

5 MR. [REDACTED]: killed himself?

6 MS. [REDACTED]: -- of course, but --

7 MR. [REDACTED]: Or anything like that?

8 MS. [REDACTED]: -- no.

9 MR. [REDACTED]: No?

10 MS. [REDACTED]: No.

11 MR. [REDACTED]: All right. Do you have

12 any information, with regard to any suspicious

13 activity that occurred on August 9th or 10th of

14 2019, leading up to the discovery of Epstein in

15 his cell?

16 MS. [REDACTED]: No.

17 MR. [REDACTED]: What do you know about

18 someone else taking Epstein's life?

19 MS. [REDACTED]: No.

20 MR. [REDACTED]: You don't know anything?

21 MS. [REDACTED]: No.

22 MR. [REDACTED]: What do you know about

23 other's assisting with taking Epstein's life?

24 MS. [REDACTED]: No.

25 MR. [REDACTED]: You don't know anything?

1 MS. [REDACTED]: No.

2 MR. [REDACTED]: Okay. Did Epstein take  
3 his own life?

4 MS. [REDACTED]: I wasn't there. But I don't  
5 know. I guess.

6 MR. [REDACTED]: Okay. Did Epstein act  
7 alone in taking his own life?

8 MS. [REDACTED]: If he was alone?

9 MR. [REDACTED]: Did he act alone?

10 MS. [REDACTED]: I wasn't there.

11 MR. [REDACTED]: So, you're not sure?

12 MS. [REDACTED]: Yeah.

13 MR. [REDACTED]: And that's totally fine  
14 to just say I don't know.

15 MS. [REDACTED]: I wasn't there.

16 MR. [REDACTED]: No, no, no. I know.

17 MS. [REDACTED]: I didn't even see it. Like --

18 MR. [REDACTED]: No, that's what I'm  
19 saying, is that total acceptable answer for you  
20 to say I don't know.

21 MS. [REDACTED]: I don't know. It's, like, what  
22 the hell, to see if he did. I don't know what  
23 he did. It's just, it's all over the media,  
24 but no.

25 MR. [REDACTED]: Did you have any

1 involvement with Epstein's death?

2 MS. [REDACTED]: No.

3 MR. [REDACTED]: Do you know what would  
4 have prevented Epstein's death? That is, what  
5 actions should have been taken to prevent his  
6 death?

7 MS. [REDACTED]: I don't know.

8 MR. [REDACTED]: You don't --

9 MS. [REDACTED]: No.

10 MR. [REDACTED]: -- you don't know. Were  
11 you ever a correctional officer?

12 MS. [REDACTED]: No.

13 MR. [REDACTED]: No. Okay. And when you  
14 came with the BOP, what did you start as?

15 MS. [REDACTED]: I started as a unit team.

16 MR. [REDACTED]: And what does that mean?

17 MS. [REDACTED]: Unit team are, like, we have  
18 counselors, case managers, secretaries. That's  
19 what I used to do, is a unit secretary. Case  
20 managers. Unit managers and stuff. Dealing  
21 with the inmates. You know?

22 MR. [REDACTED]: Okay.

23 MS. [REDACTED]: And taking care of them.

24 MR. [REDACTED]: So, not, like, watching  
25 over the cells or doing cell searches, or

1 counts, or anything like that?

2 MS. [REDACTED]: No, no, no, no, no. Oh, like,  
3 what --

4 MR. [REDACTED]: Or rounds.

5 MS. [REDACTED]: -- officers does? No.

6 MR. [REDACTED]: No. Okay.

7 MR. [REDACTED]: Isn't that - sorry - isn't a  
8 unit team member also a C.O.?

9 MS. [REDACTED]: We all are correctional  
10 officers, but I know exactly what he means.  
11 What he means is, like --

12 MR. [REDACTED]: He means, like -.

13 MS. [REDACTED]: -- as an officer, like, how  
14 they do, like, all their rounds and stuff like  
15 that.

16 MR. [REDACTED]: And custody. Working --

17 MS. [REDACTED]: Custody. Yeah.

18 MR. [REDACTED]: -- have you ever -?

19 MS. [REDACTED]: No. I do not --

20 MR. [REDACTED]: So, you've never worked  
21 in --

22 MS. [REDACTED]: -- work in custody at all.

23 MR. [REDACTED]: -- custody.

24 MS. [REDACTED]: Yeah.

25 MR. [REDACTED]: Okay. And this is the

1 last question that I have for you. What are  
2 some of the systematic problems inside the MCC?  
3 And specifically, the SHU that allowed for  
4 Epstein to die.

5 MS. [REDACTED]: Don't know.

6 MR. [REDACTED]: Okay. Do you have any  
7 more?

8 MR. [REDACTED]: Yeah. You mentioned that Mr.  
9 [REDACTED] was a communicator. Doesn't it mean,  
10 like, if there were any issues or anything that  
11 came up, he would actually address it with the  
12 supervisor?

13 MS. [REDACTED]: Yeah. He will.

14 MR. [REDACTED]: Okay. Has he ever come to  
15 you with any issues?

16 MS. [REDACTED]: No.

17 MR. [REDACTED]: Now, if [REDACTED] did come to  
18 you during that week - just a hypothetical --

19 MS. [REDACTED]: Mm-hmm.

20 MR. [REDACTED]: -- if he did come to you that  
21 week, saying, hey, listen, the cameras are  
22 down, what would you have told him to do?

23 MS. [REDACTED]: I would speak to my AW, the  
24 warden, the president, and everybody, we're  
25 fixing this situation.

1 MR. [REDACTED]: And you would have told him  
2 to fix it before he went home?

3 MS. [REDACTED]: Yeah.

4 MR. [REDACTED]: You mentioned there were  
5 comtechs in August of 2019, right? Was it  
6 another person other than [REDACTED], also?

7 MS. [REDACTED]: What do you mean, there was  
8 Comtech?

9 MR. [REDACTED]: You said there were --

10 MS. [REDACTED]: [REDACTED] is a Comtech.

11 MR. [REDACTED]: -- is there another Comtech  
12 that you were referring -?

13 MS. [REDACTED]: Now, there is.

14 MR. [REDACTED]: Oh, not back then?

15 MS. [REDACTED]: I don't recall if he got hired  
16 back then.

17 MR. [REDACTED]: Okay. Who was the other  
18 person?

19 MS. [REDACTED]: Hodge.

20 MR. [REDACTED]: First name?

21 MS. [REDACTED]: John Hodge.

22 MR. [REDACTED]: Okay. That's all I got.

23 MR. [REDACTED]: And oh, because we showed  
24 you this, do you mind just initialing and  
25 dating it?

1 MS. [REDACTED]: Oh.

2 MR. [REDACTED]: It's not certifying the  
3 accuracy. It's just to say that --

4 MS. [REDACTED]: Right here?

5 MR. [REDACTED]: -- that's what we --?

6 Yeah. That would be great. That's just --

7 MS. [REDACTED]: Initial?

8 MR. [REDACTED]: -- the email. Yes,  
9 please.

10 MR. [REDACTED]: And today's date. 8/5/21.

11 MS. [REDACTED]: Today is --

12 MR. [REDACTED]: 8/5/21.

13 MS. [REDACTED]: Five.

14 MR. [REDACTED]: Okay. If you could just  
15 bear with me. We were just provided this  
16 documentation. So, we just wanted you to -  
17 before we say done, I want to see what this  
18 says. What is a CSM?

19 MS. [REDACTED]: CSM? Correctional System  
20 Management.

21 MR. [REDACTED]: Okay. And I'm going to  
22 just read this to you. So, this is from when  
23 the camera system, I guess, has a problem, back  
24 --

25 MS. [REDACTED]: Mm-hmm.

1 MR. [REDACTED]: -- in the day, they would  
2 contact the contractor, and then, they would  
3 report what was relayed.

4 MS. [REDACTED]: Mm-hmm.

5 MR. [REDACTED]: So, maybe you might be  
6 able to help fill in the blanks here. It says,  
7 "[REDACTED] [REDACTED] called us on Thursday, August  
8 8th, stating that he had two bad drives on his  
9 raid, until" - or, sorry, "unit, of the NICE  
10 Vision Pro Unit NVR. We advised him to get  
11 replacement drives. Once they are replaced,  
12 they should start to initialize, to become  
13 available for the raid array. [REDACTED] did not  
14 have drives readily available. He checked with  
15 his local CSM to see if they had any spare  
16 replacement drives." So, do you know what the  
17 local CSM would mean?

18 MS. [REDACTED]: No.

19 MR. [REDACTED]: Do you think that may be  
20 -?

21 MS. [REDACTED]: CSM? No. That's probably  
22 something on their behalf. I don't -.

23 MR. [REDACTED]: Okay. "Once he located  
24 replacement drives on Friday, August 9th, he  
25 did not have access to the DVR room to replace

1 them. He called SIGNET (Phonetic Sp.  
2 \*00:26:14) for phone support, on Saturday,  
3 August 10th, when he gained access to the DVR  
4 room. He attempted to replace the drives, and  
5 they started to rebuild. During the rebuild  
6 process of the drives, the drives were required  
7 to be taken out of the raid on DVR-2. Once the  
8 drives are removed without proper shutdown of  
9 the recorder, the video database becomes  
10 corrupted. Typically, any time the raid on a  
11 raid-five configuration was just two drives.  
12 The raid needs to be rebuilt and all data is  
13 wiped from the raid." Do you know anything  
14 about that?

15 MS. [REDACTED]: No.

16 MR. [REDACTED]: No? All right. And just  
17 because I read that, you mind just initialing  
18 and dating that?

19 MS. [REDACTED]: Sure.

20 MR. [REDACTED]: This a service request  
21 number 24975.

22 MS. [REDACTED]: Sign here?

23 MR. [REDACTED]: Actually, you can just  
24 sign the top of this.

25 MS. [REDACTED]: Okay.

1 MR. [REDACTED]: What did you think CSM meant?  
2 MS. [REDACTED]: CM --  
3 MR. [REDACTED]: CM -.  
4 MS. [REDACTED]: -- well, we have a CSM here,  
5 which is Correctional System Management, but  
6 that's a -.  
7 MR. [REDACTED]: What do they do?  
8 MR. [REDACTED]: Because it said he  
9 checked with his local CSM.
