Additional Info: I had recently experienced sexual trauma myself, having been raped multiple times in the year prior, put into compromising situations by law enforcement, intelligence agencies, and others after reporting myself to the FBI after being coerced into molesting a child by an older man, and made aware that I was a victim of child pornography, as well as being targeted by a criminal syndicate. The extent of my participation in such acts is difficult to recall due to brain damage pertaining to the trauma, though it's possible I engaged in sexual acts with a minor at Epstein's home as part of the initiation process to be invited to future sex parties. I had blocked out many of these events until recently, which I was reminded of by entities that hacked my computer in June 2021, when I saw footage of me having sex with minors, though it is possible it was fabricated.

I am willing to meet in person, particularly if you deem it will be helpful. Please feel free to text if I don't answer your call.

How is Contact Known: I went to at least one or two of his sex parties, and socialized on a few other occasions. He used to frequent the stand up comedy open mics in Orlando and South Florida. He also used to promote events put on by his friends, that if memory serves he was an "angel investor" in, and at the time I was an aspiring comedian. I witnessed acts of sexual trauma involving minors in his home, which I believe was in Fort Lauderdale, and participated in sex acts with Ghislaine and Epstein while minors were present, though it's unclear at this time what was communicated about the extent of the presence of minors (many children younger than expected), and was perhaps overwhelmed unexpectedly.

Description: On January 31, 2023 at approximately 3:26 PM FBI Special Agent (SA) [REDACTED] telephonically interviewed [REDACTED] ([REDACTED]), date of birth [REDACTED], Social Security account number [REDACTED], telephone number [REDACTED], home address [REDACTED], [REDACTED], [REDACTED], [REDACTED]. After being advised of the identity of the interviewing Agent and the nature of the interview, [REDACTED] provided the following information:

[REDACTED] had been woken up by the telephone call and verified identity information asked by SA [REDACTED]. [REDACTED] prefaced his interview by informing SA [REDACTED] he had been admitted into a psychiatric hospital in June, 2021 and diagnosed with schizophrenia. [REDACTED] was receiving threats on his computer by a group of unknown people. [REDACTED] stated his memory was flawed and sociopaths use memory against people to take advantage of them.

[Agent Note: [REDACTED] requested SA [REDACTED] call him back in thirty minutes so he could drink some coffee and wake up]

SA [REDACTED] called [REDACTED] at approximately 4:03 PM to continue the previous interview.

[REDACTED] provided employment information about his father who is currently living in Colombia and listed the below hospitals he has been admitted to for SA [REDACTED] to verify:

- University Health Center in Tamarac, Florida
- Aspire Health Partners in Orlando, Florida
- Grady Memorial Hospital in Atlanta, [REDACTED]
- Central Florida Behavioral Hospital in Orlando, Florida
- PeaceHealth Sacred Heart Medical Center in Eugene, Oregon

[REDACTED] has been diagnosed with bipolar disorder, post-traumatic stress disorder, schizophrenia, and [REDACTED] believes that his obsessive-compulsive disorder may all be results of trauma he has experienced.

[REDACTED] father practiced law while he was living in Florida, but now is an accountant in Colombia. [REDACTED] was informed by the intelligence community that the cartels took notice of how well [REDACTED] father kept records and this may have lead to the capture of Pablo Escobar.

Jeffrey Epstein took notice of his family because of these events and met [REDACTED] aunt in Florida in the 1960s.

[REDACTED] was not certain of the timing regarding the next event, but saw surveillance footage from inside a hotel room he was staying at when he was approximately 6 years old of intruders breaking in and raping him. [REDACTED] was uncertain if law enforcement was called initially, but was certain they were contacted at least two times.

While [REDACTED] was working in Los Angeles for Atlantic Records he met [REDACTED] who is an American writer, producer, and actor. Harmon was a Central Intelligence Agency (CIA) asset and invited [REDACTED] over to what he believed to be [REDACTED] home. While [REDACTED] was at [REDACTED] house he sexually abused a blonde female child approximately 1 to 3 years old that was placed in the home at the direction of the CIA. [REDACTED] contacted the FBI in approximately Fall, 2008 when he was approximately 19 years old to turn himself in.
