[REDACTED] provided the following information:

[REDACTED] stated he was calling from West Plains, MO. [REDACTED] informed that Jefferey Epstein was in his life. [REDACTED] went to sex parties starting at the age of [REDACTED]

years old. [REDACTED] stated it was people who had money did this to him. [REDACTED] informed Jefferey and someone name George Epstein took him all over the world. [REDACTED] knows George's name was a fake name.

[REDACTED] is reporting in 2008 a girl came to his door, telling him if he was looking for a friend, she will be his friend. The smoked together and talked for a bit. She left telling him she would come back. A few days later the girl showed back up at his apartment with a dog. [REDACTED] let the girl in his apartment with the dog. The girl had [REDACTED] to lock the door. [REDACTED] heard moaning from the girl, and he found the dog humping the girl. [REDACTED] went to open the door there was a whole bunch of people there, they dragged him out of his apartment. [REDACTED] has had people following him, gangs and the Mafia watching him. [REDACTED] stated he would hear someone yelling for help from a van. By the time he would get to the van the van would leave. [REDACTED] informed they would tell him they would kill and rape him if he goes to the police. [REDACTED] informed they were already raping him. [REDACTED] stated most of them didn't want him to see their face, but they were on him 24/7. [REDACTED] has a lot of traumas, and he mentioned the name of Melissa Gillborn. [REDACTED] has a dog paw imprinted on his dog.
