292 is a program that tracks

inmates' meals, recreation, medical, showers

medical come in am + pm for Shu review

292 populates this system (BOPware)

Shu inmates automatically has a 292

but if heged to another population

there's no longer a 292

audits 292 for documentation from previous
day (mostly)

Sometimes glitches in system the
institutional controls evg co fight
accountability of inmates

never caught anyone not doing their job

reviews round forms
what are red flags
misses specs
no signatures

shu LT when Epstein came

Epstein wasn't in shu at first
10s lower (inmates not on 10s but
high profile)

cell 201

first interaction - "am i gonna get
out of here?"

bring [REDACTED] to attorney conference

at one point towards the beginning
they wanted to have with a brochure
at meetings w/ warden, assoc
wardens, etc.

doesn't remember exactly who

but remembers they were trying to
acting kind someone

chose [REDACTED] in a tier

wasn't asked for input

July 23rd incident didn't happen during shift
but found out next day

S83 packed LT [REDACTED])
pictures, memos

interacted with Epstein while on watch
"I don't want to be here"
I'm not gonna hurt myself
fed him, gave him food

psychology said must be housed w/
banker when came back to the

gave input on a few months
left institution that night and
they were still deciding

called and asked if he set a
Banker

[REDACTED] chosen

asked questions about phone calls
wanted to talk to daughter

doesn't do phone calls, doesn't track who
they can't talk to

- shown email from [REDACTED]
(old day watch)

- told [REDACTED] Epstein needed a
banker

- just stuffed

- "[REDACTED] I got it"

- next am had a bunkie

When an inmate comes off suicide
watch they have a bunkie - common
practice

part of training
clearly communicated in suicide watch training
posted

on desk signs 30 min road checks
friend's reminders

8/8 he had a bunkie anything
other than that he doesn't know

[REDACTED] was bunkie when left and
was down in attorney conference when left

didn't talk to anyone else other than

[REDACTED] officers know that when
coming off suicide watch you get a bunkie
no emails, no tally, to others
people just know

Officer Thomas + Noel knows inmates on
suicide watch get bunkie

if epstein seen alone he expects
and officer to report to shift supervisor

if person left WAB he still expects
paper to notify him if he didn't
recognize

but... short staffed

Thomas didn't get training
