Trump Moves To Defund New York City, Other Cities.

The New York Post <<https://nypost.com/2020/09/02/trump-orders-review-to-defund-nyc-other-anarchist-cities/>> (9/2, Nelson, 4.57M) reports President Trump is beginning “the process of defunding New York City and three other cities where officials allowed ‘lawless’ protests and cut police budgets amid rising violent crime.” A five-page memo Trump signed on Wednesday orders “all federal agencies to send reports to the White House Office of Management and Budget that detail funds that can be redirected.” The Post adds, “New York City, Washington, DC, Seattle and Portland are initial targets as Trump makes ‘law and order’ a centerpiece of his reelection campaign after months of unrest and violence.” Trump says in the memo, “My Administration will not allow Federal tax dollars to fund cities that allow themselves to deteriorate into lawless zones.” The Post says the memo “twice mentions New York Mayor Bill de Blasio by name.”

The Washington Times <<https://www.washingtontimes.com/news/2020/sep/2/trump-orders-anarchist-jurisdictions-funding-slash/>> (9/2, Dinan, Boyer, 492K) says Trump directed Attorney General Barr “to come up with a list of communities that have forbidden police to step in to stop violence, have declared no-go zones for officers, or pursued ‘Defund Police’ policies. Mr. Barr is also to look at communities that have rebuffed Mr. Trump’s offers of federal law enforcement.” The Washington Post <<https://www.washingtonpost.com/us-policy/2020/09/02/trump-memo-funding-cities/>> (9/2, Stein, 14.2M) says the memo “comes as the president seeks to intensify his attacks on Democratic mayors of cities that have faced civil unrest amid protests against police brutality.”

In a tweet <<https://twitter.com/realDonaldTrump/status/1301315810485579776>> Wednesday evening, Trump wrote, “My Administration will do everything in its power to prevent weak mayors and lawless cities from taking Federal dollars while they let anarchists harm people, burn buildings, and ruin lives and businesses. We’re putting them on notice today. @RussVought45”

The New York Times <<https://www.nytimes.com/2020/09/02/us/politics/trump-funding-cities.html>> (9/2, Haberman, McKinley, 18.61M) reports that the move “is almost certain to face legal challenges, and Democrats and city officials reacted furiously.” Politico <<https://www.politico.com/news/2020/09/02/trump-federal-money-police-408116>> (9/2, Choi, 4.29M) says Senate Minority Leader Schumer “quickly denounced the Wednesday memo as a ‘foolish stunt,’ urging the president to focus on the coronavirus pandemic instead of threatening federal funding for some of the country’s largest cities.”

Cuomo: Trump Would Need An Army To Walk NYC Streets. Politico New York <<https://www.politico.com/states/new-york/city-hall/story/2020/09/02/cuomo-trump-would-need-an-army-with-him-if-he-walked-new-york-citys-streets-1315077>> (9/2, Mahoney) reports that in response to Trump’s threat “to withdraw federal funds from ‘anarchist’ municipalities” like New York City, Gov. Andrew Cuomo (D) launched his “harshest attack yet on his fellow Queens native, saying he is ‘persona non grata’ in the city of his birth.” Cuomo said, “He can’t have enough bodyguards to walk through New York City. ... Forget bodyguards, he better have an army if he thinks he’s going to walk down the streets in New York. ... He is persona non grata in New York City, and I think he knows that, and he’ll never come back to New York, because New Yorkers will never forget how gratuitously mean he has been.” A spokesperson for Cuomo “later clarified that Cuomo did not mean that the president would literally need such additional protection, but was simply illustrating how unwelcome he would be in the city.”

Shootings In NYC More Than Doubled In August. The New York Times

<<https://www.nytimes.com/2020/09/02/nyregion/nyc-shootings-murders.html>> (9/2, Zaveri, 18.61M) reports that New York City “recorded 242 shootings in August, up from 91 last year, continuing a summer spike in gun violence that has become an issue in the presidential race.” The “steep rise in gun violence...continued at an alarming rate in August, as shootings more than doubled over the same period last year and murders rose by nearly 50 percent, the police said.” The Times says Trump “has seized” on the increase as he has “tried to shift the public’s attention away from his response to the pandemic to what he depicts is out-of-control crime in New York City and other urban areas. He has tried to blame the rise in violence on local Democratic leaders.”

Barr: DOJ Received Reports Of People Flying To DC To Exploit Protests.

The New York Times <<https://www.nytimes.com/2020/09/02/us/politics/barr-trump-protest-violence.html>> (9/2, Benner, 18.61M) reports that in an interview with CNN <<https://playvideo.bulletinintelligence.com/08e44ee661cd447a8bcc05382fb75568?pubid=fbi>> Wednesday, Attorney General Barr “sidestepped questions...about President Trump’s incendiary conspiracy theory about a plane ‘loaded with thugs’ headed to Washington over the weekend.” Barr said that he did not know “what the president was specifically referring to,” but that the F.B.I. was investigating reports that outsiders had traveled to the city to cause trouble. Barr “said the Justice Department had received reports that people from the West Coast and other parts of the country had flown to Washington to exploit protests for racial justice as opportunities to attack law enforcement and damage property.” Barr said, “We received numerous reports of individuals coming from Portland, Washington – Seattle – and several other cities to come into Washington for the specific purpose of causing a riot. ... I think there were many on planes.”

But the dizzying pace in which he has given oxygen to outlandish tales that are typically the domain of Internet trolls or fringe groups like QAnon suggests the practice has now become a central part of his reelection strategy.”

WTimes Review Finds Rioters Are Often Local. The Washington Times <<https://www.washingtontimes.com/news/2020/sep/2/outside-agitators-rioters-are-often-homegrown-prob/>> (9/2, Dinan, 492K) reports that while officials in the District of Columbia, Portland, and Kenosha Wisconsin blamed the violence in their cities on people coming in from other areas, “a Washington Times review of data” shows that claim is “not particularly accurate.” Portland police arrests “from Aug. 21 to Aug. 31 showed nearly two-thirds of those charged were listed as from Portland, and that ratio grows even higher when close-in suburbs like Beaverton and Vancouver, Washington, are counted.”

Investigators Release Images Of Those Sought In Kenosha Arson Cases.

The Kenosha News <https://www.kenoshanews.com/news/local/watch-now-atf-releases-images-of-persons-of-interest-in-kenosha-arson-fires/article_0118e680-7b12-5e92-906b-34aabac05144.html#tracking-source=home-top-story> (9/2, Smith, 63K) reports investigators have released “photos and video of several people sought in arson fires” in Kenosha last week. A statement from the Milwaukee field office of the Bureau of Alcohol, Tobacco, Firearms and Explosives “stated that investigators are ‘seeking to speak to at least seven persons of interest’ in the fires set to businesses and vehicles in the unrest that followed the shooting of Jacob Blake” on August 23.

Kenosha County Ends Curfew. The Kenosha News <https://www.kenoshanews.com/news/local/kenosha-county-ends-curfew-effective-immediately/article_f2f06a8a-87da-5a6b-8b62-f9bb75681ea3.html#tracking-source=home-top-story-1> (9/2, 63K) reports Kenosha County, Wisconsin “has ended its State of Emergency Curfew. That decision was announced today after local officials consulted with law enforcement and community leaders.” USA Today <<https://www.usatoday.com/story/news/nation/2020/09/02/lawsuit-kenosha-authorities-selectively-enforced-curfew/5696175002/>> (9/2, Vielmetti, 10.31M) reports four people arrested in Kenosha during demonstrations “have sued the city and Kenosha County, claiming discriminatory curfew enforcement that violates the First Amendment.”

Reuters/Ipsos Poll: Public Supports BLM Protests, Doesn't See Crime As Top Issue.

Reuters <<https://www.reuters.com/article/us-usa-election-poll/no-bounce-in-support-for-trump-as-americans-see-pandemic-not-crime-as-top-issue-reuters-ipsos-poll-idUSKBN25T1I3>> (9/2, Kahn) reports that President Trump’s “attempt to make civil unrest a central theme of his re-election campaign has yet to boost his political standing, as most Americans do not see crime as a major problem confronting the nation and a majority remain sympathetic to anti-racism protests, according to a Reuters/Ipsos poll released on Wednesday.” The poll “showed the majority – 78% – remain ‘very’ or ‘somewhat’ concerned about the coronavirus,” and “nearly 60% said Trump is at least partly responsible for the protracted school and business closures due to the virus. ... By contrast, most Americans do not see crime as a major priority and do not think it is increasing in their communities, the poll showed.” Moreover, “53% of American adults said they remain sympathetic to people out protesting against racial inequality, nearly unchanged from 52% in a similar poll that ran in late July.”

Meadows: Rioters Are Committing Acts Of Terror.

Appearing on Fox News’ Fox & Friends <https://video.foxnews.com/v/6186920671001?playlist_id=930909787001#sp=show-clips> (9/2, 831K), Chief of Staff Meadows was asked, “Do you agree with the President’s characterization of rioters as ‘domestic terrorists?’” Meadows said, “Without a doubt. You know, what a terrorist does is try to instill fear. ... You don’t have to go any further than perhaps even the roads outside the White House here where we have a number of these rioters trying to instill fear just in everyday Americans’ lives. So whether you see it here or as the President was talking about in Kenosha, Wisconsin, this is a President that has been very clear. ... It’s amazing when you stand up for safer communities and support law and order – and, more importantly, our law enforcement officers – how people of all parties come together.”

Barr: Idea Of “Epidemic” Of Police Violence Against Blacks Is A “False Narrative.”

Axios <<https://www.axios.com/barr-police-brutality-black-people-7ad13aac-3e0f-412a-a791-ea818a266690.html>> (9/2, Axios, 521K) reports that in an interview with CNN <<https://playvideo.bulletinintelligence.com/16b11caf9bf440c296ef973ad6dc5732?pubid=fbi>> Wednesday, Attorney General Barr “denied...that there are ‘two justice systems’ for Black and white people in the U.S.” Barr argued that the idea that there is an “epidemic” of police shooting unarmed Black men is “simply a false narrative.” Barr said, “I did say that I do think that there appears to be a phenomenon in the country where African Americans feel that they’re treated, when they’re stopped by police, frequently, as suspects before they are treated as citizens. I don’t think that that necessarily reflects some deep-seated racism in police departments or in most police officers. I think the same kind of behavior is done by African American police officers.”

Administration Officials Criticize Portland Mayor’s Handling Of Violence.

Acting Deputy DHS Secretary Ken Cuccinelli said on Fox Business' Varney & Co.

https://video.foxbusiness.com/v/6186948514001/?playlist_id=933116618001#sp=show-clips (9/2, 64K), "The first responsibility in these communities is state and local for policing, but we're seeing Portland intentionally not, and willfully, not police to the extent needed to stop the violence. You compare it to Kenosha. We saw the formula for a quick stop to violence and that was with a Democrat mayor and a Democrat governor. Partisanship shouldn't have anything to do with this. This is straight law enforcement."

Acting CBP Commissioner Morgan said on Fox News' Bill Hemmer Reports that Portland Mayor Ted Wheeler's "solution is to sit back and burn itself out. Literally that's what has happened. The city will burn itself to the ground. That's his strategy. It's outrageous and absurd and putting politics above public safety."

Acting DHS Secretary Wolf said on Fox News' Daily Briefing https://video.foxnews.com/v/6187045752001?playlist_id=5588812415001#sp=show-clips (9/2) that "we see some District Attorneys taking a very strange approach and posture" to charging protesters. He said, "For instance, the District Attorney in Portland has advertised a series of crimes that he's not going to prosecute, and that involves interfering with a law enforcement officer, I would say, criminal trespassing, and others. And that sets a very dangerous precedent, it fosters this environment that the violence is okay, and it draws people to those communities."

Barr: At Some Point, Federal Government Has To Step In. Attorney General Barr said on CNN <https://playvideo.bulletinintelligence.com/1a8508c89ad9442e9a97c42501310680?pubid=fbi> (9/2, 2.25M) that "what we're trying to do is make clear that it's the state's responsibility and the locality to provide protection. If they are unable or unwilling to do that, at some point, things could reach a state where the federal government has to step in." He said, "It's very easy to maintain peace in these cities, in any city where the mayor backs the police, the police chief is doing his job, and the governor's willing to provide backup support, there will be peace on the streets and there has been peace on the streets."

Portland Mayor Moving After Rioters Target His Condo Complex. The Washington Free Beacon <https://freebeacon.com/democrats/portland-mayor-to-move-after-rioters-target-his-condo-building/> (9/2, Nester, 78K) reports Portland Mayor Ted Wheeler (D) said Tuesday that he intends to move "after anti-police rioters repeatedly targeted" his condominium complex. The announcement comes after "a massive demonstration outside of the 114-unit high-rise on Monday, where more than 200 rioters gathered around the building, vandalized it with spray paint, and threw burning objects inside." In an email to his neighbors, Wheeler wrote, "I want to express my sincere apologies for the damage to our home and the fear that you are experiencing due to my position. ... It's unfair to all of you who have no role in politics or in my administration." Breitbart <https://www.breitbart.com/politics/2020/09/02/portland-mayor-ted-wheeler-looking-to-move-after-protesters-target-his-condo-building/> (9/2, Bleau, 673K) provides similar coverage of Wheeler's announcement.

President Trump reacted to Wheeler's announcement in a tweet

<https://twitter.com/realDonaldTrump/status/1301253108404613121> Wednesday afternoon. Trump wrote, "Mayor Wheeler just got harassed out of his own home in Portland by so-called 'friendly protesters'. The Anarchists, Agitators and Looters treat him HORRIBLY, even though he is so nice and respectful to them. Criminals only understand strength!"

Federal Prosecutors Charge Portland Man For Ramming Federal Officers With SUV. The Washington Times <https://www.washingtontimes.com/news/2020/sep/2/feds-charge-man-attacking-federal-police-suv-portl/> (9/2, Dinan, 492K) reports federal prosecutors have announced charges against Lonnie Vantewa Albert, "a Portland man they say targeted federal police officers for an attack, smashing his SUV into their vehicle then trying to run them down." The officers "were on their way back to their hotel early Sunday when they say an SUV began hounding them in their rental car. When one of the officers got out to check for injuries, the man drove at the officer, then swerved away and fled, prosecutors said." When the officers "followed the SUV into a hospital parking lot, it rammed into their rental car again." Albert "was charged with assault."

US Marshals Deputize Oregon State Troopers. Case files state Tornow allegedly used the city Police TrackIT system to send a message, claiming he’d planted a bomb at one of the nearby police precincts. He used the alias TORNOW and claimed to have set a device that was ‘undetected’ to canine units. He also claimed if he was caught that, ‘others will take my place and immediately detonate the bomb.’”

Biden Says Portland Victim Was “Inciting Responses.”

They’re using the police training manual as justification.” In the Minneapolis Police Department training manual, “officers are shown how to subdue violent or resisting suspects by placing their knee on the neck.” Pavlich adds, “Newly released court documents show Floyd had a ‘fatal level’ of fentanyl in his system when he died. He also resisted arrest before being placed on the ground by officers.”

Police Body Cam Footage Of Man’s Death Sparks Protests In Rochester.

Florida Man Suspected Of Missouri Homicide Is Captured In Operation LeGend.

The department of justice touted the presence of Kansas City’s Operation LeGend in the success of his arrest.” US Marshals arrested Yuri Harris, 24, Monday “at Longview Lake in the southeastern part of the Kansas City metro area on a warrant from Leon County, Florida, U.S. Marshal Mark S. James announced Tuesday in a news release. ‘Mr. Harris definitely chose the wrong place to come to with the additional resources in town for Operation LeGend,’ James said. ‘We were able to put a lot of manpower towards his capture.’” Harris “was charged in the Aug. 27 killing in which the victim was fatally shot during a home invasion robbery.”

US Charges Indiana Man With Straw-Purchasing Guns For Chicago Felon.

On July 30, Aug. 5 and Aug. 20, Haywood allegedly bought guns from stores in Hammond, Indiana, and signed forms indicating he was the actual buyer, prosecutors said. He was actually purchasing them for someone from Chicago whom he knew was prohibited from owning firearms because of a felony conviction, according to the U.S. attorney’s office.” The charges “were filed as part of Operation Legend.”

Morgan: Operation Legend Exemplifies How Trump Is “Committed To Public Safety.”

Kuzu, who is a U.S. citizen, was captured by Syrian forces in early 2019, turned over to the FBI and returned to Texas to face charges.”

They then stayed in several ‘waiting houses’ before ending up in Mosul, Iraq. There, he and 40 others allegedly underwent five days of physical and weapons training led by ISIS instructors.” Kuzu “was one of 1,500 suspected ISIS fighters that were captured in March 2019 by Syrian Democratic Forces. He was handed over to the FBI and was charged with conspiring to provide material support material to ISIS.”

Appeals Court Finds NSA Phone Data Collection Program Illegal.

Politico <<https://www.politico.com/news/2020/09/02/court-rules-nsa-phone-snooping-illegal-407727>> (9/2, Gerstein, 4.29M) reports the NSA program that “swept up details on billions of Americans’ phone calls was illegal and possibly unconstitutional, a federal appeals court ruled Wednesday.” However, the “unanimous three-judge panel” also “said the role the so-called telephone metadata program played in a criminal terror-fundraising case against four Somali immigrants was so minor that it did not undermine their convictions.” Judge Marsha Berzon’s opinion, “which contains a half-dozen references to the role of former NSA contractor and whistleblower Edward Snowden in disclosing the NSA metadata program,” concludes that the “bulk collection” of such data violated the Foreign Intelligence Surveillance Act. Politico says the release of the opinion “is another reminder of the exceedingly slow pace of some 9th Circuit appeals, particularly those involving classified information or FISA surveillance.”

The Washington Post <https://www.washingtonpost.com/national-security/phone-records-surveillance-edward-snowden/2020/09/02/97f26498-ed67-11ea-99a1-71343d03bc29_story.html> (9/2, Barrett, 14.2M) reports the court also ruled “that claims made by FBI and other national security officials in defense of the program were not accurate.” The ruling “will not have much immediate effect on the program it criticizes, because that record-gathering effort ended in 2015, replaced by a different method for searching phone records that was also eventually shut down.” The judges also “ruled that government prosecutors must tell criminal defendants when it plans to use evidence gathered or derived from surveillance done overseas.” The court also “rejected the Justice Department’s argument that the call records were properly obtained because they were relevant to a terrorism investigation.” That argument, they wrote, “depends on an after-the-fact determination of relevance: once the government had collected a massive amount of call records, it was able to find one that was relevant to a counterterrorism investigation.” The judges wrote the FISA act “required the government to make a showing of relevance to a particular authorized investigation before collecting the records.”

The Christian Science Monitor <<https://www.csmonitor.com/World/Middle-East/2020/0902/US-offers-a-way-off-terrorism-list.-Is-price-right-for-Sudanese>> (9/2, Luck, 246K) reports Secretary of State Mike Pompeo recently “offered to lift the U.S. terrorism label off post-revolution Sudan” in exchange for \$330 million in compensation for “Al Qaeda attacks from over two decades ago.” Sudan’s transitional government “reportedly favors the US offer,” but among Sudanese citizens “mired in recession and lingering poverty, a legacy of ousted dictator Omar al-Bashir’s destructive 30-year rule, the proposal is encountering resistance.” The US has “already lifted sanctions from Sudan in 2017,” but the terrorism designation “has continued to deter investment in the country.” The civilian-led transitional government “believes that by honoring the previous regime’s debts and paying compensation for his crimes – and ridding the country of the terrorism list designation and stigma – the subsequent access to international financial relief and foreign investment will save Sudan’s economy.” The hope is the benefits “will outweigh any immediate costs several-fold.”

Trial Of Alleged Accomplices In 2015 Attacks Opens In Paris.

The Chief of Staff to Acting Secretary of Homeland Security Chad Wolf put the brakes on, writing, ‘Please hold on sending this one out until you have a chance to speak to AS1.’ AS1 is Acting Secretary Wolf. That was nearly two months ago, and the bulletin still has not gone out.” Reuters <<https://www.reuters.com/article/us-usa-election-biden-russia/u-s-agency-defends-decision-to-withhold-report-on-russian-claims-about-bidens-health-idUSKBN25T33C>> (9/2, Hosenball, Hesson) reports that the draft bulletin “also said that Iranian and Chinese media had published materials questioning the mental health” of President Trump.

Arrested Texas A&M Professor Linked To Chinese Firm.

IAEA: North Korea Enriching Uranium, But Has Not Reprocessed Plutonium In Past Year.

Reuters <<https://www.reuters.com/article/us-northkorea-nuclear-iaea/no-sign-north-korea-reprocessed-plutonium-in-past-year-still-enriching-uranium-iaea-says-idUSKBN25T1JW>> (9/2, Murphy) reports there is no sign North Korea “reprocessed spent fuel from its main nuclear reactor into plutonium in the past year, but it seems to have continued to enrich uranium, the other potential fuel for atom bombs, the U.N. atomic watchdog said.” The International Atomic Energy Agency (IAEA) has not had access “to North Korea since the secretive communist state expelled its inspectors in 2009,” and since has been “monitoring North Korea’s activities from afar, including with satellite imagery.” It is “almost certain” the experimental 5-megawatt reactor “at the Yongbyon nuclear complex, which is widely believed to have produced plutonium for weapons, has been shut down since early December 2018, the IAEA said in an annual report here dated Sept. 1 and posted online.” There has, however, “been no telltale steam at the plutonium reprocessing lab there, suggesting the last batch of spent fuel stayed in the reactor building.”

Colombia Arrests Three Venezuelans “Tied To Anti-Maduro Plot.”

The AP <<https://www.expressnews.com/news/article/Colombia-arrests-3-Venezuelans-tied-to-15538882.php>> (9/2, Goodman) reports police in Colombia have arrested “three Venezuelans who were part of a failed plot organized by a former U.S. Green Beret to sneak across the border and oust President Nicolás Maduro, The Associated Press has learned.” All three lived “for months in rustic camps along Colombia’s Caribbean coast where Jordan Goudreau, an American war veteran, was helping organize a volunteer army for a rapid cross-border strike against Maduro.” It was not clear “if US officials played any role in Wednesday’s arrests,” but for months “the FBI has been interviewing associates of Goudreau as part of their own investigation into whether he violated U.S. laws that require any U.S. company supplying weapons or military equipment, as well as military training and advice, to foreign persons to seek State Department approval.”

She condemned the acts as ‘despicable’ and said they would not be tolerated.” According to the Local, “In the week before former Riverhead school superintendent Dr. Aurelia Henriquez abruptly resigned from her position June 30, she received three handwritten notes containing ethnic and racial slurs and hate speech, according to documents obtained from the Suffolk County Police Department through a Freedom of Information Law request.”

Four Arrested In New York Drug Bust.

DayShawn Brown, who is wanted on several violent felony warrants from Atlantic County in New Jersey, was charged as a Fugitive of Justice.” The Daily Voice adds, “City of Newburgh Police were assisted in their investigation by the New York State Police, the Hudson Valley Safe Streets Task Force and members of the FBI.”

Two South Carolina Men Sentenced On Drug, Money Laundering Charges.

that this case stemmed from a joint investigation by the Federal Bureau of Investigation (FBI) and the Rock Hill Police Department into individuals who were obtaining large amounts of cocaine, methamphetamine and marijuana from a distributor in Southern California.”

Montana Woman Sentenced For Running Meth Ring.

Ady admitted in an interview to being a meth distributor and said that she and another person had just returned from Las Vegas and Phoenix where they picked up four bundles of meth, each containing about 1.5 pounds, from a source.” The Sun Times adds, “This case is part of Project Safe Neighborhoods, a U.S. Department of Justice initiative to reduce violent crime. According to the FBI’s Uniform Crime Reports, violent crime in Montana increased by 36% from 2013 to 2018.”

The agent, whose name has not been released, was treated at the scene by ATF medics and taken to a hospital. ATF said he is recovering.” According to the Post-Gazette, “Authorities had not previously named the alleged shooter, but said the incident happened at the address of Williams, 44, of 1 Marion Street, who was among 12 people indicted under seal on June 16. The case was unsealed two days later as agents swept in to make arrests. Williams is charged with assault on a federal employee and violations of federal gun laws.”

discussing a plot to blow up the Mall of America.” The case was investigated “by the FBI and prosecuted by Assistant US Attorney John Docherty.”

term of imprisonment of 20 years, and one count of possession of a firearm in furtherance of a drug trafficking crime, which carries a mandatory consecutive sentence of at least five years.” The Valle “case was investigated by the DEA Bridgeport High Intensity Drug Trafficking Area Task Force, the FBI Bridgeport Safe Streets Task Force and the East Haven Police Department.”

Utah Man Pleads Guilty To PPP Fraud.

Sentencing Of Former Atlantic City, New Jersey Mayor Delayed For Sixth Time.

His sentencing date has been postponed six times since then, and no official explanation has been given as to why. His most recent sentencing date was Sept. 9.” Gilliam “pleaded guilty to defrauding a youth basketball program out of

more than \$87,000. He resigned as mayor the same day, his position filled by former City Council President Marty Small Sr.”

Another Charged In College Admissions Probe.

The AP <<https://www.latimes.com/california/story/2020-09-02/more-charges-college-admissions-scandal>> (9/2) reports, “Another wealthy parent was charged Wednesday with trying to bribe his child’s way into an elite university as a fake athletic recruit, a day after two former college coaches caught up in the nationwide admissions bribery scandal were hit with additional charges.” Amin Khoury, 54, of Palm Beach, Florida and Mashpee, Massachusetts, “in May 2014 paid \$200,000 to get former Georgetown University tennis coach Gordon Ernst to designate his daughter as a tennis recruit even though her ‘tennis skills were below that of a typical Georgetown tennis recruit,’ the U.S. attorney’s office in Boston said in a statement.” Khoury “is the 57th person charged in the nationwide investigation. He’s charged with mail fraud and bribery.”

Oregon Couple Who Scammed Elderly Victims Sentenced To Federal Prison.

Mosman “sentenced Ronnie Stevens, 51, to five years and 11 months, and Tina Ephrem, 44, to five years in prison after they had pleaded guilty to conspiracy to commit wire fraud.”

US Charges Two In \$12M Scheme Targeting Investors In Puerto Rico.

investments in promissory notes would provide loans for companies including hotels and resorts in the Dominican Republic and elsewhere. Muldrow and the Securities and Exchange Commission said more than \$1.2 million of that money was used to finance Wykle's personal expenses, including shopping, travel, rent, food and entertainment."

Trial Of Chicago Alderman Burke Could Be Delayed To 2020 Amid Pandemic.

Burke "was indicted in May 2019 on 14 counts including racketeering, bribery and extortion conspiracy alleging a variety of schemes where he used his powerful public office to pressure others into giving business to his private law firm. A trial for Burke and his two co-defendants – 14th Ward operative Peter J. Andrews and real estate developer Charles Cui – had tentatively been scheduled for mid-2021," but "during a status hearing Wednesday, U.S. District Judge Robert Dow as well as attorneys for both sides agreed that setting a firm date for such a large-scale trial seemed pointless with so many ongoing issues yet to resolve. 'I'd like to give you all a trial date, but I'd like to give you one we think will stick,' Dow said."

Louisiana Man Sentenced For Running Ponzi Scheme.

Donnie Laing, Jr., 40, was sentenced by US District Judge Terry A. Doughty "on a charge of wire fraud. Laing received 36 months in prison, followed by three years of supervised release. He was also ordered to pay \$918,531 in restitution to the victims of this scheme." Laing "pled guilty in March 2020 to wire fraud in connection with a million-dollar Ponzi scheme that he orchestrated through his limited liability company, Capital Energy Investments, LLC." Investors "were led to believe that Capital would use their money to invest in oil and gas equipment, and then lease such equipment to companies engaged in oil and gas exploration activities for a profit, promising investors high rates of return on their investments. Instead, Laing used the victims' investments for his own personal use."

Three Missouri Men Charged With Scamming Women Out Of \$500K In Cash, Electronics.

KSDK-TV adds, "A federal grand jury indicted 41-year-old Ovuoke Frank Ofikoro, 27-year-old Bonmene Sibe, and 27-year-old Trenice Hassel Wednesday, according to a press release from U.S. Attorney Jeff Jensen's office. Ofikoro and Sibe face several charges, which include conspiracy to defraud, mail fraud, and aggravated identity theft, the release said. Sibe and Hassel face charges of making false statements to a federal agency." According to KSDK-TV, "Between May 2019 and July 2020, Ofikoro, Sibe, and other individuals ran a scam in which they pretended to be high-ranking military officials who were deployed overseas, according to court documents. They preyed on women between 45 and 82 years old."

KTVT-TV adds, "According to plea papers, Linares admitted to running a Ponzi-type scheme, luring investors into handing over 'principal' that he later deposited in bank accounts at Wells Fargo, Bank of America and Legacy Texas, then paying them 'interest' from other investors' principal payments."

Florida Grand Jury Indicts Businessman Over College Admissions Investigation.

Robinhood Markets Faces Civil Fraud Investigation.

Experts Say Schools Are Particularly Vulnerable To Cyber Attacks.

NBC (Sanders) added that these types of hacks are "a growing problem. Since August 4, EdTech Strategies has tracked 56 new cyber security incidents at schools across the country. In the last four years, more than 950 cyber attacks." According to experts, "schools are especially vulnerable because in this ramp up to virtual learning, little money was earmarked for security." NBC added that "the FBI's cyber crimes unit has launched an investigation," in to the Miami-Dade attack. They are "looking for digital fingerprints that could lead to a suspect."

Miami-Dade County Public Schools Superintendent Alberto Carvalho "said in a tweet on Wednesday morning that multiple attempts to disrupt online education have been made Wednesday morning, following two previous days of cyberattacks. Carvalho said they haven't managed to penetrate the district's servers. He said the district's security and safeguard measures have been successful so far and that the 200,000 students who've logged onto the system have been asked to remain logged on." The FBI and Secret Service "have been called in to probe the cyberattacks. They subpoenaed the school district's internet provider."

Debbie Mucarsel-Powell on Wednesday "requested an immediate briefing on the cyberattacks. 'We must secure the ability of our students to receive their education, and it is imperative that I remain continuously informed on developments on the manner,' Mucarsel-Powell wrote in a letter to FBI Director Christopher Wray."

FBI Has Revamped Hacking Response, Speed.

Wired <<https://www.wired.com/story/fbi-hacking-victim-notifications/>> (9/2, Greenberg, 3.49M) reports the FBI and the “community of incident response security professionals who often work with the bureau’s agents says the FBI has significantly changed how it communicates with hacking victims” since 2016. In interviews with WIRED, FBI officials “described a bureau that has revamped its practices to warn hacking targets faster, and at a higher level of the targeted organization.” The improvements go “beyond warnings to state officials, says Mike Herrington, the section chief of the FBI’s cyber division.” Herrington said, “I see a key change in practice and emphasis, getting our special agents in charge keyed up to gain the full cooperation of potential victims.” In some cases, “says special agent Tyson Fowler, the FBI has developed a so-called ‘emergency lead notification’ process that bypasses the bureau’s usual internal consultations and immediately notifies a cybersecurity-focused agent in a field office who can warn a victim, hopefully before the hackers deliver their ransomware payload.”

Colorado Man Sentenced For Moderating Dark Web Marketplace.

The AP <<https://www.chron.com/news/article/Colorado-man-sentenced-for-moderating-dark-web-15538356.php>> (9/2) reports from Aurora, Colorado, “A Colorado man was sentenced to federal prison for serving as a moderator on a global dark web marketplace that peddled guns, drugs and stolen identities.” Bryan Herrell, 26, of Aurora “was sentenced to 11 years by a U.S. District Court Judge in California Tuesday for his role in operating AlphaBay.” The Justice Department “said the now-shuttered online bazaar operated on the Tor network and became the most expansive internet market for drug sales. AlphaBay launched one year after the FBI shut down the similar Silk Road network. Herrell used the online monikers Penissmith and Botah to referee arguments between sellers and buyers and watch for scams, federal officials said.”

Potential TikTok Bidders Consider Four Acquisition Options.

Reuters <<https://www.reuters.com/article/us-usa-tiktok-bytedance-exclusive/exclusive-aspiring-tiktok-buyers-pursue-four-options-in-effort-to-revive-talks-idUSKBN25T2IG>> (9/2, Wang, Roumeliotis, Hu) reports TikTok’s prospective buyers are discussing “four ways to structure an acquisition from its Chinese owner ByteDance, which include buying the app’s US operations without key software, after Beijing stalled a deal which could be worth \$30 billion, sources said.” Other options being considered, three sources say, “include asking for Chinese approval to pass TikTok’s algorithm on to the acquirer of the short video app’s U.S. assets, licensing the algorithm from ByteDance,” or negotiating a “transition period of up to a year with the Committee on Foreign Investment in the United States (CFIUS), which is overseeing the deal talks, the sources said. It is not clear whether China’s new rules would allow this in the time frame required.” The fourth scenario involves “ByteDance’s licensing the algorithm to the buyer of the TikTok assets, the sources said. However, this could worry CFIUS, which wants ByteDance to forego any relationship it has with TikTok in the United States.”

European Officials Targeted By Chinese Phishing Attacks.

intelligence about global economies reeling from the pandemic, according to cybersecurity experts.” In March, hackers from a “group known as APT TA413 sent phishing emails mimicking the World Health Organization’s Covid-19 guidance in an attempt to lure victims into clicking on an attachment containing malicious code, the cybersecurity firm Proofpoint Inc. said in a report Wednesday.” It said the malicious email was sent to “numerous entities involved with economic policy and forecasting within Europe.” The same strain of malware “was discovered in a phishing campaign in July targeting Tibetan dissidents, which the TA413 hacker group is best known for targeting, Proofpoint said.” The campaign’s focus on “economic, diplomatic and legislative entities in Europe suggests a momentary realignment for the Chinese hackers ‘to collect information on global economies cast into upheaval as a result of Covid-19,’ according to the report.”

CISA Orders Increased Cybersecurity Vulnerability Reporting.

The Hill <<https://thehill.com/policy/cybersecurity/514891-dhs-cyber-agency-issues-order-boosting-cybersecurity-vulnerability>> (9/2, Miller, 2.98M) reports DHS’s Cybersecurity and Infrastructure Security Agency (CISA) on Wednesday “issued a final directive requiring all federal agencies to develop and publish cyber vulnerability disclosure policies.” The directive, which is the “finalized version of a draft order published by CISA in November, is intended to make it easier for the public to disclose cybersecurity vulnerabilities to federal agencies and what types of communication to expect after reporting the issue.” In a statement, CISA Assistant Director for Cybersecurity Bryan Ware said, “Cybersecurity is strongest when the public is given the ability to contribute, and a key component to receiving cybersecurity help from the public is to establish a formal policy that describes how to find and report vulnerabilities legally.”

Cybersecurity Talent Initiative Places “First Class Of New Feds.”

The program is also “intended to promote diversity in federal ranks and cybersecurity as a whole.” The cohort is 60 percent African-American and 30 percent female. The first cohort partnered with the CIA, “Departments of Defense, Energy, Health and Human Services, and Homeland Security, Environmental Protection Agency, Federal Bureau of Investigation, Federal Election Commission, National Oceanic and Atmospheric Administration and the Office of Naval Intelligence to place applicants in the first cohort, as well as Mastercard, Microsoft and Workday as private sector partners.”

ODNI Waivers For Huawei, ZTE Rule Expected To Be Rare.

National Defense Magazine <<https://www.nationaldefensemagazine.org/articles/2020/9/2/regulators-issue-huawei-zte-interim-rule>> (9/2, Burnette, Cassidy, Clark, 163K) reports the Federal Acquisition Regulatory Council recently “released an interim rule governing Section 889(a)(1)(B) of the 2019 National Defense Authorization Act.” The rule bans federal agencies from contracting with users of “all telecomm equipment or services produced and provided by Huawei or ZTE, and video surveillance and telecommunications equipment or services produced and provided by Hytera, Hikvision, or Dahua, or any subsidiaries or affiliates.” This prohibition applies “to all U.S. government prime contractors, whether domestic or international, including those selling commercially available off-the-shelf items.” The outlet says that where a contractor “sells the same products or services to multiple agencies, the contractor must initiate the waiver request with the contracting

officers in each agency responsible for the potential contract.” Although Section 889 allows “an entity to receive a national security waiver from the Office of the Director of National Intelligence, we expect those waivers to be rare.”

Jewish Federation Of Greater Washington Reports Endowment Cyberattack.

The Washington Post <https://www.washingtonpost.com/local/jewish-federation-of-greater-washington-reports-75-million-hack/2020/09/02/d8944f7c-ed3d-11ea-b4bc-3a2098fc73d4_story.html> (9/2, Davies, 14.2M) reports the Jewish Federation of Greater Washington reported a “hack that drained \$7.5 million from its endowment fund and funneled the money into international accounts.” CEO Gil Preuss announced the hack “to employees in a virtual call Wednesday morning, saying the initial attack targeted an employee using a personal computer while working from home.” The FBI is assisting “in an ongoing investigation of the incident, according to Joy Jiras, a spokeswoman for the agency’s field division in Baltimore.” The attack targeted an agency “fund within the federation’s endowment, said Preuss, who declined to identify the agency, at its request.” As of Wednesday, the federation’s “internal investigation had found that other agency funds and donor information remained unscathed.”

However, she said there was too little male DNA present to identify the donor. Davis was among several FBI forensics specialists who testified during the sixth day of the homicide trial of Hap Seiders, 66.” Chief Deputy District Attorney Courtney Hair LaRue “claims Hap Seiders killed his 53-year-old wife and burned her body in the fireplace of their Silver Spring Township home. He was charged with homicide last year.”

Anyone prohibited under federal law from possessing a firearm who is found with one will be prosecuted in federal court pursuant to that effort, Mr. Herdman said, and anyone who commits a violent crime or drug-trafficking offense while possessing a firearm will also be charged federally.”

OPD was the only Nebraska agency that participated in 2019, according to the FBI. That's changed since Jan. 1, when the Nebraska Crime Commission began collecting data that it passes along to the FBI. Since then, 109 agencies have participated in the Crime Commission program."

Mexican Officials Say Missing Los Angeles Firefighter Likely Victim Of Kidnapping.

'We are working with technical personnel to establish his last instance when his freedom was taken,' Hiram Sanchez, the head prosecutor, said. 'We have found a lot of evidence that leads us to believe this was an act of violence, nevertheless we have not determined for sure this is what happened to him.'"

President Trump’s visit to Wilmington, NC, garnered largely favorable local coverage but received scant attention from national outlets. his reelection campaign and has sparked concerns in the scientific community in particular that the White House could pressure regulators to cut corners.”

Fauci, Birx Dismiss Claims Administration Pursuing “Herd Immunity.”

Politico <<https://www.politico.com/news/2020/09/02/anthony-fauci-rejects-herd-immunity-407747>> (9/2, Forgey, 4.29M) reports that on Wednesday, NIAID Director Fauci “argued...that the United States should not pursue herd immunity in its fight against the coronavirus – even as a top White House adviser has reportedly advocated the strategy and President Donald Trump himself invoked it this week.” According to Politico, “The remarks from Fauci, who had been sidelined from most public appearances for two weeks following vocal cord surgery, come amid Trump’s elevation of a new health adviser,” Scott Atlas, who is described by Politico as “a physician with no expertise in infectious diseases or epidemiology.”

Fauci was asked on MSNBC’s Andrea Mitchell Reports <<https://playvideo.bulletinintelligence.com/652e2eff79040c2b867f51ee9a2cd03?pubid=fbi>> (9/2, 1.2M) about the Administration’s policy toward herd immunity as a strategy to combat coronavirus. Fauci said, “That’s not a fundamental strategy that we’re using. The fundamental strategy that we clearly articulate and go by through the task force is to try to prevent as many infections as you possibly can prevent.”

We’ll get to herd immunity through a vaccine and that’s the right way to do it.” Reuters says Birx was “responding to news reports that [Atlas] had advocated for the Trump administration to lift all social and business restrictions aimed at stopping infections from spreading.”

The New York Times <<https://www.nytimes.com/2020/09/02/us/politics/trump-scott-atlas-coronavirus.html>> (9/2, Weiland, Stolberg, Shear, Tankersley, 18.61M) profiles Atlas, who the Times says “has argued that the science of mask wearing is uncertain, that children cannot pass on the coronavirus and that the role of the government is not to stamp out the virus but to protect its most vulnerable citizens as Covid-19 takes its course.” According to the Times, “Ideas like these, both ideologically freighted and scientifically disputed, have propelled the radiologist and senior fellow at Stanford University’s conservative Hoover Institution into President Trump’s White House, where he is pushing to reshape the administration’s response to the pandemic.” The Times reports that the President “has embraced” Atlas, as has Chief of Staff Meadows, “even as he upsets the balance of power within the White House coronavirus task force with ideas that top government doctors and scientists like” Fauci and Birx “find misguided – even dangerous – according to people familiar with the task force’s deliberations.”

Azar, Slaoui: Operation Warp Speed Is “Working” And Will Likely Succeed.

HHS Secretary Azar and Moncef Slaoui, chief scientific advisor to Operation Warp Speed, write in USA Today <<https://www.usatoday.com/story/opinion/2020/09/02/covid-19-developing-vaccine-operation-warp-speed-alex-azar-column/5681364002/>> (9/2, 10.31M), that “so far” the Operation Warp Speed (OWS) “strategy is working,” and “it is...increasingly” likely to succeed. The strategy is to select “a diverse portfolio of vaccine candidates,” conduct clinical trials, and manufacture “the vaccine candidates while still conducting the clinical trials.” Two of the vaccines, they add, “are already being manufactured at scale,” while the other candidates “will soon begin manufacturing” and “three OWS-supported candidates are in Phase 3 trials in the United States, and more are expected...by the end of September.” Azar and Slaoui conclude, “We are immensely encouraged by the progress so far.”

WPost Analysis Details Criticisms Of Navarro's Role In Pandemic Response.

In a 2,900-word article titled "Tactics Of Fiery White House Trade Adviser Draw New Scrutiny As Some Of His Pandemic Moves Unravel," the Washington Post <<https://www.washingtonpost.com/us-policy/2020/09/02/navarro-pandemic-coronavirus/>> (9/2, Lynch, Leonnig, Stein, Dawsey, 14.2M) reports that "amid the Trump administration's troubled response to the coronavirus pandemic," Director of Trade and Manufacturing Policy Navarro has "refashioned himself as a powerful government purchasing chief, operating far beyond his original role." However, according to the Post, Navarro's "harsh manner and disregard for protocol have alienated numerous colleagues, corporate executives and prominent Republicans." The Post also reports that "in a previously undisclosed incident, the White House Counsel's Office in 2018 investigated Navarro's behavior in response to repeated complaints and found he routinely had been verbally abusive toward others." Nevertheless, the Post says Navarro "remains unbowed, scorning critics inside and outside the White House as disloyal and leaning heavily on his one true ally: Donald Trump."

Another FDA Appointee Ousted Amid Fallout Over Convalescent Plasma Announcement.

The AP <<https://apnews.com/fe123eaff5652cb5c4cbb5f50558ec77>> (9/2, Perrone, Foley) reports, "A second Trump administration appointee has been ousted at the Food and Drug Administration in the wake of the agency's botched announcement about an experimental therapy for COVID-19, which medical experts said damaged the health regulator's credibility with the public." An FDA spokesperson on Wednesday confirmed "that John 'Wolf' Wagner, a political appointee installed by the White House earlier this summer, is no longer heading the agency's office of external affairs." The FDA's announcement that it had granted emergency authorization to convalescent plasma "triggered a backlash last week" after FDA Commissioner Hahn "was forced to correct misstatements that inflated the potential benefits of the therapy." Medical experts and "former FDA officials say Hahn tarnished the agency's reputation at the moment it's needed most: as agency scientists prepare to decide whether upcoming coronavirus vaccines are effective and safe to be given to millions of Americans."

NIAID Director Fauci was asked on MSNBC's Andrea Mitchell Reports <<https://playvideo.bulletinintelligence.com/652e2eff79040c2b867f51ee9a2cd03?pubid=fbi>> (9/2, 1.2M) about whether the Emergency Use Authorization on convalescent plasma to treat coronavirus was rushed. Fauci said, "There was a lot of concern in the press that there was conflict between the guidelines that came out from the NIH and the EUA, and as a matter of fact, if you read the EUA word for word carefully and read the guidelines, they say the same thing, that there really isn't enough evidence for or against to recommend it, that it is not considered the standard of care, and that you should be using clinical trials to ultimately get the definitive answer."

Lamas: Insufficient Clinical Data For Efficacy Or Safety Of Convalescent Plasma. In an op-ed for the New York Times <<https://www.nytimes.com/2020/09/02/opinion/coronavirus-convalescent-plasma.html>> (9/2, 18.61M), Daniela J. Lamas, a critical care doctor, questions the Food and Drug Administration's "emergency use authorization for convalescent plasma despite inadequate evidence." Lamas writes that possible treatments must undergo clinical trials; "they are the gold standard to test a treatment's efficacy but have been scarce in the pandemic." Lamas also criticizes the FDA's announcement because it makes clinical trials unfeasible, pointing out that "if convalescent plasma is widely available and hailed as a major breakthrough, who is going to sign up for a trial where a roll of the dice might leave the patient with a placebo?"

Federal Funding Helps New Virus Tests Come To Market.

The New York Times <<https://www.nytimes.com/2020/09/02/us/politics/covid-testing.html>> (9/2, Lafraniere, Wu, 18.61M) reports, “With the pandemic still raging as fall approaches, the government’s efforts to support development and deployment of a variety of testing methods are a rare if belated bright spot amid widespread failures to contain the virus.” The National Institutes of Health “said on Wednesday that it was providing nine more companies with \$123.3 million from a \$2.5 billion pot of money allocated last spring by the stimulus bill to support testing.” However, “even as the government helps rush new tests to market, the administration continues to issue conflicting – and sometimes flatly contradictory – messages about how many and what types of tests are needed, when they should be administered and to whom.”

More Police Officers Have Died From COVID This Year Than All Other Causes Combined.

But the San Francisco Democrat said that if anyone owes an apology, it’s the salon.” Said Pelosi, “I think that this salon owes me an apology, for setting me up.” Newsweek <<https://www.newsweek.com/pelosi-says-salon-owes-her-apology-setting-me-after-footage-leaks-her-indoor-appointment-1529293>> (9/2, Roos, 1.53M) recounts that “when a reporter asked Pelosi if she believed she owed the service industry an apology, Pelosi responded, ‘I don’t.’”

Two major network newscasts covered the story last night. US To Contribute Funds For Some WHO Programs Despite Withdrawal.

The firm “received \$144,000 from the Chinese embassy and \$313,200 from the China-U.S. Exchange Foundation (CUSEF) from Jan. 1 through June 30, according to a disclosure BLJ Worldwide filed with the Justice Department this week under the Foreign Agents Registration Act (FARA), which was enacted in 1938 to counter Nazi propaganda.”

South Korea Struggling With Second Wave Of Coronavirus Infections.

State Department Imposes New Restrictions On Chinese Diplomats In US.

Access for our diplomats in China should be reflective of the access that Chinese diplomats in the United States have, and today’s steps will move us substantially in that direction.”

These are the kinds of restrictions they've had on us, our diplomats in China, and now we've got a reciprocal arrangement." He said, "For 40 years...the United States took a knee, it bent a knee to the Chinese Communist Party and President Trump has said enough, whether it's on trade, or on their stealing of intellectual property and trade secrets, destroying jobs here in the United States. We're simply not going to take it anymore."

Chinese FM Pressed On A Host Of Issues While Touring Europe. The Post reports that in Rome, Wang "was pressed on the question of autonomy and freedoms in Hong Kong," in Paris, he was "asked about Beijing's treatment of the Muslim minority Uighurs," and "in Berlin, he was chastised by the German foreign minister for making threatening remarks toward European officials." The Post says the EU "has been viewed by Beijing as a more pragmatic and potentially pliable partner than overtly hostile Washington."

Saudis Allow Israeli Flights To Access Their Airspace For First Time.
