I have been communicating with you regularly and the last time we spoke you screamed at me and hung up on me which was highly inappropriate. I am trying to help you but you are not even willing to give me basic information so that I can do so. I explained yesterday that I do not have experience with complaints to the FBI and that I was trying to get a hold of David who is in the USVI handling the hearing today. When I am able to reach him I will discuss this with him and get back to you. It would be helpful to have the information on what is the subject of your complaint specifically but in the last several communications you have refused to provide that information. I do not understand what you are referring to by your reference to Scotland Yard below?

[REDACTED] you explained to me that you suffer from [REDACTED] [REDACTED] and I am concerned that you may be experiencing something that requires you getting professional care. I am available to talk to you or [REDACTED] if I can be of help.

I have a [REDACTED] tomorrow (Wednesday) which will take me out of the office but I will try to reach David later today after the hearing and will try to schedule a call so that we can see how we can help

address the issues you would like to raise.
