



I would like to remind all of you that living in a "democracy" guarantees civil liberties and human rights, and I would like to remind you all what civil liberties myself and the Epstein survivors are entitled to and have been robbed of before I continue,

The clip has subsequently been deleted from YouTube, but Gloria, my attorneys, will get the full transcript of what you said, and then you, my dear, will be proven to be a big fat liar who, too, has done everything to protect the guilty.

What also can be confirmed by multiple victims who have come forward and in court documents is the mention of specific names over again, like the names Sergey Brin, Bill Gates and Bill Clinton.

Israel's finance minister, Bezalel Smotrich, has called for the return of Jewish settlers to the Gaza Strip after the war and said Gaza's Palestinian population should be encouraged to emigrate, according to AFP.

"To have security, we must control the territory," Smotrich told Israel's Army Radio in response to a question about the prospect of re-establishing settlements in Gaza.

"In order to control the territory militarily for a long time, we need a civilian presence."

The Israeli government under Benjamin Netanyahu has not officially suggested plans to evict Gazans or to send Jewish settlers back to the territory since the war broke out on 7 October.

Israel unilaterally withdrew the last of its troops and settlers in 2005, ending a presence inside Gaza that began in 1967, but maintained near complete control over the territory's borders.

All settlements on occupied Palestinian land are regarded as illegal under international law, regardless of whether they were approved by Israel.

Far-right coalition parties are pushing for resettling parts of the Strip and encouraging Palestinians to leave the enclave, and are flatly ruling out any post-war plan that includes a governing role for the Palestinian Authority in Gaza. This puts the government at odds with demands from the United States and other international allies.

It has also been reported that "147 Palestinians were killed and 243 injured in the past 24 hours. 1.9 million people, or nearly 85% of the total population of Gaza, are estimated to have been displaced from their homes. Only 15 out of Gaza's 36 hospitals are partially functional. This alone is a war crime.

330 Palestinians have also been killed in the Israeli-occupied West Bank over the same period, including 84 children, and nearly 4,000 people have been injured by Israeli security forces during that time".

Honestly, I got those figures from The Guardian News and copied them; seems that everyone has their knickers in a twist about plagiarism these days, which reminds me I will be writing to Harvard and MIT demanding a full investigation into their close ties with Epstein, Dershowitz and others, including Leslie Wexner. For example, it might be said that it takes a three-second psychological reaction time to make a decision during an emergency,[1]that you can survive 3 minutes in icy water,[5] or that an individual can last three months without hope (or companionship).[6][5][7]

### Water

The amount of time a person can survive without a source of water (including food which contains water) depends on the individual and the temperature. As temperature increases, so does water loss, decreasing the amount of time a person can survive without water. The longest anyone has ever survived without

water was 18 days.[8] The source of the "3 days" number likely comes from an experiment two scientists did in 1944 where they ate only dry food for a period of time; one ended the experiment at 3 days in, and the other at 4 days in. However since they stopped the experiment before being in any real danger, the actual survival time at room temperature likely exceeds 3-4 days. [8] However, at temperatures greater than room temperature, dehydration can occur very quickly, and death can occur in a matter of hours rather than days. In these cases people typically die of heat stroke first, not terminal dehydration. [8] One person was purported to survive 7 days in the desert, 6 of these without water, without suffering heat stroke as the temperature reached no higher than 103.2 °F (39.6 °C) during his ordeal. [9] However, he had reached the third stage of dehydration, which is 80-90% fatal; this likely represents an upper limit of survival at high temperatures.[9]"

"The Court's founding treaty, called the Rome Statute, grants the ICC jurisdiction over four main crimes.

First, the crime of genocide is characterised by the specific intent to destroy in whole or in part a national, ethnic, racial or religious group by killing its members or by other means: causing serious bodily or mental harm to members of the group; deliberately inflicting on the group conditions of life calculated to bring about its physical destruction in whole or in part; imposing measures intended to prevent births within the group; or forcibly transferring children of the group to another group.

Second, the ICC can prosecute crimes against humanity, which are serious violations committed as part of a large-scale attack against any civilian population. The 15 forms of crimes against humanity listed in the Rome Statute include offences such as murder, rape, imprisonment, enforced disappearances, enslavement – particularly of women and children, sexual slavery, torture, apartheid and deportation.

Third, war crimes which are grave breaches of the Geneva conventions in the context of armed conflict and include, for instance, the use of child soldiers; the killing or torture of persons such as civilians or prisoners of war; intentionally directing attacks against hospitals, historic monuments, or buildings dedicated to religion, education, art, science or charitable purposes.

Finally, the fourth crime falling within the ICC's jurisdiction is the crime of aggression. It is the use of armed force by a State against the

sovereignty, integrity or independence of another State. The definition of this crime was adopted through amending the Rome Statute at the first Review Conference of the Statute in Kampala, Uganda, in 2010.

On 15 December 2017, the Assembly of States Parties adopted by consensus a resolution on the activation of the jurisdiction of the Court over the crime of aggression as of 17 July 2018."

So, let's be very clear that the Israeli Government turning off Gaza's water supply not only constitutes a war crime but genocide of an entire population. Fact! And any doctor or medical professional will say the same. If they don't they should have their medical licence revoked.

Environmental experts have warned the strategy – which Israel has yet to commit to – risks causing an ecological catastrophe that will leave Gaza with no drinkable water and devastate what little agriculture is possible in the 141 sq mile territory.

The UN special rapporteur for the right to water, Pedro Arrojo-Agudo, compared it to the legend of Romans' salting of the fields of Carthage to render uninhabitable the territory of their ancient rival. The

rapporteur for human rights and the environment, David Boyd, said damaging Gaza's sole water supply would be "catastrophic" for the environment and human rights"

"Media reports, photographs and satellite imagery suggest the Israel Defense Forces (IDF) have set up pumps at al-Shati refugee camp on the eastern coastline of the Gaza strip, which they could use to pump millions of gallons of seawater into the tunnels used by the militant group.

Israeli soldiers reportedly began trialling pumping seawater into the subterranean network last week, in an effort to drive Hamas's militants above ground and deny them a significant strategic tool."

Mark Zeitoun, director of the Geneva Water Hub and professor at the Geneva Graduate Institute, said seawater pumped into the hundreds of kilometres of tunnels crisscrossing the porous, sandy soil of Gaza would inevitably seep into the aquifer that its 2.3 million residents rely on for about 85% of their water.

Zeitoun, who has worked as a water engineer for the UN in the occupied Palestinian territories, said the aquifer was already badly contaminated from wastewater and from seawater infiltration caused by years of overabstraction.

"If you add more seawater directly, right on through the sand into the aquifer, it's not going to turn a top-quality resource into a vulnerable resource, it will turn a vulnerable resource into a catastrophic one," Zeitoun said.

He said the contamination would be such that current neighbourhood-level reverse osmosis desalination methods used by Palestinians in Gaza to treat their water would no longer be feasible.

"It would ruin the conditions of life of everyone in Gaza," he said. "I say the conditions of life because I think that's one of the elements of genocide within the UN convention, the partial or complete physical destruction of the conditions necessary for life of any people.

"Flooding the freshwater aquifer with seawater would go against every norm humanity has ever developed, including

the environment aspects of international humanitarian law/rules of war and the recent principles on the protection of environment in relation to armed conflict and all the progress made towards criminalising harm to the natural environment: ecocide.”

Wim Zwijnenburg, a researcher for the Dutch NGO Pax for Peace, who investigates the environmental impacts of war, warned of additional dangers. “We don’t know what’s stored in the tunnels,” he said.

As you know, every business day there have been additional documents unsealed by the Court in the [REDACTED] v Maxwell case. Most of the papers could have been more interesting.
