When I was seeking legal representation to advocate for my rights as a sex trafficked victim of Epstein, Maxwell and their co-conspirators, [REDACTED] and his firm informed me that they would represent me [REDACTED]

On **January 10 2017**, I wrote an email to [REDACTED]. “[REDACTED] Can you please give me a call please thank you [REDACTED]”

On **January 13 2017** [REDACTED] wrote back to me. “Hi [REDACTED], When can we talk? Important that we do so Friday. Send Proton, please. [REDACTED]”

On **January 14th 2017**, I wrote to [REDACTED] and [REDACTED] “[REDACTED], Can you please give me an update on what this [REDACTED] relates to, i.e. Which case? Also, did you manage to talk with the 1 party you contacted and the other you were trying to contact? Thank you”

On **January 14th 2017** [REDACTED] wrote, “The other side has been notified that we will be [REDACTED] Only the time needs to be worked out. I mention this, as I did in our telcon call today, so that you can be on your toes in

case they try to call you, email you, or contact you in any way. Do not talk to them in any fashion. Hang Up. Do not reply to emails. Do not be frightened by anything. Once you are in the open, so to speak, you are safer than ever. They cannot harass you because your name is now part of the United court system. They are not allowed to tamper with you, and if they try, they are subject to legal sanctions by the court. Let me know if you get any strange calls or efforts to contact you. You will be fine, but we want to know of any funny business by the other side. Best, [REDACTED]”.

On **14th January 2017**, [REDACTED] wrote, “Hi, [REDACTED] The [REDACTED] in connection with [REDACTED] case against Maxwell, [REDACTED] The subjects covered are those we talked about with you in person, including Epstein and [REDACTED]. I will talk to you on the phone regarding the scope of [REDACTED] and the related questions you raise, including [REDACTED]”.

On the [REDACTED] I wrote to [REDACTED], “ [REDACTED], when are you able to call me please.”

On **21st February 2017**, [REDACTED] replies, “What about”

On **21st February 2017**, I replied, “[REDACTED], I think you know what it's about. Now that you guys have what you want from me, you have left me high and dry. You obviously don't need me anymore. Your last conversation was a disgrace, and you have let me down and gone back on your word. Our time is finished.”

Three days later, on the **24th of February 2017**, after they had already [REDACTED]

When I was asked to do the [REDACTED] for [REDACTED], I was in hiding in [REDACTED]. I was frightened, and indeed Jeffrey was trying to find me whilst in hiding.

On **13 January 2017**, Jeffrey contacted another sex trafficked victim [REDACTED]. “hi, was [REDACTED] a friend of yours?”

Doing [REDACTED] jeopardised my safety, and [REDACTED] I had already been tracked down in [REDACTED] and they knew this, which is why I went into hiding in the first place.

I made it very clear at the start of [REDACTED] that I was afraid for my and my family's safety and that I had been followed. [REDACTED] I was then harassed and intimidated to repeatedly give the address where I was in hiding, including my loved one contact details. This made me very uncomfortable and even more frightened as Ghislaine [REDACTED]

[REDACTED] I found this incredibly intimidating.

I would like to point out that in [REDACTED] book, [REDACTED] pg [REDACTED] and [REDACTED] he said that after my two-day briefing in [REDACTED] on his way back to [REDACTED]

So, [REDACTED] why on earth would they put me on a plane whilst in hiding with Jeffrey trying to locate me again to do [REDACTED]

This shows that [REDACTED] had absolutely no regard for me and my then partner [REDACTED] safety, who flew with me and was always about their other client [REDACTED]. This, of course, was not mentioned to me and had the delight of reading about it [REDACTED] the incidents occurred. If I had known about [REDACTED] experiences, I would never ever have flown to [REDACTED] to do [REDACTED] for [REDACTED], but sadly if I had known, I would have had little choice otherwise; they wouldn't have proceeded with my own litigation against Epstein and Co. They could have arranged to do [REDACTED] in [REDACTED] to protect me. Perhaps I'm the one that's lucky to be alive?!

What is even worse, whilst I was in [REDACTED] for [REDACTED] [REDACTED], they helped me reach out to another fellow survivor who was on the island with me. She was the [REDACTED] I tried to protect from Epstein and Maxwell. We were both raped repeatedly by Epstein whilst on the island together. I wanted to reach out to her to see if she was still alive and tell her I loved her and that I was sorry I didn't take her with me when I fled for my life in 2007 from Epstein and Maxwell. I couldn't. For years I blamed myself for not saving her.

On **28th February 2017**, [REDACTED] (the other rape victim) wrote to me, "Hi [REDACTED], it's [REDACTED]. It was so nice hearing from you, and I can't wait to see you and catch up!"

On **28th February 2017**, I wrote to [REDACTED] and [REDACTED], "I'm just going to forward any correspondence I have with her."

On the **1st of March 2017**, [REDACTED] wrote to me saying that he had managed to contact her, "I sent an email to her inviting her to a risk-free chat. This would be an ideal time for you to send her an email encouraging her to meet and assuring her that she can trust me. She has absolutely nothing to lose and potentially a lot to gain. Tnx."

It breaks my heart that whilst I was trying to connect with a long-lost friend and fellow survivor of Epstein, I led her straight into the lion's den. I won't forgive myself for that.

[REDACTED] was also a key witness in my litigation because she would corroborate my story and whom we met on the island, for example, Epstein and Maxwell's long-time friends Sergey Brin (Co-Founder of Google) and his then fiancé Ann Wojcicki (Co-Founder of 23&ME) on [REDACTED]

[REDACTED] fully corroborated my story. We also both had a disk of photos that Jean Luc Brunel gave us during one trip to the island, which included pictures of us, another rape victim, [REDACTED], Epstein, Maxwell, [REDACTED] [REDACTED], [REDACTED] [REDACTED], and Jean Luc himself, staff etc. I also have an email from [REDACTED] [REDACTED] on **28 December 2006** confirming this.

[REDACTED] [REDACTED] correspondence of that specific trip below will also be included in my evidence.

Here is your flight details..You will be going with a girl named [REDACTED] and a guy named Valdson. They will both be staying at [REDACTED] as well. I have a car picking you all up at 6:45am if you want to meet in the lobby...Please let me know you got this.. thanks!Traveler(s) Frequent flier details [REDACTED] [REDACTED] Saturday, December 30, 2006Continental Airlines [REDACTED] Depart: 9:25ammorning Newark, NJNewark Liberty Int'l (EWR)Arrive: 2:43pmafternoon St Thomas Island, Virgin Islands (U.S.)St Thomas Island Cyril E King (STT)Economy | Boeing 737-700 Passenger ([REDACTED]) | 4hr 18min | 1635 milesSeat: [REDACTED] Seat is confirmed

Initially, [REDACTED] said she would help me, but she just disappeared, and I never heard from her again. I was shocked to see her in the courtroom when on **29th August 2019**, the survivors were kindly invited to address Judge Burman and the court after Epstein's death to give our Victim Impact Statements and to finally give us our day in court after years of fighting for justice.

It turns out that [REDACTED] and [REDACTED] were now representing her. I wish [REDACTED] and [REDACTED] had told me they had contact with her and found this confusing and distressing, especially as they knew I had reached out to her. I'm also confused about why she wasn't subpoenaed and deposed in [REDACTED] My case was [REDACTED] [REDACTED] yet the very key witness that would provide testimony is now their client a mere **8 months** later. I'm assuming they also represented [REDACTED] too, which also could have provided information on Epstein's sex trafficking conspiracy.

I also don't understand why Igor Zinoviev, Epstein's bodyguard, was not subpoenaed [REDACTED] In [REDACTED], he said he met Igor after [REDACTED] [REDACTED], who was a key witness in my litigation, confirmed to [REDACTED] that I did [REDACTED] after I had been repeatedly raped by Epstein.

[REDACTED] showed no greater level of distress than he'd seen in other girls throughout the years. The rest of the meeting had little to do with the girls, and much to do with the danger he saw me putting myself in with Epstein”.

This was a direct threat to [REDACTED] and his safety.

Again, I ask, why would they then put me on a plane a month later [REDACTED]
[REDACTED]

In my previous grievance dated [REDACTED]
[REDACTED]

[REDACTED] This is because to do so would benefit another of his clients, [REDACTED], but was strongly counter to my interests.”

Upon my own investigation and that of [REDACTED]
[REDACTED]

[REDACTED] I would

like to point out that [REDACTED] [REDACTED] had been disqualified from representing [REDACTED] in the Dershowitz case since her [REDACTED] could be called to testify as part of the underlying allegations in the case, according to a court order.

When the judge did give the Jane Does an opportunity to register any objections, I had to hear the news from another sex trafficked survivor [REDACTED] [REDACTED], another of [REDACTED] Clients.

I made my feelings very clear about [REDACTED] [REDACTED] when I wrote to [REDACTED] on [REDACTED]

“Dear [REDACTED], Thank you for taking time out for me yesterday. Unfortunately I had some bad news from [REDACTED] yesterday and am besieged and riddled with FEAR, anger and hatred! Enough!!!!!! I have had enough!!!!!! I’m inconsolable since [REDACTED] and my conversation yesterday. Alan is after me. He will find me and serve me. For what??? This is not my case, I chose my battles wisely and this was not a fight I have the strength to fight. If I wanted to be involved in this shit show I would have sued Alan myself but chose a life of peace and solidarity instead. And my voice was silenced by the very people I trusted. For what! [REDACTED] [REDACTED] to appease all of you, because I will!! You will never know what I went through. Ever! What do you want from me! I’m broken now I have to live in fear, once again. Everyday, every month, every year until Alan finds me! I supported [REDACTED] once before, and will not do it again. She also betrayed me. [REDACTED]

[REDACTED] I know this as a fact. I spent two years living in isolation in a [REDACTED] where I didn’t have an [REDACTED] conversation for two years because I was so frightened. For what! I was followed in [REDACTED] (none of you believed me but [REDACTED] and my life threatened yet you guys still did not believe me. I will give you my previous address so you can research where I lived and maybe then you’ll have some respect for me and what I have actually been through. Now I must live in fear once more!!!! Alan will find me!!!! For what, so VR can get another payout!!! [REDACTED] And I’m not joking! Who will protect me??? [REDACTED], that’s as bad as a knock knock joke! I will not be betrayed again! I’m tired of being used!

I later followed up with an email to [REDACTED], **23rd April 2020 7.39pm UK Time,**

“If Alan or his cronies come anywhere near me or my home, you will all have blood on your hands.”

Fourthly, it's appalling that [REDACTED] gave me, her client, so little time to find a new law firm to represent me and to put my case together to protect myself and my family.

At this point, I was desperate to find new lawyers to represent me in the fight against [REDACTED]
[REDACTED] This fight is ongoing and has harmed me immeasurably.

They knew that [REDACTED] had sensitive material about my private life and family, including their contact details which I did not feel comfortable giving to Ghislaine's attorneys [REDACTED] I was incredibly embarrassed about my past. It was then used against me in [REDACTED] to my detriment.

On **August 7th 2020** I was completely distressed and subsequently wrote to [REDACTED],

"Dear [REDACTED],

I authorize you to speak to [REDACTED] and his team regarding matters concerning [REDACTED]

I'm really concerned though as [REDACTED] said she had found a lawyer to represent me Pro Bono to [REDACTED] but she said he hadn't got back to her. That was two days ago.

I can't afford a lawyer to help me and feel very let down and abandoned by other parties, you are very much excluded from this. Would [REDACTED] be able to do the [REDACTED] pro bono?

I'm at a loss of what to do and completely traumatised by the whole thing. I have until the 18 th August to put in my objection and time is running out."

On **7th August 2020** [REDACTED] responds,

"[REDACTED],

Because of the particular legal conflict, I cannot speak with [REDACTED] on your behalf on this matter. It's just not allowed or I would do it of course.

He is a reasonable and good guy, which is why I connected you to him. He will do a good job. However, I doubt he will handle this pro bono but you can ask him. If you learn who [REDACTED] was connecting you with, let me know and I'll see if I know them.

[REDACTED]"

I signed a retainer with [REDACTED] on [REDACTED] and superhero [REDACTED] filed a motion on the [REDACTED] to protect my privacy and to **STOP ME FROM BEING PULLED INTO ANOTHER [REDACTED] CASE AGAINST MY WILL!** From what I understand, it was [REDACTED] who helped find [REDACTED] [REDACTED].

[REDACTED]

I can also produce a note from my therapist, Dr [REDACTED], to [REDACTED] [REDACTED], dated [REDACTED], [REDACTED]. Dr [REDACTED] wrote, "it is important for her healing for Ms [REDACTED] to be able to process her past without the ongoing disruption of court proceedings and with her confidentiality being maintained."

My current attorneys, [REDACTED] and [REDACTED], also wrote a letter, which I can also produce, saying that I "should not now be forced to endure further emotional turmoil by being pulled (unwillingly) into another round of heated litigation, with its attendant public feeding frenzy."

[REDACTED] I felt forced to write [REDACTED] and include most of all of the details that I [REDACTED] in an attempt to take control of the narrative.

I also feel that [REDACTED] failed to help me when I desperately tried to give my evidence to the FBI. I had approached the FBI several times, asking to be interviewed and share my evidence about Jeffrey Epstein's sex trafficking scheme. Still, I never

got a response and also as repeatedly tried to make an official complaint against them too.

So, I requested [REDACTED] to help me with this, and she responded in an email dated [REDACTED], which I can produce:

“I do not have experience with complaints to the FBI and that I was trying to get a hold of [REDACTED] who is in the USVI handling [REDACTED]. When I am able to reach him I will discuss this with him and get back to you.” As far as I know, no one at the firm ever pursued my complaint against the FBI.”

On **February 4, 2020**, I wrote to [REDACTED], saying, “I don't feel that I am being represented equally or fairly and have never been either. I'm tired of being ignored not only by you guys but also by the FBI and [REDACTED]. I have been shown no respect, humility, kindness or compassion by anyone.”

In my view, this is a direct obstruction of justice at its finest in an ongoing federal investigation not only by [REDACTED] but also by the federal prosecutors in the FBI carrying out the investigation. My evidence includes photographic evidence of Epstein, Maxwell, Jean Luc Brunel, [REDACTED], [REDACTED], [REDACTED], other rape victims, including [REDACTED], who had also come forward at that point, the date Sergey Brin (another long-term friend of Epstein's and the Clintons) and Anne Wojcicki who visited the island and Cathy Alexander, the house manager on the island (she is in the background in a photo).

I also have multiple email evidence against [REDACTED] [REDACTED] and [REDACTED] [REDACTED]. Flight logs which show [REDACTED] [REDACTED] was on with us on at least one occasion, email correspondence between myself and my recruited [REDACTED] [REDACTED] and a first-hand witness Igor. He cooperated with [REDACTED], as mentioned before, who confirmed I tried to swim off the island.

I would like to clarify that I called the Metropolitan Police, not [REDACTED], on the **30th of January 2020** to try and report the sex trafficking ring and the perpetrators who enabled my rape and others. I have the recording upon request. As I lived in [REDACTED] even though I am a [REDACTED] was informed to go to my local [REDACTED] Police Station to report my crime of an international sex trafficking operation. The local [REDACTED] police station didn't speak [REDACTED]

Because my lawyers were not helping me with this, I was forced to go to a separate organisation, the Organization for Security and Co-operation in Europe (OSCE), on my own to try and give my evidence about Jeffrey Epstein and his co-conspirators.

Although [REDACTED] (to my detriment and to silence me...again), I still wanted to hold these people accountable. Money was never my drive to prevent further children and women from being raped. There were no civil suits on the horizon, just a passion to help other human beings, so they didn't suffer as I and many others had.

On **25 February 2020**, I wrote to the OSCE: "I will fight this battle with everything I have to give, and I'm not giving up hope. So yes, please pass on my information to the right people. Not only for me but for every rape victim that has been abused previously, for every current rape victim and future."

A representative at OSCE said she had passed on my evidence to the US Department of Homeland Security, but I never heard back from them.

On the **9th March 2020**, the representative wrote to me,

"Dear [REDACTED],

I hope this finds you well, and [REDACTED] is getting better. I want to inform you that we passed your evidence to a US Homeland Security chargé.

Best wishes,

[REDACTED]"

I expressed my concern in an email to another attorney, [REDACTED]. I wrote on **March 23, 2020**: "I no longer want to be represented by [REDACTED]. I understand this is complex, but I don't feel they have worked in my interest or the other victims."

On **April 6, 2020**, I expressed my sense of betrayal to [REDACTED] [REDACTED] directly in an email. He did not respond.

On the 28th of July 2020, I was utterly shocked and retraumatized when the [REDACTED] found the woman [REDACTED] [REDACTED] living in [REDACTED]. She is the one responsible for coercing and profiting handsomely from befriending me [REDACTED] and luring me into Jeffrey Epstein's sex trafficking ring, which resulted in me being repeatedly raped. It was a shock to see her, but [REDACTED] told me they could not locate her during my own litigation, which is why she was never subpoenaed and deposed.

On Jul 29, 2020, at 7:02 AM I wrote to [REDACTED] regarding the article.

“Omg!

What a liar, she knew exactly what would happen to me after meeting JE.

Epstein's sex ring 'recruiter' is spotted hiding away in [REDACTED]

On Wed, Jul 29, 2020, at 13:15, [REDACTED] <[REDACTED]> wrote:

Let's talk tomorrow. As with all things in this case, nothing is simple. The fact that [REDACTED] is cooperating could actually be really good for your claim so let's think this through before reacting.

I thought I told you to stop reading this smut! Kidding. I knew you couldn't stop altogether. But it really rarely helps. Either way, hang tight. We will talk tomorrow. I'll send you an email when I get in with the call in number.”

[REDACTED] [REDACTED], who was on the island with me on more than one occasion, was there to pacify me and others between rapes, as were others when [REDACTED] wasn't around. [REDACTED] [REDACTED] is a long-time employee of Jeffrey Epstein, profiting greatly from this sex trafficking conspiracy.

[REDACTED] [REDACTED] went on to marry [REDACTED] [REDACTED], reportedly from [REDACTED] in [REDACTED]

“This is the [REDACTED] of Jeffrey Epstein who he phoned from prison just before he hanged himself – but gave no hint he was so despondent he was about to commit suicide”

They reportedly got divorced in July 2019 after Jeffrey Epstein was arrested.

Karyna Shuliak, is reportedly the last person to speak to Epstein before his death when he rang her on **10th August 2019**.

I would like to point out that [REDACTED]

I hope for [REDACTED] because once again, everything he does and touches always leads back to aiding and abetting a sex trafficking scheme to grant visas to Epstein and Co's victims, which has been widely reported as another way to get Epstein victims visas to enter the US.

I'm also confused about how [REDACTED] could also be [REDACTED] attorney. I mentioned her repeatedly during [REDACTED] Why was she not subpoenaed [REDACTED]? I would also like to make clear that in [REDACTED] on [REDACTED] on the docket, it says [REDACTED] case was [REDACTED] as against [REDACTED]. [REDACTED]

They said they couldn't find her. [REDACTED] found it very easy. Again, a little black cube action on her would have worked in a rape victim's favour, No? But it's ok to behave like that when you're trying to intimidate and silence witnesses and the New

York Times journalists in another former client's case, serial rapist Harvey Weinstein but not for justice for another?

Of course, they could have found her [REDACTED] and did only after my case was [REDACTED], just like they could have found [REDACTED], [REDACTED], [REDACTED] etc. [REDACTED] and [REDACTED] had already corroborated my story right from the beginning in **January 2017**.

I understand that if they had all been subpoenaed and ignored the subpoena, they would have all been found guilty of contempt of court, which is a criminal offence punishable by prison. None of the named persons was deposed in [REDACTED]

Nor am I aware that any other depositions were taken for example Epstein's, Maxwell [REDACTED] [REDACTED] and Lesley Groff, and [REDACTED] [REDACTED]

Therefore, I accuse [REDACTED] of aiding and abetting Epstein and co's sex trafficking conspiracy where I and hundreds if not thousands of children and young women were repeatedly raped. How many others were raped after I came forward in [REDACTED] to get justice for what these people did?? I'm aware that Epstein was arrested after returning from Paris. I would like to point out that the age of sexual consent is shockingly 15 years old in France. Epstein should never have been allowed to leave the United States of America after he was first convicted in **2008**.

[REDACTED] and [REDACTED] also [REDACTED] I received a call from [REDACTED] asking me to do this on a Saturday morning after not having heard from my lawyers for several weeks and sending distressed emails asking for any updates on my case.

Then, I finally received contact from my lawyers in the form of a call from [REDACTED] [REDACTED] I feel that this is highly inappropriate. I had repeatedly begged the lawyers to do a media campaign to expose Epstein and co and also wanted to encourage more victims to come forward. I was repeatedly ignored.

On **29 August 2017** I had an update from [REDACTED] regarding [REDACTED]

On **October 17, 2017**, I wrote to [REDACTED] as I hadn't heard any updates [REDACTED] for sometime.

“Good Morning [REDACTED],

I hope you are well?

We havent spoken for awhile so I thought I would just check on how everything is going?

Kind Regards

On **17 October 2017** [REDACTED] responded,

[REDACTED]

[REDACTED] Once the Court makes any meaningful rulings on the issue, we will let you know. How have you been?”

On **17th October 2017** I responded,

“Thanks for the update. I am good actually. I feel like I have come along way emotionally and mentally through this period. Despite what happens, I will never regret coming forward as it made me deal with issues that I had kept hidden which made me a very angry person for a very long time.

This Weinstein bussiness has brought a bit of upset back because its along the similar lines as myself however feel Epsein is worse.

On **17 October 2017** I send a follow-up email to [REDACTED].
“Is there no way we can use this Wienstien media coverage to our advantage?

Can we not leak about Jeffery and Ghilslain? Has G been found yet? Maybe this will up our game, get more girls ro come forward and put preasure on [REDACTED]?”

On **17 October 2017** [REDACTED] responded,

“[REDACTED]

Did you ever meet Weinstein? Do you know anything about a relationship between Weinstein and Epstein? If so, how do we prove it? “

On **Oct 17, 2017**, I respond to [REDACTED]

“Well done for finding that horrid woman. I would have paid good money to see her face when served. Good job :)

Can we prehaps have a quixk chat instead. Just 5 mins to explain where i am going with this. At least its something we should consider.

Please let me know when is a good time to chat? “

On **17 October 2017** [REDACTED] sends a follow up email

“Did you ever meet Weinstein? Just curious. I have a reason for asking.”

On **17 October 2017**, I respond,

No i havent ever met him but i suspect they were friends. Too many similarities including their involvment with the Clinton Fountaion.

However if I come forward with my story re Epstein any involvement that those two have had together would for sure come out. 100%.

I would like to go to the media. I think the time is rigt now. Can we chat?

On **17 October 2017**, [REDACTED] responded,

“I will be with [REDACTED] today. He is flying down from New York. Let me talk with him and then I will circle back with you.”

On **17th October 2017**, I responded to [REDACTED]

“Thanks

Basically the question is :

With the momentum of the Weinstein issues creating a catalyst for girls to come forward . Should we/I/someone make a call via the media/social media for girls ‘abused’ by Epstein et al to come forward?

Let’s discuss an appropriate plan going forward please !!

On **17th October 2017**, [REDACTED] responded,

“I understand. There is a Weinstein/epstein connection though that we are looking into presently.”

On **20th October 2017**, I write to [REDACTED],

“Hi [REDACTED],

How is everything going? Please let me know when your ready to chat.

Kind Regrads

On **2nd November 2017**, I write to [REDACTED] again,

“Hi [REDACTED],

I hope you are well?

Please can we arrange a time to talk?

Kind Regards

On the 7th **November 2017**, I wrote to [REDACTED] again,

“Hi [REDACTED]

I havent heard back from you for weeks now. Has something happened, are ypu ok?

I dont know what else to think really?

Please can you get in touch with me. Im loosing my mind waiting to have some for of communication??”

On **25th November 2017** I again responded to Stans request,

Yes as previously stated please [REDACTED]

On **25th November 2017**, [REDACTED] writes again,

I would like to clarify this and have the witnesses back me up; [REDACTED]

[REDACTED] Due to their incessant GASLIGHTING, GHOSTING AND USING ME TIME AND TIME AGAIN FOR THEIR OWN PURPOSES, whilst I WAS [REDACTED] what did they expect? Strategic, I think so.

Again, I would like to remind you, that the New York Bar Association's Rules of Professional Conduct state that "loyalty and independent judgement are essential aspects of a lawyer's relationship with a client"

"The professional judgement of a lawyer should be exercised, within the bounds of the law, solely for the benefit of the client and free from compromising influences and loyalties".

It is a massive betrayal for a lawyer to speak this way about their client and attempt to smear the reputation of someone they should be protecting and fighting for. I also heard directly from [REDACTED]

[REDACTED] I was in tears and very upset after that encounter which every journalist including [REDACTED] my lawyer in the overflow room at the time could confirm.

Linked to this, I feel that [REDACTED] was generally trying to discourage me from publicly telling my story. [REDACTED] wrote to me on **9 November 2018**, when he knew I was [REDACTED] linked to the re-traumatisation of my civil case:

"Just a note here to let you know that we have entered a sensitive period when none of us—and least of all you, [REDACTED]—can speak to the press about anything. If you get an inquiry from anyone, simply tell them to call me or [REDACTED], but do NOT give them anything further. They may ask for innocuous things—Like, [REDACTED]—all things that have simple and straightforward answers but cannot be answered by you. DON'T GIVE THEM ANYTHING, literally."

Was this to benefit me and [REDACTED]?? I think not. [REDACTED]

I didn't see the article as I had [REDACTED] and [REDACTED] and didn't have access to any communication so I wouldn't have seen the article and was in no fit state to talk to anyone, never mind a journalist. Living in [REDACTED] was also tricky following [REDACTED]-related articles as there are restrictions to information on [REDACTED]-related matters within the media.

██████████ because of how ██████████ and ██████████ treated me and because I was also in hiding due to fear of being harmed. I knew Jeffrey was after me; the lawyers did nothing to protect me. I am attaching the email Jeffrey Epstein sent to ██████████ ██████████ (incidentally, ██████████ is also ██████████ client). Please note that the email is dated ██████████ ██████████ ██████████

How did Jeffrey know I was coming forward and about to submit my claim? This shows he tried to get to me before my claim was submitted. At that point, it was confidential between myself and my lawyer, ██████████.

I also feel that, in general, ██████████ was incredibly uncommunicative during my case and would ignore me for weeks at a time, despite my desperate attempts to get updates from them. They knew, from many emails that I can produce, that I was incredibly distressed by their lack of contact, but they continued to ignore me. They also knew I was more generally in an extremely vulnerable and traumatised state and continued to ignore me.

My then-partner, ██████████, also wrote to ██████████ on July 16, 2019, to express my disappointment at ██████████ lack of communication. He wrote: "I'm writing because ██████████ is feeling terribly left out and left behind after her years of anguish to help to be heard."

On March 24, 2017, I wrote in an email to my lawyers:

Please can someone call and let me know what's going on.?

- > If I'm not of value or I have done something wrong, tell me. I am a big girl.
- > Please stop giving me the silent treatment as it not fair on me, and I'm very upset about it, and it's increasingly stressful my end being kept in the dark or having almost zero communication.
- > ██████████, I phoned you in tears last Thursday night, and you promised to call me back the next day.
- > It not cool, especially under the circumstances, but I do understand you guys are very busy and working long hours. I don't know what to do anymore or where I'm at or anything.
- > Please call me?

On November 17, 2017, I wrote to ██████████ in an email:

In addition to the above, I recently discovered that [REDACTED] h [REDACTED]

I want to be very clear: I consider Bill Clinton a co-conspirator of Jeffrey Epstein's, and I would never, ever, ever have [REDACTED]
[REDACTED] When Epstein was luring me into his abuse and sex trafficking scheme, he frequently bragged about his close friendship with Bill Clinton and Donald Trump. In my mind, this gave Epstein credibility and is one of the primary reasons I trusted him.

I was very explicit with [REDACTED] when I first met with them – via a conference phone call held in [REDACTED] [REDACTED] office in [REDACTED] where [REDACTED] [REDACTED] were present – that [REDACTED] [REDACTED] and knowing as I did that Bill Clinton was a co-conspirator. The lawyers knew this prompted me to come forward but did not disclose that [REDACTED] had a close personal friendship with Bill Clinton, which seems like a vast and unforgivable conflict of interest.

On Saturday, February 22nd, [REDACTED] Responded, "Hello [REDACTED] – If you are referring to the article that I saw yesterday with Gloria Allred hiring a bus with a sign about Prince Andrew – that was her doing exclusively. Ms. Allred has her own clients and we are not affiliated with her or her actions in that regard nor her daughter Lisa Bloom. If I am mistaken and you are referring to something else she has done please forward me whatever it is you would like me to review. feel free to call me if you want to discuss anything."

They should NOT be allowed near sex abuse survivors, never mind be practising lawyers. They have all viciously abused their power on rape victims who had the bravery and courage to come forward like me. This is NOT acceptable! They have betrayed our trust and lied to us all. Not only this, but they also actively went out of their way to damage my reputation, which they succeeded in whilst I was their client, which has caused me tremendous financial harm.

Please, I ask that an immediate investigation occur so that the other Epstein and Maxwell sex trafficked survivors and I might have the freedom to live in peace, find some form of happiness, and move on with our lives. All we ever wanted was justice

for all of us being raped. We didn't know by coming forward to "trusted" lawyers that they too were co-conspirators themselves of the sex trafficking ring. They raped us again, as did the system. We will NOT be Silenced anymore!

And I would like to clarify that I will not be intimidated or bullied, or "Silenced" anymore by [REDACTED]. Who ARE the very co-conspirators I tried to bring to justice!

I would also prefer not to have "Black Cube" on my doorstep tomorrow courtesy of [REDACTED] or the US GOVERNMENT. Or have they always been around? [REDACTED]
