The squad has definitely been taking advantage of this time to review digital evidence, warrant returns, subpoena returns, prison calls, etc. However, this issue is a CART backlog problem. [REDACTED] is assigned to this matter, as well as the Epstein and [REDACTED] cases, both high priority matters with a mountain of forensic evidence to process. CART is only in the office 1 or 2 days a week so I'm not surprised that there is a delay. I will reach out to [REDACTED] and get a status and see what solutions may exist.
