For info - SDNY advised that Epstein was found unconscious in his cell with red marks on his neck. When staff was able to revive Epstein, he couldn't recall what happened. His cellmate denied knowing anything and said he was just sitting on his bunk with his earphones on. Epstein was removed from the cell and has been medically evaluated. MCC has initiated an investigation per their SOPs. Cellmate is [REDACTED]

[REDACTED] We arrested him last year. Washington Post has already made inquiry to SDNY. The cellmate ident is not public knowledge.
