Of the 10 co-conspirators, 3 have been located in FL and served GJ subpoenas; 1 in Boston, 1 in NYC, and 1 in CT were located and served. 4 of the 10 are outstanding with attempts having been made. 1 is a wealthy business man in Ohio, a lead is being sent to CV; the remaining 3 are currently out of pocket. The team (8 SAs/TFOs, 2 AUSAs) is flying out tonight/tomorrow to various locations in Florida to interview approximately 25 victims. The 1-800-CALL-FBI line is up and running, we have received approximately 45 calls which we are in the process of vetting out. Let me know if you need anything else.
