The ADIC has a pretty good handle on a lot of the information, but wanted to get him some examples of recent cases. I've pasted below links to three recent cases - are there any more you think would be worth highlighting. Time frame I think would be last four months or so. Also - anything new you are seeing? I'm going to ask the reporter to stay away from asking about stats specifically to a time range, but she may ask if we're seeing an increase.
